Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Clarke Schools Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Clarke Schools Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of The Clarke Schools Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Clarke Schools Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN:

General

The following description of the Clarke Schools Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established to provide benefits to all eligible employees of the Clarke School for the Deaf (the "School"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

The Plan covers all eligible employees of the School. Employees, excluding student, non-resident alien, union, and casual labor employees, are eligible for participation in the Plan immediately upon hire.

Contributions

Participants may contribute up to 100% of their eligible compensation as defined in the Plan agreement, subject to certain limitations. The Plan provides for the School to make a discretionary matching contribution based upon a percentage of participant's elective deferrals, which the School determines from year to year, at its sole discretion, which was 5% for 2024 and 2023. Contributions are subject to certain limitations as provided by the Internal Revenue Code (IRC). The School contributed \$205,608 and \$246,653 in matching contributions to the Plan for the years ended December 31, 2024 and 2023, respectively.

The Plan allows for participants who are age 50 or older before the end of a calendar year, to make additional catch-up deferrals. The maximum catch-up deferral a participant can make is \$7,500 for 2024 and 2023.

Rollover contributions from other qualifying plans, as determined by the Plan administrator, may be contributed to the Plan. Participants shall be 100% vested in the value of their rollover account at all times.

Participant accounts

Each participant's account is credited with the participant's contributions, the participant's allocation of the School's contributions, and the participant's proportional allocation of the Plan's earnings or losses. Participant's accounts are charged with an allocation of administrative expenses paid by the Plan. Participants determine the percentage in which contributions are to be invested in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, a pooled separate account and an insurance company general account as investment options for participants. Effective November 7, 2020, new loans may only be issued from participant accounts held at Charles Schwab Trust Bank ("Schwab").

1. DESCRIPTION OF PLAN: (CONTINUED)

Vesting

Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon. Participants are immediately 100% vested in employer contributions made prior to January 1, 2015 plus actual earnings thereon.

Vesting in employer contributions made on or after January 1, 2015 plus actual earnings thereon are based on years of continuous service. A participant must complete at least 1,000 hours of service during a year to receive credit for a year of service. A participant becomes 100% vested upon death, disability, or after six years of credited service in the following increments:

If a participant retires after reaching age 55, they would become 100% vested in any employer contributions. Effective January 1, 2023, the Plan was amended to no longer provide an early retirement age for participants who have not attained age 55 as of December 31, 2022. Thus, if a person retires without having 6 years of service, forfeitures would apply.

Effective July 1, 2025, a participant becomes 100% vested after two years of credited service.

Forfeitures

The balance of a participant's account related to the School's contributions which are not vested at the time a one-year break-in-service occurs will be forfeited. As allowed by the Plan provisions, forfeitures are used to cover administrative expenses or used to offset future employer contributions. At December 31, 2024 and 2023, the unallocated balance of forfeited non-vested accounts was \$35,255 and \$15, respectively. There were \$52,752 and \$33,152 of forfeitures used to offset employer contributions for years ended December 31, 2024 and 2023, respectively.

Payment of benefits

Upon termination of services, death, disability, or retirement participants may request a distribution in a lump-sum amount, installment payments, or an annuity contract. Participants may also choose to roll over distributions to other eligible retirement plans. If the Plan is terminated, the entire account balances will be distributed to participants.

Participant loans

Participants may borrow from the Plan in any amount greater than \$1,000 but no more than 50% of the participant's vested account balance. Participants may have a maximum of two loans outstanding at a given time. In no event can the participant borrow more than \$50,000. Loans are for a period not to exceed five years (except, longer terms are available for loans issued for the purchase of a principal residence). The loans are secured by the balance in the participant's account and bear interest at rates ranging from 9% to 9.5%. The rate of interest for loans is prime plus 1%. Principal and interest are paid ratably through payroll deductions as long as the participant is employed by the School and thereafter by regular installment payments.

1. DESCRIPTION OF PLAN: (CONTINUED)

Participant loans (continued)

Prior to January 1, 2015, participant loans were not available through the Plan, however participants had been allowed to enter into loan agreements with Teachers Insurance and Annuity Association – College Retirement Equity Fund (“TIAA-CREF”). TIAA-CREF issued and administers the loans directly with the participant. These loans are not Plan assets but rather the balance of any outstanding loan is collateralized by its equivalent amount from the assets in the participant’s account held with TIAA-CREF. As of December 31, 2024 and 2023, \$7,179 and \$6,830, respectively, of participant accounts were pledged as collateral for participant loans.

Plan termination

The School presently expects to continue the Plan indefinitely but reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the Act generally need not to be made until the end of the first plan year beginning on or after January 1, 2026, however, plans must operate in accordance with effective date of each new provision.

Major provisions of this Act that may effect the Plan include:

- Effective January 1, 2024, the limit for mandatory cash outs was raised from \$5,000 to \$7,000.
- Effective January 1, 2025, further expansion of eligibility to long-term part-time workers, which will allow participation after two consecutive years of 500 or more hours.
- Effective January 1, 2026, catch up contributions for any participants over age 50 who earn over \$145,000 are now required to be made on a Roth basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of presentation

The financial statements for Clarke Schools Retirement Plan have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition

Investments held by the Plan are stated at fair value with the exception of fully-benefit responsive investment contracts which are stated at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to fully benefit-responsive investment contracts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)

Investment valuation and income recognition (continued)

The Plan administrator is responsible for determining the Plan's valuation policies and analyzing information provided by the investment advisors, insurance company and record keeper that is used to determine the fair value of the Plan's investments. See Note 5 for further discussion of fair value measurements. All investments are participant directed.

In accordance with the policy of stating investments at fair value, the Plan presents in the statements of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Interest income is recorded as earned. Dividend income is recorded on the ex-dividend date. Purchases and sales are recorded on a trade date basis.

Earnings on investments, with the exception of participant loans, are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of participant's individual account balance to the aggregate of participant account balances. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's individual account.

Risks and uncertainties

The Plan provides for various investment options in any combination of fixed income securities, mutual funds, and a pooled separate account. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America and Department of Labor ("DOL") rules and regulations for reporting and disclosure under ERISA require the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

Administrative expenses

Substantially all expenses incurred in the administration of the Plan are paid by the plan sponsor except for certain participant transaction fees. These fees are paid to USI Consulting Group, the recordkeeper of the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments (Note 7).

Payment of benefits

Benefit payments are recorded when paid.

3. INFORMATION CERTIFIED BY CUSTODIANS:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Charles Schwab Trust Bank and TIAA-CREF, the custodians of the Plan, certified to the Plan administrator the fair value and physical custody of investments and participant loans included in the Statements of Net Assets Available for benefits to be complete and accurate as of December 31, 2024 and 2023 and investment transactions, investment income and net appreciation included in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023, the information contained in Notes 4 and 5 concerning investments and the types of investments held, and information pertaining to the supplemental Schedule of Assets Held (At End of Year).

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS:

The Plan invests in fully benefit-responsive investment contracts, the ("Contracts"), issued by TIAA-CREF. The Contracts invest primarily in guaranteed investment contracts (GIC's) and security backed investment contracts. TIAA-CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fund is included in the financial statements at contract value as reported to the Plan by TIAA-CREF. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The guaranteed investment contracts issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contracts issuers or otherwise. The credit rate net of administrative expenses was 5.50% for the period of January 1, 2024 through June 30, 2024, and 5.25% for the period of July 1, 2024 through December 31, 2024. The credit rate net of administrative expenses was 6.00% for the period of January 1, 2023 through June 30, 2023, and 6.50% for the period of July 1, 2023 through December 31, 2023.

The Plan provides an investment option, the Empower (formerly Prudential) Guaranteed Income Fund (a fully benefit-responsive contract), which is a stable value fund administered by Empower Annuity Insurance Company (EAIC) designed to provide safety of principal, liquidity and a competitive rate of return. The fund invests in a broadly diversified, fixed-income portfolio within EAIC's general account. The portfolio is primarily invested in public bonds, commercial mortgages and private placement bonds. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses. The contract is valued at fair market value and is then adjusted to contract value, when necessary, as reported to the Plan by the issuer, Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. In most circumstances, participants may not directly transfer amounts from Guaranteed Income Fund to a competing fund. A transfer out of this investment must be directed to and remain in a non-competing fund for a period of 90 days before it can be invested in a competing fund. Competing funds are generally short-term fixed income investments, money market funds or stable value investments that may be available as a Plan investment option.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS: (CONTINUED)

The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. There are no reserves against the contract for credit risk of the contract issuer or otherwise. The guaranteed interest rate is announced in advance and is guaranteed for a six-month period. The crediting interest rate was 2.00% for the period of January 1, 2024 through June 30, 2024 and 2.15% for the period of July 1, 2024 through December 31, 2024. The crediting interest rate was 1.15% for the period of January 1, 2023 through June 30, 2023 and 1.50% for the period of July 1, 2023 through December 31, 2023.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

5. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Fixed income annuities - Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

5. FAIR VALUE MEASUREMENTS: (CONTINUED)

Mutual funds and variable annuities - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are valued at the closing price recorded on the active market in which these individual securities are traded.

Pooled separate account - This is a real estate account (REA). The value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments as well as such liquid fixed-income investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. REA also holds liquid, fixed-income investments. These are generally priced using quoted prices in active markets or values obtained from independent pricing sources.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Level 3 gains

6. TAX STATUS:

The Plan is an ERISA Code Section 403(b) Plan. The Internal Revenue Service (IRS) has not offered a determination letter for this type of plan as of the date of this audit report. On March 31, 2017, the IRS issued an opinion on Volume Submitter 403(b) Plans which this Plan is a part of. The IRS determined that the form of the Plan is acceptable under section 403(b) of the Internal Revenue Code for use by eligible employers for the benefit of their employees.

Although the Plan does not have a determination letter, the Plan administrator and School management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

7. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS:

Charles Schwab Trust Bank and TIAA-CREF are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included in net appreciation in the fair value of investments, as they are paid through revenue sharing rather than a direct payment.

In addition, amounts paid to USI Consulting Group for transaction fees of \$8,558 and \$7,172 for the years ended December 31, 2024 and 2023, respectively, qualify as party-in-interest transactions.

Certain employees and officers of the School, who may also be participants in the Plan, perform administrative services at no cost to the Plan.

8. SUBSEQUENT EVENTS:

Management has evaluated subsequent events through July 22, 2025, the date on which the financial statements were available to be issued.
