INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Smilebuilderz, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Smilebuilderz, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Smilebuilderz, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 – Plan Description

The following description of Smilebuilderz, LLC (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan with a 401(k) provision covering eligible employees of the Company. Employees are eligible to enter the Plan after reaching age 21 and completing six months of employment. Eligible employees of the Company are automatically enrolled into the Plan starting at 3% of eligible compensation unless they affirmatively opt out of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to the maximum limits of the Internal Revenue Code (IRC), as defined in the Plan. Participants may elect salary deferrals in the form of Pre-Tax 401(k) deferrals or Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. In addition, participants over the age of 50 at the end of the Plan year may make catch-up contributions. The Company may make a matching contribution to the Plan at the discretion of the Board of Directors. Matching contributions for both the years ended December 31, 2024 and 2023, totaled \$0. Participants direct the investment of all contributions into their accounts into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as investment options for the participants. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the discretionary employer contributions, and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Participants are vested in employer discretionary contributions plus actual earnings thereon based on years of continuous service. A participant is vested in discretionary contributions on a six-year graded schedule and is 100 percent vested after six years of credited service. Special vesting rules apply for participants who die, become disabled, or reach the normal retirement age (65) prior to becoming fully vested.

Payment of Benefits - Upon termination of service, the participant, or beneficiary in the case of death, is eligible to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum payment or as a direct rollover to an individual retirement account, individual retirement annuity, or to another employer's tax qualified plan. Participants with vested account balances of less than \$5,000 upon termination will automatically have their distribution rolled over into an IRA with an affiliate of the Trustee, unless they elect to receive a lump sum payment or elect a direct rollover into an IRA or qualified plan specified by the participant. If the terminated participant's vested balance exceeds \$5,000, a written request from the participant is required before distribution.

Note 1 – Plan Description – Continued

Hardship distributions may be requested from the Plan in the event of financial hardship and are permitted to be taken from participants' elective deferral amounts (excluding earnings), rollover accounts, and vested employer match accounts.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loans must be fully repaid through payroll deductions within five years, unless the loan is used for the purchase of a primary residence, which must be repaid within a period no more than fifteen years. The loans are secured by the balance in the participant's account. The interest rate charged is calculated at the prime rate as published in the Wall Street Journal on the 14th day of each month, plus one percentage point. The rate of interest on all outstanding loans as of December 31, 2024 was between 4.25% - 9.5%.

Forfeited Accounts - At December 31, 2024 and 2023, there were forfeited non-vested accounts of \$100 and \$56, respectively. Forfeited amounts may be used to reduce future employer contributions. Forfeitures used to reduce employer contributions were \$0 for both years ended December 31, 2024 and 2023.

Note 2 – Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value as determined and certified to by the Plan's Trustee. See Note 5 for discussion and methods of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - All administrative expenses will be paid by the Plan unless paid by the Company. Certain administrative expenses associated with the Plan were paid by the Plan.

Subsequent Events - Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through September 10, 2025, which is the date the financial statements were available to be issued.

Note 3 – New Accounting Standards

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

Note 4 – Investments

During the years ended December 31, 2024 and 2023, the Plan's investments in pooled separate accounts, including gains and losses on investments bought, sold or held during the year, appreciated in fair value by \$517,662 and \$522,324, respectively.

Note 5 – Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of the units held by the Plan at year end as reported by the custodian. The NAV is calculated daily based on the quoted market prices of the underlying investments. Investments in pooled separate accounts can be redeemed daily at the current NAV per unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value of the investments in this class has been estimated using the net asset value per unit of the underlying investments. There are no unfunded commitments and no redemption period notice required.
- (d) This class invests primarily in common stocks and preferred stocks, bonds, convertibles and cash. The class's objective is to seek long-term growth with some protection against stock market volatility. Investments in this class can be redeemed daily at the current net asset value per unit based on the fair value of the underlying investments. The fair value of the investments in this class has been estimated using the net asset value per unit of the underlying investments. There are no unfunded commitments and no redemption period notice required.

- (e) This class invests primarily in U.S. investment-grade bonds. The class's objective is to produce steady stream of investment income while providing protection against stock market volatility. Investments in this class can be redeemed daily at the current net asset value per unit based on the fair value of the underlying investments. The fair value of the investments in this class has been estimated using the net asset value per unit of the underlying investments. There are no unfunded commitments and no redemption period notice required.
- (f) This class invests in low-risk, high-quality assets, such as government securities. The class's objective is to preserve capital and bring modest, stable returns. Investments in this class can be redeemed daily at the current net asset value per unit based on the fair value of the underlying investments. The fair value of the investments in this class has been estimated using the net asset value per unit of the underlying investments. There are no unfunded commitments and no redemption period notice required.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7 – Party-in-Interest Transactions

The Plan has notes receivable from participants that are secured by participant account balances. All these transactions qualify as party-in-interest transactions.

At December 31, 2024 and 2023, Plan investments consisted of \$4,124,889 and \$3,206,531, respectively, of units of pooled separate accounts managed by John Hancock Life Insurance Company, the Custodian of the Plan. Administrative expenses paid to John Hancock Life Insurance Company totaled \$40,719 and \$29,705 for the years ended December 31, 2024 and 2023, respectively.

The Paragon Alliance Group, LLC provided record keeping services to the Plan. Fees paid by the Plan for these services amount to \$1,884 and \$1,175 for the years ended December 31, 2024 and 2023, respectively.

Note 8 – Income Tax Status

The Company adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The opinion letter stated that the Plan as amended is designed in accordance with applicable sections of the IRC. The Plan did not apply for a separate determination letter and the Plan has been amended since receiving the letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Information Prepared and Certified by Custodian

The following information for the years ended December 31, 2024 and 2023 included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by John Hancock Life Insurance Company, the Custodian of the Plan.

Note 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
