## **Note 1. Description of the Plan**

The following brief description of J.A. Watts, Inc. 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

### ***General***

The Plan is a defined contribution plan covering substantially all employees of J.A. Watts, Inc. (Company). The Plan was established January 1, 2015, and is subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. Empower Trust Company, LLC (Empower), is the trustee for the Plan.

### ***Eligibility***

Eligibility to participate in the Plan is limited to employees, as defined, who have completed one month of service, and are not part of a collective bargaining agreement, an intern, leased employee, or reclassified employee.

### ***Contributions***

Each year employees may contribute up to 100% of their compensation to the Plan, subject to limitations imposed by the Internal Revenue Code. Such elective deferrals can be made via pre-tax or after-tax (Roth) deferrals. Participants age 50 or older may contribute an additional amount as a “catch-up contribution.” Unless specifically declined, eligible employees are automatically enrolled in the Plan at an amount equal to 3% of eligible compensation. Such percentage is increased by 1% as of each subsequent anniversary of their plan entry date, not to exceed 10%. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company’s employer-matching contribution, if any, is determined by the Board of Directors of the Company prior to the beginning of a plan year. The Company may also, at its discretion, make a pay-based profit sharing contribution to the Plan which follows a two-year vesting schedule. No discretionary match was made in 2024 or 2023. Additionally, the Company will make safe harbor matching contributions, equal to 100% of salary deferrals, not to exceed 3% of a participant’s compensation, plus 50% of a participant’s deferrals between 3% and 5% of their compensation.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

### ***Vesting***

Participants are immediately vested in their voluntary contributions and safe-harbor employer-matching contributions. Vesting in nonelective discretionary employer contributions is based upon years of service. A participant is 100% vested after two years of service.

### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, the entire vested balance in a participant’s account may be distributed in a lump-sum payment, rolled over into another qualified plan or, if the amount is in excess of \$5,000, in substantially equal annual installments as selected by the participant or beneficiary. Participants may also withdraw elective deferrals or rollover contributions in the event of hardship due to an immediate and heavy financial need, as defined by the Internal Revenue Service.

If a participant terminates prior to death, disability or retirement with a vested account balance less than \$5,000, the balance of the account will be distributed as soon as administratively feasible.

***Notes Receivable From Participants***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Interest rates at December 31, 2024, ranged from 4.25% to 9.50%, which is commensurate with local prevailing rates for this type of loan as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions and are payable within five years, except for loans used to acquire a principal residence, which are payable within 15 years.

***Forfeited Accounts***

All forfeitures will be applied to reduce employer discretionary matching contributions to the Plan or to pay the Plan's ordinary and necessary administrative expenses during the plan year. Any remaining forfeitures are to be allocated to participants in the manner described in the Plan. A forfeiture balance of \$25 and \$103 was available at December 31, 2024 and 2023, respectively. During 2024 and 2023, forfeitures of \$2,917 and \$0, respectively, were used to reduce the employer's safe harbor matching contributions. No forfeitures were used to reduce administrative expenses during 2024 or 2023.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. The Plan's investments in shares of registered investment companies are valued at quoted market prices of shares held by the Plan at year-end. The Plan's investment in the guaranteed investment contract is fully benefit-responsive and is valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that

such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Administrative Expenses***

Certain expenses of administering and operating the Plan are paid by the Company. The Plan pays certain administrative expenses and transaction costs related to participant loans and investment fees. Investment fees are included in net appreciation in fair value of investments.

***Revenue Sharing***

The Plan recognizes the income from revenue-sharing agreements when received. During 2024 and 2023, the Plan received \$42,566 and \$31,107, respectively, of revenue sharing, all of which was used to pay expenses for professional and investment management and advisory services. At December 31, 2024 and 2023, no revenue-sharing funds are available to offset future plan expenses.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

**Note 3. Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 or 2023.

The fair value of registered investment companies is determined by obtaining quoted market prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to

**Note 4. Information Certified by the Trustees**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income components and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 5. Group Annuity Contract**

Effective January 1, 2015, the Plan entered into a fully benefit-responsive group annuity contract with Great-West Life & Annuity Insurance Company, an affiliate of Empower, totaling \$465,164 and \$550,447 as of December 31, 2024 and 2023, respectively. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments, which are guaranteed and

cannot be less than zero and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Investments may be redeemed daily without prior notice.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event which would limit the Plan's ability to transact at contract value with plan participants is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## **Note 6. Party-in-Interest Transactions**

The Plan's investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for professional services rendered by parties-in-interest during 2024 and 2023 were \$126,890 and \$97,940, respectively, before the effect of revenue-sharing amounts of \$42,566 and \$31,107, respectively. The Company provides certain administrative services at no cost to the Plan.

## **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

## **Note 8. Tax Status**

The Plan operates under a non-standardized pre-approved profit sharing/money purchase/CODA adoption agreement in connection with a non-standardized plan and trust sponsored by Empower Retirement LLC. This prototype plan document was filed with the appropriate agency and the prototype sponsor has obtained an opinion letter dated November 14, 2022, from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan is designed and is currently being

operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through September 5, 2025, which is the date the financial statements were available to be issued.
