This letter is in place of an Independent Qualified Public Accountant’s (“IQPA Report”) and its purpose is to explain why there is no IQPA Report attached to the 2023 Form 5500 and why none will be attached to the 2024 Form 5500.

On June 28, 2023, the Plan Sponsor filed a petition for protection under Chapter 7 of the United States Bankruptcy Code and Jeffrey L. Burtch was appointed as the Chapter 7 Trustee (“Chapter 7 Trustee”). All of the Debtor’s employees were terminated on or before the filing date.

As you likely know, since a 401(k) plan is not an asset of the Chapter 7 Estate, Estate assets cannot be used to pay the expenses of administering the plan. Thus, the only source for the payment of plan expenses are the plan’s assets. Nonetheless, the Chapter 7 Trustee has been working with the Plan’s recordkeeper, Nexus, and the custodian, John Hancock, to wrap up the Plan and make distributions to participants. The Plan is expected to be closed out by December 31, 2024. Given the high cost of the IQPA Report on a plan of this size (815 participants with account balances), and the fact that the Plan was properly administered

continuously pre- and post-bankruptcy by Nexus and John Hancock, the Chapter 7 Trustee believes that foregoing the IQPA Report would be in the best interest of the Plan participants.

Accordingly, we request that the attached 2023 or 2024 (as the case may be) Form 5500 for the Plan be accepted as filed without the Opinion of an Independent Qualified Public Accountant.
