Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed an audit of the financial statements of WestRock Company Retirement Savings Plan for Puerto Rico Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

1. Description of the Plan

The following description of the WestRock Company Retirement Savings Plan for Puerto Rico Employees (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all Puerto Rico resident employees of WestRock Puerto Rico Inc. (the Company). The Plan became effective December 1, 2006 and most recently amended on July 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The WestRock Company Retirement Plan Administrative Committee (the Committee) oversees governance of the Plan. The WestRock Company Retirement Plan Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Committee.

Administration

Empower Trust Company, LLC (Empower Trust) is the trustee and custodian of the Plan, and Empower Retirement, LLC (Empower Retirement) is the Plan's recordkeeper who maintained individual accounts reflecting each participant's respective interest in the value of the Plan's net assets.

Eligibility

In general, employees who are residents of Puerto Rico are eligible to participate in the Plan after completing a minimum service period of one month and temporary employees are eligible to participate after one year of service. Service with Rock-Tenn Company, MeadWestvaco Corporation, SP Fiber Technologies LLC, and an employee's service with a predecessor employer acquired by or merged with the Company is generally taken into account for purposes of determining eligibility to participate in the Plan.

Contributions

Participants may make before-tax or Roth contributions between a minimum of 1% and a maximum of 75% of eligible compensation, as defined by the Plan, to the Plan through salary deferrals, subject to certain maximum limitations under the Puerto Rico Internal Revenue Code (PR Code). Participants are automatically enrolled equal to 3% of eligible compensation unless a different election is made. Participants who have or will attain age 50 on or before the end of the year are eligible to make catch-up contributions to the Plan. Employees can request to make a rollover contribution to the Plan before meeting the participation requirement of the Plan. The Company made a safe harbor matching contribution for the year ended 2024 equal to 100% of the first 5% of eligible compensation. Additionally, the Company makes an automatic contribution to the Plan regardless of employee contributions equal to 2.5% of eligible compensation.

Participant Accounts

Each participant's account is credited with (i) the participant's 401(k) contribution, (ii) the Company's contributions, and (iii) the participant's account earnings. Each participant's account is charged with (i) withdrawals, (ii) the participant's account losses, and (iii) an allocation of administrative expenses. Allocations are based on participant earnings and losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the participant's vested account balance.

Vesting

Participants vest immediately in their voluntary contributions and Company contributions plus actual losses thereon.

Forfeitures

Forfeitures of non-vested benefits may be used to pay Plan expenses, restore account balances for reemployed employees and reduce future Company contributions. Forfeitures of \$2,926 were used to offset Company contributions for the Plan for the year ended December 31, 2024. Forfeitures of \$3,480 and \$1,562 were available for future use at December 31, 2024 and 2023, respectively.

Withdrawals and Payments of Benefits

Participants can elect to receive payment of their vested account balance as soon as practicable after employment is terminated or after becoming disabled. Participants may have their account paid directly to them net of appropriate taxes and penalties (as applicable) or transferred in a direct rollover to another qualified plan or individual retirement account without taxes or penalties.

In general, the Plan also provides for withdrawals by a participant from his or her contribution account prior to retirement either upon the attainment of age 59½, disability, a hardship withdrawal, rollover withdrawal, or upon termination of the Plan without establishment of a successor plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The period for loan repayment cannot exceed five years from the date of the loan unless it was used to purchase a principal residence. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The Plan Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based on terms of the Plan document.

Administrative Expenses

Certain administrative expenses are paid by the Plan, as allowed by the Plan document. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Recordkeeping, investment advisory, and custodial fees are paid by plan participants and all other expenses are paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements.

Payment of Benefits

Benefit payments are recorded upon distribution.

3. Fair Value Measurements

The Financial Accounting Standards Board (FASB) has established a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted

prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Income Tax Status

The Commonwealth of Puerto Rico Treasury Department has informed the Company by determination letter dated March 23, 2017, that the plan adopted by the Company was in accordance with applicable sections of the PR Code. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the PR Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include loans made to participants. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account

balances, and the assets of the Plan will be distributed to the participants in accordance with the Plan provisions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events through August 20, 2025, the date which the financial statements were available to be issued, and there are no other events which would require recognition or disclosure in the financial statements.
