Independent Auditors' Report

Opinion

We have audited the financial statements of Heath Village Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of November 18, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to November 18, 2024 (in liquidation), and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of November 18, 2024 (in liquidation) and December 31, 2023 (ongoing), and the changes in its net assets available for benefits for the period from January 1, 2024 to November 18, 2024 (in liquidation), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As described in Notes 1 and 2 to the financial statements, the Board of Directors of Heath Village approved a plan of liquidation on July 26, 2024, with an effective date of August 1, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing plan basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

1. Description of Plan

The following description of the Heath Village Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution money purchase plan established effective July 1, 1989, as restated July 1, 2024. The Plan covers substantially all employees, excluding union employees, nonresident aliens, leased employees, per diem and contract employees, of Heath Village Inc. (the Village) who have attained age 21 and completed one year of service, provided that the employee worked at least 1,000 hours during such plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Pension Committee (the Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Termination

In July 2024, the Board of Directors approved the termination of the Plan effective August 1, 2024, with the Plan's assets to be distributed as soon as administratively feasible. As a result of the termination, all participants became 100% vested in Village contributions. The liquidation of the Plan was completed in November 2024 under applicable requirements of ERISA and in accordance with the provisions of the plan document.

Contributions

Prior to 2024, the Village contributed to the Plan 5% of each eligible participant's compensation, as defined in the plan document. Participants who did not have at least 1,000 hours of service during the plan year were ineligible to receive Village contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participant contributions are not permitted.

Participant Accounts

Each participant's account is credited with the Plan's earnings and formerly with an allocation of the Village's contribution. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

As a result of the termination, participants are 100% vested in the Village's contributions plus earnings thereon.

Payment of Benefits

On termination of service due to death, disability, retirement or other reason, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or a 50% joint and survivor annuity; installments paid over a selected number of years, a life annuity or an annuity that will continue for 10 years or until death (whichever is later).

Forfeited Accounts

At November 18, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$2,946, respectively. These accounts will be used to reduce administrative expenses and future Village contributions and to restore the forfeited account balances of rehired participants. For the period ended November 18, 2024, the Village contribution paid in 2024 which was for the 2023 receivable was reduced by \$2,946 from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

As a result of the resolution to terminate the Plan, the Plan considers liquidation to be imminent, and therefore, the financial statements of the Plan as of November 18, 2024, and for the period from January 1, 2024 to November 18, 2024 are presented on the liquidation basis of accounting. The statement of net assets available for benefit of the Plan as of December 31, 2023 is presented on the ongoing accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Village. Expenses that are paid by the Village are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through September 9, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Common stock, preferred stock and exchange traded funds are valued at the closing price reported on the active markets on which the individual securities are traded.

Certificates of deposit are valued at face value which approximates fair value.

4. Concentrations

As of December 31, 2023, the Plan had investments of \$962,650 that were concentrated in one fund.

5. Related-Party and Party in Interest Transactions

Certain plan investments were managed by Wells Fargo and Mutual of America, the Custodians, and therefore, these transactions qualified as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Village. No such officer or employee receives compensation from the Plan.

6. Plan Termination

As disclosed in Note 1, the Board of Directors signed a resolution to terminate the Plan effective August 1, 2024. During 2024, all assets were distributed subject to the applicable requirements of ERISA and in accordance with the plan document.

7. Tax Status

The Plan adopted a pre-approved plan offered by CCH Incorporated DBA FTWilliam Company. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
