**NOTE A - DESCRIPTION OF PLAN**

The following description of the Del Automotive Group Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions. Del Automotive Group is comprised of two automobile dealerships--Del Automotive, Inc. and Del Chevrolet, Inc. (collectively the “Company”).

**General**

The Plan is a defined contribution plan, which commenced January 1, 1978. All employees who have attained age 20 and have completed one year of service with 1,000 hours are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 75% of their gross compensation on a pre-tax basis to a regular 401(k) account or an after-tax basis into a Roth 401(k) account to the Plan through salary reduction. Participants’ elective deferrals are subject to the limitations of Internal Revenue Code Section 402(g). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plan (rollovers). The Company can make a discretionary match, as defined in the Plan. The Company match is determined annually by the Board of Directors. There was a calculated employer matching contribution of \$19,168 for 2024, but was not credited to the plan’s investment accounts until 2025.

**Participant Accounts**

A separate investment account is maintained for each Plan participant. Participants may direct the investment of their accounts into various funds specified by the Plan. Participant accounts are credited with the participant’s contribution, an allocation of the Company’s matching contribution and an allocation of Plan earnings, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately 100% vested in their own contributions to the Plan. Participants will be considered to have earned a year of service upon completing 1,000 hours of service within a 12 consecutive month eligibility computation period. Vesting in the Company’s matching contribution is determined as follows:

Year 2.....	20%
Year 3.....	40%
Year 4.....	60%
Year 5.....	80%
Year 6.....	100%

#### **Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate up to 10.5%. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Participants are eligible to receive a distribution of the vested portion of their individual account balance upon the following:

- The occurrence of any of the distributable events specified in the Adoption Agreement,
- The participant's termination of employment after attaining normal retirement age, or
- Termination of the Plan.

The normal retirement age under this Plan is 65.

#### **Forfeitures**

Employees who terminate employment and are not vested will forfeit the nonvested portion of their account balance to the Plan as specified in the Adoption Agreement. For the year ended December 31, 2024, there was no use of forfeited balances. The amount of unallocated forfeitures at December 31, 2024 and 2023, was \$8,316 and \$0, respectively.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distribution of participants' accounts shall be in accordance with the Plan document.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the modified cash method of accounting, which adjusts securities investments to fair value and records participant loans.

The Plan accounts for all transactions on the modified cash basis. Security transactions are recorded on the settlement date, and the determination of gain or loss on securities sold is based on the average cost of the securities. Investment income (interest and dividends) is recorded on the date received. Expenses are recorded on the date of payment.

Modified cash basis accounting represents a departure from accounting principles generally accepted in the United States of America. It is not a prohibited method of accounting for pension plans under the reporting requirements of ERISA. The result of the use of the modified cash basis of accounting is that dividends and interest receivable, security trades made but not settled, contributions receivable from the employer and liabilities at December 31, 2024 and 2023, are not included in the accompanying financial statements. Accordingly, the financial statements are not intended to present financial position and changes in net assets in conformity with generally accepted accounting principles.

#### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Plan investments in mutual funds are stated at fair value. Shares of registered investment companies are valued at quoted market prices. The Plan's investments in the common collective trust is stated at net asset value as reported by the trustee which include a mix of mutual funds and managed accounts. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investment options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principle market is open and available to any participant in the Plan.

Purchases and sales of the common/collective trust shares are recorded at end of day net asset value. Dividends are recorded as of the record date.

#### **Contributions**

Contributions from participants are recorded in the period in which they are received by the Plan. Company matching and discretionary profit-sharing contributions are recorded in the period made.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Administrative Expenses**

Administrative expenses, excluding transaction fees, are paid from the assets of the Plan.

#### **Party-in-Interest Transactions**

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as exempt party-in-interest transactions.

#### **Plan Amendments**

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

#### **Date of Management's Review**

Management has evaluated subsequent events through September 2, 2025, the date which the financial statements were available to be issued.

### NOTE C - RELIANCE ON TRUSTEE'S REPORT

The administrator of the Plan chose the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by the trustee of the Plan, Ascensus Trust Company, other than comparing such information to that contained in the financial statements and schedule. The information certified by Ascensus Trust Company, which was relied upon in the preparation of these financial statements and schedule, includes:

### NOTE D - TAX STATUS

The Plan uses a non-standardized pre-approved profit sharing plan sponsored by Ascensus Trust company. Ascensus Trust Company has received a favorable opinion letter from the Internal Revenue Service for the prototype plan on June 30, 2020. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has been amended since receiving the letter, but still in compliance with IRS requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE E - RISKS AND UNCERTAINTIES

The Plan provides for investments in a selection of mutual funds and common collective trust. Mutual funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain mutual funds, it is at least reasonably possible that changes in the values of mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits--modified cash basis.

### NOTE F - FAIR VALUE MEASUREMENTS

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

*Level 1* inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. *Level 2* inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. *Level 3* inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
