In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the HelloFresh 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants and all others should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2021. The Plan is a contributory defined contribution 401(k) plan available to qualifying employees of Grocery Delivery E-Services USA, Inc. dba HelloFresh (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company previously was a participating employer in the Insperity 401(k) Plan (the Insperity Plan), a multiple employer plan, and assets were spun off from the Insperity Plan and merged into the Plan in January of 2021.

Trustee, Issuer, and Administration of the Plan

The trustee of the Plan is Voya Institutional Trust Company (Voya or Trustee). The issuer of the insurance products held in the Plan is Voya Retirement Insurance and Annuity Company (VRIAC or Issuer). VRIAC provides the recordkeeping and other administrative services. The Trustee and Issuer hold all assets of the Plan in accordance with the provisions of the service provider contract with the Company. The Company and the investment advisor determine the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees are eligible for the Plan after attaining age 21 and completion of three months of service, as defined, and can participate in the Plan on the first day after the eligibility requirements are met. Non-resident aliens, union employees, leased employees, and temporary employees are not eligible for the Plan. Temporary employees who complete at least three (two starting January 1, 2025) consecutive 12-month periods in which they complete at least 500 hours of service will be eligible to participate in the Plan.

Contributions

Participants may elect to contribute, on a pre-tax or after-tax Roth basis, up to 80% of their eligible compensation as defined by the Plan Document, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained or will attain age 50 by the last day of the plan year may make catch-up contributions, as defined by the Plan, subject to IRC limitations. Participants may contribute rollover contributions from other qualified retirement plans.

The Company makes a safe harbor matching contribution of 100% of employee deferrals up to 3% of eligible compensation and 50% of salary deferrals between 3% and 5% of eligible compensation on a pay period basis.

Participant Accounts and Investment Options

Participant accounts are credited with (1) the participant elective deferral and rollover contributions, (2) the safe harbor matching contributions, and (3) and allocation of plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are

paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. Participants can change their investment elections at any time. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting and Forfeitures

Participants are fully vested in all employee and Company matching contributions.

Forfeited non-vested amounts that would result from excess contributions can be used to reduce employer contributions or pay plan expenses. For the year ended December 31, 2024, \$28,080 of forfeitures were used to reduce the employer contributions. The balance in the forfeiture account as of December 31, 2024 and 2023 was \$0 and \$27,746, respectively.

Payment of Benefits

A participant's entire vested interest in the Plan is payable in the event of termination, upon death of the participant, attaining normal retirement age (65), or becoming totally disabled, as defined in the Plan Document. Actively employed participants can begin withdrawing their vested interest without penalty at age 59½. A participant's benefits are payable in a lump-sum payment or a direct rollover to another qualified plan. Immediate lump-sum distributions are to be made to terminated participants if the participant's vested balance is \$1,000 or less. Balances between \$1,001 and \$7,000 are rolled over to an Individual Retirement Account (IRA) for the benefit of the participant. These mandatory distributions are only applicable if the participant does not elect another form of distribution. In addition, hardship distributions are permitted if specified criteria is met.

Notes Receivable from Participants

A participant may borrow from their account the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. Loans are secured by the participant's vested account and bear interest at a fixed rate of prime plus 1% as of the date of loan origination. The loans are to be repaid over a five-year period unless they are for the purchase of a principal residence, which allow a longer period. Principal and interest are collected ratably through payroll deductions. Only two borrowings may be outstanding at a time.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan Document to terminate the Plan, subject to the provisions of ERISA. If the Plan is terminated for any reason, the plan administrator is to distribute each participant's interest to the participant or their beneficiary.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments (except for the fully benefit-responsive investment contract), are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor, Trustee, and Issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Accounting for Fully Benefit-Responsive Investment Contracts with Insurance Companies

The Plan entered into a fully benefit-responsive investment contract with VRIAC. This contract met the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to pay the principal and specified interest rates guaranteed. There are no reserves against the contract value for credit risk of the contract issuer as of December 31, 2024 or 2023. The crediting interest rate is based on a formula agreed upon with VRIAC but cannot be less than 1%. Interest rates are reset quarterly. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with VRIAC. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The plan administrator does not believe that the occurrence of such events is probable.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Any accrued, but unpaid, interest was de minimis. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions

Participant contributions and any related safe harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions in the year the excess occurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company and the Plan. Fees, primarily loan origination, distribution fees, and asset-based fees, are charged directly to the participant's account and are included in administrative expenses or net with investment earnings. All other expenses of the Plan incurred during 2024 were paid by the Company and are excluded from these financial statements.

3. Certified Investment Information

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya and VRIAC, qualified institutions of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in the fair value of investments, interest and dividend income, and other income as reported on the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts included in the notes to financial statements.
- All investment information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, excluding notes receivable from participants.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, and reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan sponsored by VRIAC. The Internal Revenue Service (IRS) has determined and informed VRIAC, by an opinion letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan with CODA qualifies under Code Section 401. The plan administrator and Company management believe that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC, thus, no provision for income taxes has been provided for in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Concentrations, Risks, and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, there were three investments held which individually accounted for more than 10% of net assets available for plan benefits. See the supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

7. Related Parties and Party-in-Interest Transactions

The Plan invests in a group annuity contract and a money market fund issued by VRIAC and Voya. Certain fees were paid from Plan assets to VRIAC and its affiliates. Other administrative and investment advisory fees were also paid from the Plan during the year ended December 31, 2024. VRIAC may also receive certain eligible indirect compensation. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. The above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

8. Subsequent Events

Management has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available for issue. There were no events or transactions discovered during this evaluation that require recognition or disclosure in the financial statements.
