Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of GROWMARK 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the GROWMARK 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of GROWMARK 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis Of Matter - Basis Of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities Of Management For The Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about GROWMARK 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities For The Audit Of The Financial Statements

Except as described in the Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of the GROWMARK 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility And Contributions

The Plan is a defined contribution plan. The Plan covers all of GROWMARK, Inc.'s (the Employer) domestic employees other than those excluded because of coverage under a collective bargaining agreement. The Plan was adopted effective July 1, 1986. The Plan was restated effective January 1, 2014.

Eligible employees become participants on the first day of the first full payroll immediately after or coincident with the employee hire date.

Employees are automatically enrolled at 5% pre-tax. Employees may elect not to participate within 45 days of the beginning eligibility period. Participants who are automatically enrolled will have their deferral percentage automatically increased annually by 1% of compensation up to a maximum deferral percentage of 10% of compensation unless those participants request that such automatic increases cease.

The Plan is funded by: (1) salary reduction contributions, on behalf of participants, (2) Employer matching contributions at the rate of 50% of employee contributions, up to a maximum of \$1,000 annually per employee, who are employed on the last day of the Plan year (seasonal employees are excluded from Employer matching), (3) Employer profit sharing contributions, and (4) supplemental contributions as determined by the GROWMARK Board of Directors, if any. An individual's salary reduction may not exceed 75% of compensation (as defined by the Plan), determined annually. Participants may elect to designate a portion of their contributions as pre-tax and/or a portion as Roth contributions. The maximum allowable annual contribution (excluding catch-up contributions) is \$23,000 per employee for 2024 (adjusted for inflation in future years, as provided by Internal Revenue Service (IRS) regulations). Participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions. Participants may elect to make rollover contributions from other qualified plans. The Employer matching contribution to the Plan in 2024 was \$1,711,380. There were no profit sharing or supplemental contributions in 2024.

Notes To Financial Statements (*Continued*)

Plan Termination

While the Employer has not expressed any intent to terminate the Plan, it is free to do so at any time, in accordance with the terms of ERISA. In the event the Plan is terminated, participants are entitled to receive the fully vested value of their separate accounts in the manner specified in the Plan. In the event the Plan is terminated, participants would become fully vested in their accounts.

Description Of Investments

The investments of the Plan are held and transactions are executed under the GROWMARK 401(k) Plan and GROWMARK Member Cooperative 401(k) Savings Plan Master Trust (GROWMARK Master Trust) agreement with Fidelity Management Trust Company (Fidelity), who has investment responsibility with respect to the assets and is the Trustee for the Plan. See Note 5.

Participants may elect to invest in 1% increments in one or a combination of the investment funds provided by the Plan.

Participant Accounts

A separate account is maintained for each participant, which includes: (1) salary reduction contributions, (2) Employer matching and supplemental contributions on behalf of the participant, (3) Employer profit sharing contributions, and (4) the participant's share of income and gains or losses from investment of participant and Employer contributions.

Net investment activity is allocated to each participant's account daily. Participants share only in the income, gains and losses of the investment funds in which their equity is invested.

Administration

The Plan is administered by the Plan Administrative Committee which is appointed by the Employer and which serves without compensation. The majority of administrative expenses of the Plan are allocated to each participant's account. Other accounting and administrative duties are performed by the Employer, at no charge to the Plan.

Vesting And Benefit Payments

Voluntary contributions of participants, Employer contributions, and net investment activity earned thereon are fully vested at all times.

GROWMARK 401(k) PLAN

Notes To Financial Statements (*Continued*)

Upon termination of the participant's employment (whether by reason of retirement, death, disability, or other reasons), participants, or their beneficiaries, may request full or partial payment of the vested value of their separate account, as a lump sum payment or in installments. Annual or more frequent installments (over a period as limited by the Plan) may be made if the participant's vested account balance exceeds \$1,000.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. Loans are for a period not exceeding five years, unless used to acquire a primary residence, in which case the term is not to exceed 10 years. Interest on loans is fixed and charged at the prime rate as of the first day of the month of issuance plus 2%. Loans are secured by participants' vested account balances and principal and interest are repaid through payroll withholdings.

Withdrawals

A participant may, under certain circumstances and with the approval of the Plan Administrator, make a partial withdrawal of his or her account balance while actively employed by the Employer, subject to various limitations specified in the Plan.

2. Significant Accounting Policies

Basis Of Accounting

The financial statements are accounted for on the modified cash basis of accounting. Investments are stated at fair value, with the corresponding unrealized net change in fair value reflected in the financial statements. All other transactions are recognized when cash is received and distributed. Accordingly, the accompanying financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

Notes Receivable From Participants

The Plan follows accounting guidance, which requires that participant loans be classified as notes receivable from participants and measured at unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable are recorded as a distribution based on the terms of the Plan document.

Notes To Financial Statements (*Continued*)

Investment Valuation And Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments represents the difference between the aggregate fair value of investments at the end of the year and the values at the beginning of the year, and includes any realized gains and losses and unrealized appreciation or depreciation on those investments.

Fair Value Measurement Policy

The GROWMARK Master Trust follows Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the GROWMARK Master Trust has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;

 - Quoted prices for identical or similar assets or liabilities in inactive markets;

 - Inputs other than quoted prices that are observable for the asset or liability;

 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Notes To Financial Statements (*Continued*)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 or 2023.

Mutual Funds

Valued at the daily closing price as reported by the mutual funds. Mutual funds held by the GROWMARK Master Trust are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the GROWMARK Master Trust are deemed to be actively traded.

Self-Directed Brokerage Accounts

Self-directed brokerage accounts are comprised of money market funds, common stocks, exchange traded funds, and mutual funds. The money market funds held by the GROWMARK Master Trust are open-end investment funds that are registered with the Securities and Exchange Commission. These investment funds are required to publish their daily NAV and transact at that price. The investment funds held by the GROWMARK Master Trust are deemed to be actively traded. Common stocks and exchange traded funds are valued at the closing market price reported on the active market on which the individual securities are traded.

Pooled Separate Account

Valued at the stated NAV of shares held in the pooled account at New York Life. The NAV is used as a practical expedient for estimating fair value. There are no unfunded commitments relating to this investment or any significant restrictions on redemptions. The pooled separate account may generally be redeemed daily, and it files an annual report on Form 5500 as a direct filing entity.

Notes To Financial Statements (*Continued*)

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan and the GROWMARK Master Trust believe their valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Use Of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated the impact of material subsequent events through the date of the Independent Auditors' Report, which is the date that the financial statements were available to be issued.

3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statement of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes as of December 31, 2024 and 2023 and investment information on the supplemental schedule of assets held at end of year as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Investments In The GROWMARK Master Trust

The Plan's investments are held in the GROWMARK Master Trust, which was established in 2012 for the investment of assets of the Plan and the GROWMARK Member Cooperative 401(k) Savings Plan. Each participating retirement plan has an interest in the GROWMARK Master Trust. The assets of the GROWMARK Master Trust are held by Fidelity.

8. Income Tax Status

The IRS issued a letter of determination dated September 2, 2014, advising that the Plan is qualified under Section 401(a) of the Internal Revenue Code (Code) and therefore the trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended. Once qualified, the Plan is required to be operated in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Transactions With Parties In Interest

Certain GROWMARK Master Trust investments consisted of mutual funds managed by Fidelity Investments Institutional Operations Companies, Inc., an affiliate of Fidelity. Also, certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as party in interest transactions allowable under ERISA guidelines.
