Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of the Landmark Builders Profit Sharing and Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the 2024 Financial Statements* section of our report,

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

NOTES TO FINANCIAL STATEMENTS

FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1 – Description of Plan

The following description of the Landmark Builders Profit Sharing and Retirement Savings Plan (the “Plan”) provides only general information to assist the reader in reviewing the Plan’s financial statements. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan covering all employees of Landmark Builders, Inc. (the “Plan Sponsor” or “Company”) and sister organizations who are 20½ years of age or older. Employees are immediately eligible to participate upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Eligible employees are automatically enrolled at a 5% pre-tax deferral percentage unless they elect an alternate percentage or decline participation. Participants may otherwise contribute up to 100% of their pre-tax and/or after-tax (“Roth”) annual compensation, as defined in the Plan, subject to the maximum contribution limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company may make a discretionary matching and/or profit sharing contribution to be determined annually by the Board of Directors both of which are generally funded within 75 days of the date they are accrued. For 2024, the Company matched 50% of the first 8% of employee deferrals. There was no discretionary profit sharing contribution in 2024.

Investment Options

Upon enrollment in the Plan, participants direct the investment of their contributions and the Company contributions into the various investment options offered by the Plan. The Plan offers investments in mutual funds, common collective trust funds and pooled separate accounts. Participants may elect to move the assets in their account to different investment options and/or change the direction or percentage of future contributions at any time. There are currently thirty-four (34) options available under the Plan.

Participant Accounts and Forfeitures

Each participant's account is credited with the participant's contributions and allocations of: (a) Company contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined. At the discretion of the Plan Sponsor, forfeited balances of terminated participants' nonvested accounts may be used to pay the Plan's expenses or to reduce the Company's contributions to the Plan. There were no forfeitures utilized during 2024. Forfeited non-vested accounts of approximately \$1,000 and \$0 were available at December 31, 2024 and 2023.

Vesting

Participants are immediately vested in their voluntary contributions and actual earnings thereon. Participants vest in Company discretionary matching contributions and earnings thereon based on the number of years of credited service according to the following schedule;

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation, a participant may elect to receive a lump sum, a life annuity, or periodic payments (monthly, quarterly, semi-annually or annually) over a period determined by the participant in an amount equal to the value of the participant's vested interest in his or her account. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Notes Receivable from Participants

Notes receivable are not allowed in the Plan.

Administrative Costs

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including custodian and recordkeeping, may be paid by the Plan. Distribution fees are paid from the affected participant's account.

NOTE 2 – Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates and Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits paid to participants are recognized upon payment.

Subsequent Events

The Plan evaluated events occurring subsequent to the date of the financial statements through September 11, 2025, the date financial statements were available to be issued.

NOTE 3 – Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, the custodian of the Plan.

NOTE 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standard Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”) are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include –
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, other than as it pertains to the presentation of the stable value fund held by the Plan at December 31, 2023.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

See accompanying independent auditor’s report.

Common collective trust funds: Valued at NAV as determined by the issuer based on the fair market value of the underlying investments, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

Pooled separate accounts: Valued at unit value as reported by the issuer based on quoted market prices of the underlying assets, which is then adjusted for dividends and separate accounts fees. As the value of these investments is readily determinable, these investments are classified within Level 2 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – Party-in-Interest Transactions

Certain Plan investments are investments and shares of mutual funds managed by Principal Life Insurance Company (“PLIC”), the recordkeeper of the Plan and Principal Global Investors Trust Company, an affiliate of the Plan’s custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to PLIC for administrative services for the year ended December 31, 2024 totaled \$106,751.

The Plan’s financial statements are audited on an annual basis. Fees paid to the Plan’s auditor qualify as party-in-interest transactions. Fees paid to the Plan’s auditor for the year ended December 31, 2024 totaled \$9,500.

NOTE 6 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their Company contributions.

NOTE 7 – Income Tax Status

The Plan has adopted a non-standardized plan document sponsored by PLIC. The IRS has determined and informed PLIC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan may be subjected to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.
