To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hayes 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Hayes 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all full-time employees of Hayes Chrysler-Dodge-Jeep, Inc., Hayes Chrysler-Dodge-Jeep of Gainesville, Inc., Hayes Chrysler-Dodge-Jeep of Baldwin, Inc., and Hayes Chevrolet, Buick, GMC, Cadillac, Inc. (referred to collectively hereafter as "the Company"). Employees are eligible to participate in the Plan beginning on the first day of each quarter once attaining age 21 and completing ninety days of service. Effective September 1, 2023, the plan added an automatic contribution arrangement whereby employees eligible to enroll September 1, 2023 and after are automatically enrolled at a contribution rate of three percent (see Note 10). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may elect to defer a portion of their compensation and make a contribution to the Plan. Each year, participants may contribute up to the maximum amount allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. Participant catch-up contributions are permitted by the Plan. The Company makes matching contributions equal to 50% of the participant's elective deferral up to a maximum of \$2,000 for non-highly compensated participants only. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various separate accounts as investment options.

Participant accounts:

Each participant's account is credited with the participant's contributions, allocation of the Company's matching contributions, and allocation of Plan earnings. Allocations are based on compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service with the Company. A participant is fully vested after five years of service.

Note 1. Description of Plan (continued)

Forfeited accounts:

Forfeitures of nonvested balances resulting from termination of service can be used to reduce future employer contributions or pay plan expenses. At December 31, 2024, there was \$14,124 in unallocated forfeitures (\$8,778 in 2023). No forfeitures were used during 2024.

Notes receivable from participants:

Participants are permitted to borrow against their fully vested accounts with the minimum loan being \$1,000 and maximum set at the lesser of 50% of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money, as determined by the Plan administrator or custodian. The interest rate is fixed at the time of the loan agreement.

Payment of benefits:

The vested value of a participant's account is payable upon termination, retirement, death or disability in either a lump sum or installments, in accordance with the terms of the Plan. The non-vested portion of the participant's account will be forfeited.

Hardship withdrawals are permitted as defined in the Plan documents.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Note 2. Significant Accounting Policies (continued)

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan expenses:

Company personnel perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as Plan expenses. The Company paid a portion of plan expenses for the year ended December 31, 2024.

Notes receivable from participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Note 3. Party-In-Interest Transactions

The pooled separate accounts and The John Hancock Stable Value Fund are investment products of John Hancock Life Insurance Company (USA), and therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

The Plan paid administrative service fees to ERISA Services, Inc and Northwestern Mutual.

Fees paid to parties-in-interest totaled \$66,633 for the year ended December 31, 2024.

Note 4. Information Prepared and Certified by Custodian

The following information was compiled from data certified by the custodian, John Hancock Life Insurance Company (USA), as being complete and accurate:

- A. Investments included in the Statements of Net Assets Available for Benefits - December 31, 2024 and 2023.
- B. Investment income included in the Statement of Changes in Net Assets Available for Benefits - Year Ended December 31, 2024.
- C. Investment information included in Schedule of Assets Held at End of Year.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 7. Income Tax Status

The Plan adopted a pre-approved plan document which received an opinion letter from the Internal Revenue Service (IRS) on June 1, 2021, which stated that the prototype basic plan document is designed in accordance with the applicable sections of Internal Revenue Code (IRC). Any employer adopting this form of the plan will be considered to have a plan qualified under the applicable section of the IRC. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Although the plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. No provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require the recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 8. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts (PSAs) invest in mutual funds. The fair value of the mutual funds is a publicly quoted pricing input and is used in determining the net asset value (NAV) of the PSAs, which is not publicly quoted. These PSAs can generally be redeemed at NAV as of the measurement date.

Stable value fund: The NAV for each unit class of the trust is calculated daily by dividing the net assets applicable to each unit class by the respective number of units outstanding for the class. Deposits to and withdrawals from the trust may be made daily at the current NAV per unit. Each unit is equal in value to every other unit.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) The pooled separate accounts and stable value fund are measured using net asset value (NAV) as a practical expedient. In accordance with guidance in ASU 2015-07, which has been adopted by the Plan, these investments have not been classified in the fair value hierarchy table. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Note 9. Fair Value of Investments in Entities That Use Net Asset Value

The investments measured at fair value based on NAV per share have no unfunded commitments, a maximum redemption frequency of two per month, and no redemption notice period as of December 31, 2024 and 2023. Although there is no notice period limitation for redemptions, participants who take redemptions from individual funds are not allowed to transfer back into those funds until the 30-day holding period has expired. New contributions are allowed during this time period.

Note 10. Plan Amendments

Effective September 1, 2023, the Company added an automatic enrollment arrangement whereby all participants whose Plan entry date is on or after September 1, 2023 are automatically enrolled at a contribution rate of three percent.

Note 11. Subsequent Events

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued.
