## Independent Auditors' Report

To the Plan Participants and Plan Administrator  
AAA Northeast Retirement Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are *available to be issued*. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditors' Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.



We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### *Supplemental Schedule Required by ERISA*

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### *Auditors' Report on the 2023 Financial Statements*

Other auditors performed an audit of the 2023 financial statements of AAA Northeast Retirement Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 8, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. Description of Plan**

The following description of AAA Northeast Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

**General**

The Plan was established by AAA Northeast (the Employer) on January 1, 1986. The purpose of the Plan is to accumulate retirement income for its employees which will supplement retirement benefits provided to them by Social Security. The Plan is a contributory single-employer defined contribution plan under the Internal Revenue Code (IRC).

AAA Northeast Retirement Plan & Investment Committee (the Committee) is responsible for the general administration of the Plan. Fidelity Management Trust Company (Fidelity) is the trustee and recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Eligibility**

Employees are eligible to participate in the Plan and receive matching Employer contributions effective upon completing 90 days of service.

**Contributions**

Participants may elect to contribute to the Plan any whole number percentage of their eligible compensation as defined in the Plan (elective deferrals). Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who are at least age 50 before the end of the plan year may make catch-up contributions equal to any whole number percentage of their eligible compensation or whole dollar amount. Participants may not contribute more than the maximum amount allowed by the IRC.

Unless they elect otherwise, employees hired on January 1, 2009 and thereafter are automatically enrolled in the Plan and elective deferrals of 3% are deducted from their eligible compensation beginning on their first day of eligibility for participant contributions. Each July 1, the rate of elective deferral increases 1% until the total elective deferral equals 10%.

**Contributions (continued)**

Safe harbor matching contributions to the Plan are equal to 100% of each participant's elective deferrals up to 6% of each participant's eligible compensation. Additional discretionary contributions may be contributed at the discretion of the Employer's board of directors. No such amounts were contributed for 2024.

**Vesting**

Participants are fully vested in their contributions to the Plan and the earnings thereon. Rollovers and transfers of funds from other qualified plans in which employees cease to participate are permitted and are fully vested.

Participants are 100% vested in Employer safe harbor contributions and discretionary contributions and the related allocated earnings relating to such amounts.

Participants who incur a break in service of less than five years and return to employment retain credit for their pre-break years of service subject to certain rules.

**Forfeitures**

Forfeitures of nonvested Employer contributions are used to reduce Employer contributions in the subsequent period. During the plan year ended December 31, 2024, approximately \$35,000 was forfeited by employees and was used to fund employer matching contributions. There were \$0 forfeitures held in unallocated accounts at December 31, 2024 and 2023.

**Participant Accounts**

Contributions are paid to the trust, which is administered by the recordkeeper, who is responsible for receiving contributions, making distributions, maintaining accounts and records, and rendering an annual report. Participants designate their desired allocation of elective deferrals and related Employer contributions to the Plan's investment funds and retain the right to change their investment allocation on a daily basis. Participants' accounts are credited with their contributions, Employer contributions made on their behalf and earnings thereon, and charged with an allocation of administrative expenses, if any. The earnings generated by the trust's investments and administrative expenses are allocated to participants' accounts daily, based upon the proportionate value of each active account participating in the applicable investment to the total of all accounts participating in the applicable investment as of the valuation date, as defined in the Plan. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Benefits**

Upon termination of employment by reason of normal retirement, death, or disability, participants are entitled to 100% of the amounts credited to their accounts. Upon termination of employment for other than normal retirement, death, or disability, participants are entitled to the vested amounts credited to their accounts.

Upon termination, participants may elect to receive their benefit either in a lump-sum payment or in installments as provided in the Plan and as selected by the participant.

**Participant Loans**

The Plan provides that participants may request a loan from their participant account for any purpose. The maximum loan that may be received cannot exceed the lesser of 50% of the participant's eligible account balance, as defined in the Plan, or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. The minimum loan amount is \$1,000. Loans are secured by the vested balance in the participant's account and bear a fixed rate of interest equal to the prime rate plus one percent at the date of closing. Principal and interest are paid in level payments on at least a quarterly basis and must be completed within five years, with the exception of loans whose proceeds are used for the purchase

of a participant's primary residence, which must be repaid within ten years. Loans in effect prior to January 1, 2012 and used for the purchase of a primary residence may have repayment terms up to thirty years. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**In-Service Withdrawals**

In-service withdrawals are permitted by the Plan up to 100% of a participant's account balance, as defined in the Plan, for participants who have reached the age of 59 ½.

**Hardship Withdrawals**

A qualifying hardship withdrawal may be authorized by the plan administrator to assist a participant in the same manner as loans to participants in an amount up to 100% of a participant's account balance, excluding Employer contributions and related earnings.

Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

**Expenses Not Included in the Financial Statements**

The Employer pays certain professional fees and other expenses related to the Plan; therefore, such expenses are not included in the accompanying financial statements.

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with U.S Generally Accepted Accounting Principles (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell the asset in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

**Notes Receivable from Participants**

Participant notes are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. At December 31, 2024, the Plan's participant notes outstanding bore interest at rates ranging from 4.25% to 9.50% and are due through September 2034. Delinquent notes receivable are reclassified as participant benefit payments upon the occurrence of a distributable event based upon the terms of the plan document. Related fees are recorded as administrative expenses and are recorded when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

**Subsequent Events**

The Plan's management has evaluated subsequent events through August 28, 2025, the date that the accompanying financial statements were available to be issued.

**3. Information Certified by Fidelity**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity, the trustee of the Plan.

**4. Fair Value Measurements**

Accounting guidance pertaining to fair value measurements provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are described as follows:

Level 1 – Values measured using quoted prices in active markets for identical assets

Level 2 – Values measured using other significant observable inputs such as quoted prices for similar assets

Level 3 – Values measured using significant unobservable inputs, including internal assumptions

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs (that is, Level 1 and Level 2 inputs that do not require significant adjustment) and minimize the use of unobservable inputs.

The following is a description of the significant valuation methodologies used for the Plan's investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies – Valued at quoted market prices representing the net asset value (NAV) of the shares held by the Plan at year-end.

Money market account – Valued at closing price reported on the active market on which the money market fund is traded, which represents the fair value of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Party-in-Interest Transactions**

At December 31, 2024 and 2023, all Plan investments are in the custody of the trustee and recordkeeper. Therefore, any transactions between the Plan, the trustee and the recordkeeper, qualify as party-in-interest transactions. In addition, the Plan issues loans to participants, which are secured by the balances in the participant's account and also constitute party-in-interest transactions.

**6. Plan Termination**

Although the Employer has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances to the extent of fair value.

**7. Tax Status**

The Plan has adopted the Non-Standardized Pre-Approved Defined Contribution Plan (Profit Sharing/401(K) Plan, a safe-harbor plan. The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
