To the Audit Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AAA Northway, Inc. Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AAA Northway, Inc. Profit Sharing 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

Description of the Plan

The following description of AAA Northway, Inc. Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a profit sharing 401(k) plan and covers substantially all of the non-union employees of AAA Northway, Inc. (the Company) who meet certain eligibility criteria. Employees are eligible to participate in the Plan upon attaining age 21, working a minimum of 1,000 hours, and completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan permits employees to contribute to the Plan at their own discretion. In addition, the participant is able to receive an employer discretionary match (\$0.75 on each \$1.00 up to 5% of the employee's salary for 2024 and 2023). At the end of every year, the Board of Directors elects an amount, if any, to remit to the Plan based on annual profit. The profit-sharing allocation is calculated based on each participant's total salary for the year as a percentage of total salaries. For profit sharing contributions and forfeitures, each participant's salary is increased by the amount of their salary which exceeds the integration level of \$25,000.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution, discretionary employer matching contribution, an allocation of the employer's discretionary profit-sharing contribution, forfeitures and plan earnings. Participants are immediately vested in their voluntary contributions plus net earnings thereon. Each participant chooses the fund or funds in which contributions are to be invested. A participant may change the fund or funds into which their contributions are invested or transfer all, or a portion of, their account balance between funds upon proper notification by initiating the change/transfer on their own. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. During 2023, all assets were transferred to Ascensus Vanguard – Vanguard is the recordkeeper of the plan and the plan's assets are actually held at Vanguard. Vanguard is the website that participants use to see their account balance. The plan offers a self-directed brokerage option which allows you to select investments in addition to those designated by the plan. This account option is offered through Charles Schwab & Co., Inc.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in AAA Northway, Inc.'s contributions portion of participant accounts is based on years of continuous service and is the earlier of the vesting schedule below or plan termination, the occurrence of normal retirement age (65), or death or disability.

Payment of Benefits

Participants receive their benefits in a single lump sum amount if their balance does not exceed \$5,000. If the balance exceeds \$5,000, participants can receive benefits in a single lump-sum payment or a partial withdrawal.

Forfeited Accounts

Any balance in forfeited accounts will be used to reduce the employer matching and profit-sharing contributions or used to pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$ -. For 2024 and 2023, \$ - and \$1,919, respectively, of forfeitures from partially vested accounts were used to reduce employer contributions. Forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation.

Summary of Significant Accounting Policies

The following is a summary of significant accounting policies, which are in conformity with generally accepted accounting principles and the trust for the Plan:

Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Participant Loans Receivable

Loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans from participants are recorded as distributions based upon the terms of the Plan Document.

Benefits

Benefit payments to participants are recorded when paid.

Plan Expenses

All costs and expenses incurred in connection with the operation of the Plan, other than quarterly statement, loan maintenance and distribution fees, are paid by AAA Northway, Inc. and are not included in the financial statements. The Plan is not responsible for reimbursement to AAA Northway, Inc.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Participant Loans Receivable

Under the terms of the Plan agreement, participants may be approved to borrow up to 50% of their account balances. The minimum loan amount is \$1,000 and the maximum loan cannot exceed the lesser of 50% of the account balance or \$50,000. The loans are secured by the participant's account (subject to the terms of the Plan and in accordance with applicable legal requirements). Participant loans are payable over a period, no longer than five years, together with interest at market rates. However, loans made for the purchase of a primary residence may not exceed 30 years. Participant loans were \$109,532 and \$101,214 at December 31, 2024 and 2023, respectively, with stated interest rates of 9.50% to 4.25%.

Plan Termination

Although it has not expressed any intent to do so, AAA Northway, Inc. has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balance.

Income Tax Status

The underlying non-standardized prototype plan has received an opinion from the Internal Revenue Service (IRS) dated March 31, 2014, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is tax exempt. In accordance with Revenue Procedures 2011-49 and 2011-44 I.R.B 608, the plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The prototype plan has been amended to comply with recent legislation. The Plan has not filed for its own determination letter. However, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Parties-in-Interest

The Plan utilizes vendors to provide services to the Plan including, but not limited to its annual audit, participant record keeping, trustee and custodian of assets and insurance coverage. Such service providers are parties-in-interest under ERISA.

For the years ended December 31, 2024 and 2023, there were no prohibited transactions between the Plan and the parties-in-interest.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
