## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Woodland Park Zoological Society 403(b) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Woodland Park Zoological Society 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Woodland Park Zoological Society 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Woodland Park Zoological Society 403(b) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Woodland Park Zoological Society 403(b) Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with generally accepted auditing standards, we:

Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Woodland Park Zoological Society 403(b) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule") is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Woodland Park Zoological Society 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established August 1, 2002 and restated effective December 1, 2021, to provide voluntary retirement benefits and tax deferred savings opportunities to eligible employees of the Plan's sponsor, Woodland Park Zoological Society (the "Zoo", "Employer", or "Plan Sponsor"). The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination of employment, or financial hardship. The Plan covers all eligible employees of the Zoo upon employment, as defined by the plan documents. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the Internal Revenue Code (IRC).

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Zoo has until the end of the first plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of December 31, 2024, however, certain provisions were administratively adopted during the year (see Note 1, Payment of benefits).

Plan administration

The Plan Sponsor is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Plan Sponsor has delegated certain responsibilities for the operation and administration of the Plan. Recordkeeping services are provided by Lincoln Retirement Services Company, LLC. Custodian services are provided by Lincoln Financial Group Trust Company, Inc. (the "Custodian"). Certain administrative expenses of the Plan, including recordkeeping and audit fees were paid by the Zoo for the year ended December 31, 2024. Investment fees, which may vary according to the individual funds selected, are paid out of the assets of the Plan.

Eligibility

All employees, except leased employees are eligible to participate in the Plan upon hire and make elective deferrals. Employees become eligible for Employer discretionary matching contributions, if any, after completing six months of service.

Contributions

Each year, participants may contribute up to 100% of their annual eligible compensation, as defined in the plan documents, on a pre-tax basis or Roth basis, up to the maximum allowed by the IRC. Participants who have attained age 50 before the end of the Plan year may make an additional catch-up contribution of up to \$7,500 annually. Participants may also contribute amounts representing distributions from other qualified employer-sponsored retirement plans (rollovers).

The Employer may make discretionary matching contributions to eligible participants. The Zoo approved and made discretionary Employer matching contributions up to 6% of eligible compensation for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Employer discretionary matching contributions, if any, and Plan earnings, and charged with Plan losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Notes receivable from participants (participant loans) must be repaid within five years, unless the loan is for the purchase of a principal residence, in which case the repayment term may not exceed fifteen years. The loans are secured by the remaining vested balance in the participant's account and bear interest at a rate determined by the prime rate as of the first calendar quarter plus 2%. Principal and interest are paid directly to the Custodian on a monthly or quarterly basis. All participant loans become immediately payable in the event of default or termination of employment. A participant may have only two notes receivable outstanding at any time. As of December 31, 2024, the rate of interest on active outstanding participant loans ranged from 5.25% to 10.50% with various maturities through October 2038.

1. DESCRIPTION OF THE PLAN (continued)

Payment of benefits

Distribution and withdrawals are payable upon retirement, termination of employment, financial hardship, attaining age 59 ½ while still employed by the Zoo, disability, or death. Prior to April 1, 2024, for balances of \$5,000 or below upon termination of employment, the participant is eligible to receive a lump sum distribution or rollover to another qualified plan. Effective April 1, 2024, the Plan increased the involuntary cash-out threshold from \$5,000 to \$7,000 in accordance with SECURE 2.0. The funds will be rolled over to an individual retirement account designated by the administrator if the participant does not elect to receive a distribution of such amount. If the account balance exceeds \$5,000 prior to April 1, 2024, or \$7,000 on or after April 1, 2024, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, installment payments, annuity payments, or postpone payment to a later date and remain in the Plan as described in the plan documents.

Hardship distributions are permitted for immediate and heavy financial needs, as defined in the plan documents, from a participant's elective deferral account.

Vesting

Participants are immediately vested in their voluntary contributions, plus earnings thereon.

Vesting in the Employer discretionary matching contribution portion of their accounts and earnings thereon is based on years of service. A participant is 100% vested after four years of credited service, building to this in annual increments of 25%. Pursuant to the Woodland Park Zoo Operations and Management Agreement and the subsequent Employee Transition Plan, the Plan allows service years earned by City of Seattle employees, who were previously assigned to the Zoo and elected to become Zoo employees, to count as service years for vesting credit. A participant's vesting percentage increases to 100% if the employee, while employed by the Zoo, reaches early retirement age (defined as age 55), dies, or terminates employment due to becoming disabled.

Administrative and investment related expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Zoo. Expenses that are paid by the Zoo are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees paid related to benefits paid are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Forfeitures

Forfeitures may occur as a result of excess Employer contributions or forfeited non-vested Employer contributions. Forfeitures are retained in the Plan and may be used to pay Plan expenses or reduce the matching contributions of the Employer. For the year ended December 31, 2024, \$44,206 of forfeitures were used to reduce Employer matching contributions and no forfeitures were used to pay Plan expenses. Forfeited non-vested accounts totaled \$9 and \$3,030 as of December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared under the accrual basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates. Significant items subject to such estimates and assumptions include the fair value of investments.

Investment valuation and income recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4). Contract value is the amount to be received by a participant under the terms of the investment contract, generally contributions plus earnings, less distributions and expenses (Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of fair value of investments includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Notes receivable from participants

Notes receivable from participants represents loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Contributions and receivables

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Zoo, which is the pay date. Zoo contributions, if any, are recorded in the year they are earned. The Plan records receivables based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Rollover contributions from participants are recorded based on the date the contributions are received by the Custodian.

Subsequent events

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued. No subsequent events have occurred which would require recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Custodian (Note 1), determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of the following information ("certified information"):

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023; and,

- Net appreciation in fair value of investments and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and,
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) ("supplemental schedule") as of December 31, 2024.

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to measurements involving significant unobservable inputs (Level 3).

The fair value hierarchy levels of inputs that may be used to measure fair value are as follows:

- *Level 1* - inputs are quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;
- *Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- *Level 3* - significant unobservable inputs (including management's own assumptions in determining the fair value of investments) are used to arrive at fair values..

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Under U.S. GAAP, fully benefit-responsive investment contracts are valued at contract value and, therefore, are not categorized within the fair value hierarchy (Note 5).

5. GROUP ANNUITY CONTRACT WITH LINCOLN NATIONAL INSURANCE COMPANY

The Lincoln Stable Value Account is a fixed group annuity contract issued by The Lincoln National Life Insurance Company (the "Issuer"). It is issued to the Plan itself, so participants have a beneficial interest in the Plan's group annuity contract. The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the Issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments. The Lincoln Stable Value Account has crediting rates based on an external index that are backed by the general account of the issuing company. The crediting interest rates of the contract were 3.89% and 2.56% as of December 31, 2024 and 2023, respectively.

A premature termination of the Plan's contract, or other occurrences such as Plan termination, could limit the Plan's ability to withdraw 100% of the participants' interests in this account. Plan management believes these events are highly unlikely.

The value of the fixed group annuity contract is derived from the contract provisions, which is backed by the general account of the Issuer. The contract value is defined as the value of the contract owner account. It is the sum of contributions plus interest credited, less withdrawals. Should the Plan stop investing in the fixed group annuity contract, under no circumstances would the Plan have to receive installment payments greater than one year to withdraw all of the Plan funds at contract value. Several events could cause the Issuer to cancel the contract, such as non-payment of any charges, no additional deposit activity, or discontinuation. Plan management believes these events are highly unlikely.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similar to a related party as defined in U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be party-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more such employer or employee association or relatives of such person.

Certain fees and expenses of the Plan are paid by the Plan Sponsor. The Plan is not required to repay these expenses. The Plan has included in its investment fund options certain funds managed by the Custodian; therefore, these transactions qualify as exempt party-in-interest transactions.

7. TAX STATUS

The Plan has adopted a Volume Submitter 403(b) Plan (the "volume submitter plan") sponsored by Lincoln Retirement Services Company LLC. The Internal Revenue Service has issued an opinion letter dated March 31, 2017, that the volume submitter plan was designed in accordance with applicable sections of the IRC and is available for use by employers for the benefit of their employees. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and that it, and the related trust, are tax-exempt. No provision for income taxes has been included in the Plan's financial statements.

8. PLAN TERMINATION

While it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested and nonforfeitable.
