#### **1. DESCRIPTION OF THE PLAN**

The following description of the 9 Dot Education Solutions Group Insurance Arrangement (the “Plan”) sponsored by the Trustees, through which various welfare plan benefits within the meaning of Employee Retirement Income Security Act of 1974 (“ERISA”) Section 3(1) are offered to employees of Participating Employers throughout the Trust provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan was established on March 1, 2020, to provide health and other benefits to eligible employees and covered dependents of Participating Employers (the “Employers”). The Plan operates as a group insurance arrangement with a trust used as a conduit through which contributions from Participating Employers and Participants are paid to insurance carriers for the provision of certain welfare plan benefits. The Plan is subject to the provisions of the ERISA, as amended.

**Eligibility** – In general, full-time employees who are employed an average of at least 30 hours of service per week with the Employer are eligible to participate. Independent contractors leased employees and individuals designated by the Employer as temporary employees shall not be Employees for purposes of the Plan. Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Participating Employer makes contributions to the Plan on their behalf. The participants’ coverage will end on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

**Contributions** – Participating Employers contribute to the Plan on behalf of employees who are eligible to receive health benefits under the Plan and have enrolled in coverages offered under the Plan. Although the employee’s portion of insurance premiums are deducted from employees’ wages, they are not separated from employer contributions when remitted to the trust and are therefore included in member contributions on the statement of changes in net assets available for benefits. Accounting principles generally accepted in the United States of America (“GAAP”) require separate disclosure of employer and employee contributions. Each employer determines the cost allocation between employee and employer to provide benefits. Based on how the Plan is administered, it is not feasible to segregate between the source of the contributions and, consequently, that information is not disclosed in the accompanying financial statements.

**Benefits** – The Plan provides health benefits (medical, vision, dental), life insurance, short and long-term disability benefits, accidental death and dismemberment benefits and critical illness benefits to eligible members and to their beneficiaries and dependents. The Plan administrator purchases annual insurance contracts for these benefits on a fully insured basis. Premiums for these insurance contracts are paid to the insurance companies by participating employers through the trust.

#### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of accounting*** – The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with GAAP.

***Use of estimates*** – The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Contributions receivable*** – Member contributions due but not collected by year end are recorded as contributions receivable from members. The Plan’s management generally does not consider credit evaluations of its members necessary as historical collections have been within management’s expectations. As such, an allowance for doubtful accounts is considered unnecessary.

***Administrative expenses*** – The Plan pays certain administrative expenses consisting of administrative fees paid to insurance companies and brokers. These expenses are included in the insurance premiums reported on the statement of changes in net assets available for benefits as they are not separately identifiable. All other administrative expenses are paid by the Plan Administrator, 9 Dot Education Solutions, LLC.

***Payment of benefits*** – Premiums paid by the Plan are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits and a corresponding member contribution receivable is simultaneously recorded. Premium payment surpluses are recorded as prepaid insurance premiums. Insurance premiums payable were not material as of February 28, 2025 and February 29, 2024. There were no prepaid insurance premiums as of February 28, 2025 or February 29, 2024.

***Subsequent events*** – The Plan’s management evaluates events or transactions occurring after the statement of net assets available for benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. For the purposes of the accompanying financial statements, subsequent events have been evaluated through August 29, 2025, which represents the date the financial statements were available to be issued.

#### **3. TAX STATUS**

The Plan operates as a Group Insurance Arrangement within the meaning of Department of Labor Regulation Section 2520.104a-6. The trust established for the Plan has not applied for exemption from tax. Management does not believe there is activity that would subject the trust to income taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **4. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Administrator has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all assets of the trust shall be used for the exclusive purpose of providing benefits to the Participants. In no event shall the assets of the Trust revert to the participating employers upon termination of the trust.

#### **5. PARTY-IN-INTEREST TRANSACTIONS**

The Plan has several agreements with service providers. Transactions related to these service agreements qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA.
