## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Haver & Boecker Holding USA Profit Sharing & Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

NOTES TO FINANCIAL STATEMENTS

**Note 1. Description of Plan**

The following description of the Haver & Boecker Holding USA Profit Sharing & Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan that covers substantially all employees of Haver & Boecker Holding USA, Inc., Haver Tyler Inc., Major Wire Screening, Inc., Major Wire Screen Media, Ltd., and Major Wire Texas, Inc. (collectively the "Company"), who are at least 18 years of age and have completed three months of service. The Plan became effective January 1, 1998. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. As of November 1, 2024, the Plan was amended to make Haver & Boecker Holding USA the Plan Sponsor.

Administration:

The plan administrator oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the plan administrator.

Contributions:

Participants may elect to contribute on a pre-tax or Roth 401(k) basis a portion of their eligible compensation subject to certain limitations of the Plan and the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral includes an escalation provision where a participant's deferral percentage increases by 1% on January 1 of each plan year until the deferral reaches 10%, unless the participant elects annually to opt out of this increase. The Company has elected to make annual "safe harbor" matching contributions to the Plan equal to 100% of each participant's elective deferrals that do not exceed 4% of each participant's compensation for the Plan year.

Participant Accounts:

Participant and employer contributions are invested in various investment funds in proportions selected by each participant. Dividends, interest, and other income earned are reinvested by the fund managers in the fund for which such income was received. Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of Plan earnings and expenses based on account balances maintained or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are at all times 100% vested in their accounts.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 1. Description of Plan (Continued)**

Notes Receivable From Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and the loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits:

Upon termination of service due to death, disability, retirement, or attainment of age 59½ a participant may elect to receive distributions either as a lump-sum distribution equal to his or her vested account balance or periodic installments over a period not to exceed the participant's life expectancy. Under certain circumstances, a participant's ability to receive distributions is restricted until the participant reaches age 59½. If a terminated participant's account balance is between \$1,000 and \$5,000, the plan administrator will make an automatic rollover of the account balance to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the plan administrator directs Empower Trust Company, LLC, the Trustee of the Plan, to make a lump-sum distribution. Distributions of a participant's account balance may be authorized at any time by the Investment Committee under certain hardship conditions, as defined.

**Note 2. Summary of Significant Accounting Policies**

- A. Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").
- B. Investment Valuation and Income Recognition – Investments are reported at fair value as reported by the Trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- C. Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. An allowance for credit losses of \$1,090 has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 2. Summary of Significant Accounting Policies (Continued)**

D. Plan Expenses – All administrative fees of the Plan are paid by the Plan or by the Company at the option of the Company except fees related to participant loans and distributions, which are paid by the affected participants.

E. Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

F. Benefit Payments – Benefits are recorded when paid.

G. Subsequent Events – The Plan has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

**Note 3. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time, subject to the provisions of ERISA.

**Note 4. Unaudited Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received a certification from Empower Trust Company, LLC, the Trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable from participants, with the exception of the participant-directed brokerage accounts, reflected in the statements of net assets available for benefits at December 31, 2024 and 2023, the supplemental schedule at December 31, 2024, the related investment and loan interest activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 5. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3 – Unobservable inputs in which little or no market data exists

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 5. Fair Value Measurements (Continued)**

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- Common/collective trust funds: The investment in the common/collective trust funds is valued at their closing net asset value ("NAV"). The NAV is based primarily on observable inputs, the market value of the underlying investments, and is classified as Level 2.
- Registered investment companies: Valued at quoted closing market price reported in active markets for identical investments, and are classified as Level 1.
- Common stock: Valued at the closing price reported in the active market in which the individual securities are traded, and is classified as Level 1.
- Cash: Interest bearing cash is classified as Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Income Tax Status**

The Plan has adopted a prototype plan document. This prototype document has obtained an opinion letter dated November 14, 2022 from the Internal Revenue Service ("IRS") in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8. Party-in-Interest Transactions**

Certain plan investments are held in funds managed by JPMorgan Chase Bank, N.A. ("JPMorgan").
