## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## NOTES TO FINANCIAL STATEMENTS

---

### 1. DESCRIPTION OF THE PLAN

The following brief description of the Fazio Mechanical Services, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan covering substantially all employees of Fazio Mechanical Services, Inc. (the "Company") excluding union, leased, and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### CONTRIBUTIONS

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan subject to limitations of the Internal Revenue Service. Participants may also contribute Roth contributions to the Plan on an after-tax basis. The Plan provides for a safe harbor contribution of 3% of participants' compensation. There are no age or service requirements for a participant to make a salary deferral and receive a safe harbor contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company may also make annual discretionary profit sharing contributions to the Plan as approved by management. To be eligible to receive profit sharing contributions, a participant must have attained age 21, completed one (1) year of service, and be employed the last day of the Plan year.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a person is entitled is the benefit that can be provided from the participant's vested account.

#### VESTING

Participants are immediately vested in their contributions, the safe harbor contribution, and actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after six years of credited service.

### **PAYMENT OF BENEFITS**

Upon termination of service, death, disability, or retirement, a participant may elect to receive the vested interest in their account either in the form of a lump-sum payment, or a life annuity.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **BASIS OF ACCOUNTING**

The accompanying financial statements of the Plan are presented under the accrual method of accounting.

### **NOTES RECEIVABLE FROM PARTICIPANTS**

Loans are not permitted.

### **USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **PAYMENT OF BENEFITS**

Benefits are recorded when paid.

### **FORFEITED ACCOUNTS**

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture. Forfeitures may be used to offset Plan expenses, reduce future employer contributions, or allocated to participant accounts. Forfeited non-vested accounts totaled \$4,902 and \$5,540 as of December 31, 2024 and 2023, respectively.

## **SUBSEQUENT EVENTS**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 28, 2025, the date the financial statements were available to be issued.

## **3. FAIR VALUE MEASUREMENTS**

The Plan measures its investments at fair value on a recurring basis in accordance with accounting principles generally accepted in the United States of America. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that authoritative guidance establishes for measuring fair value includes a hierarchy used to classify inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value measurement.

The levels of the fair value hierarchy are as follows:

Level 1 – Fair value is based on unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.

Level 2 – Fair value is based on significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Level 3 – Fair value is based on significant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- Registered investment companies (mutual funds) are valued at Level 1. Shares of mutual funds are valued at the quoted net asset value (“NAV”) of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Investments measured at NAV: The common collective trust is based upon the units of the collective trust funds held by the Plan at year end times the respective unit value. The collective trust funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business fashion. The Plan’s investment in the funds is not subject to any withdrawal restrictions, and distributions may be taken at any time. The Plan has no unfunded commitments relating to the funds at December 31, 2024 and 2023. The objective of the fund is to provide investors with a moderate level of stable income without principal volatility.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's assets are administered under a contract with Capital Bank and Trust Company (the "Trustee"), a party-in-interest as defined by ERISA. Contributions are held and managed by the Trustee, who invests cash received. The Trustee invests investment income and makes distributions.

Except for withdrawal fees associated with benefit payments and investment advisory fees, all reasonable expenses of maintaining the Plan are paid by the Company.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

#### **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become one hundred percent vested in their accounts.

#### **6. TAX STATUS**

The Company adopted a prototype volume submitter profit sharing plan with a cash or deferred arrangement ("CODA") which the Internal Revenue Service has determined and informed the prototype plan author by a letter dated March 31, 2014 that the prototype plan was designed in accordance with section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. Although the Plan has been amended since receiving this determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related custodial accounts are tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate Plan tax positions and recognize a tax liability (or asset) if the Plan has entered into an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Company analyzed the tax positions taken by the Plan, and possible recognition of a liability (or asset) or disclosure in the financial statements. Additionally, the Plan has not incurred any penalties by any taxing jurisdictions for any reason. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

## **7. INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2502.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustee has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of Schedule H, Line 4(i) – Schedule Of Assets (Held At End Of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year then ended. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **8. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **9. RECONCILIATION TO FORM 5500**

The DOL regulations [Reg. 2520.103-1(b)(3)] require the notes to the separate financial statements to explain any variances from accounting principles generally accepted in the United States of America or differences between the information reported in the separate statements and in Schedule H. There were no material differences between the financial statements and the Form 5500.




