### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Clarity Care, Inc. Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Clarity Care, Inc. ### Note 1 – Plan Description

The following description of the Clarity Care, Inc. Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Clarity Care, Inc. (Employer). The Plan is a 403(b) plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee is responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Employees become eligible to make elective deferrals and receive employer matching contributions upon their date of hire; but if hired to work less than 1,000 hours, that employee is not eligible to participate until the employee has worked 1,000 hours in twelve months.

The Plan uses the hours of service method for purposes of determining whether or not the employee is entitled to have an Employer contribution allocated to their account. Employees who make elective deferrals and complete at least 1,000 hours of service during the Plan year are eligible to receive an employer matching contribution. The employee must be employed as of the last day of the year to be eligible for the employer contribution. The Employer's matching contribution on elective deferrals will be determined each year and contributed to each eligible participant.

#### Contributions

Employee pre-tax and Roth contributions are limited to thresholds set by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Additionally, participants who have attained 15 years of service before the end of the Plan year are eligible to make a separate catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Annually, the Employer's matching contribution amounts will be determined by the Employer's board of directors. For the year ended December 31, 2024, the matching contribution was 100% of participant deferrals up to 2%. Matching contributions of \$59,114 were made by the Employer for the year ended December 31, 2024.

Upon enrollment in the Plan, a participant may direct the investment of their contributions and employer contributions into various mutual fund investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Employer's matching contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and actual earnings on these contributions. Vesting in matching contributions and related earnings thereon is based on years of continuous service. A participant is 100% vested in matching contributions and related earnings after three years of credited service. Participants become 100% vested in employer matching contributions in cases of termination due to death or disability while an employee.

#### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installment payments over a period not to extend beyond the participant's life expectancy.

#### Forfeitures

Forfeitures represent the non-vested portion of a terminated participant's account balance. Forfeitures remain in the Plan and are either 1) allocated to remaining Plan participants as additional employer contributions, 2) used to reduce employer contributions to the Plan, or 3) used to reduce Plan expenses. There were \$13,916 and \$6 of forfeited nonvested accounts as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, employer contributions were reduced by \$1,137 from forfeited nonvested accounts.

### Note 2 – Summary of Significant Accounting Policies

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follow.

#### Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

All expenses of maintaining the Plan are paid by the Plan. Investment related expenses are included in net appreciation in the fair value of investments.

#### Subsequent Events

Subsequent events were evaluated through August 5, 2025, which is the date the financial statements were available to be issued.

### Note 3 – Risks and Uncertainties

The Plan invests in various investment securities through mutual funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 4 – Tax Status of Plan

403(b) plans currently are not required to submit plan documentation to the Internal Revenue Service for determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 5 – Party-In-Interest Transactions

Certain Plan investments are managed by Empower Trust Company, LLC (Empower). Empower is the custodian as defined by the Plan. MAP Retirement (MAP) records certain transactions of the Plan and prepares the Plan's Form 5500. KerberRose SC (KerberRose) performs the financial statement audit of the Plan. Transactions with Empower, MAP, and KerberRose qualify as party-in-interest transactions. Fees paid to these parties-in-interest for the year ended December 31, 2024 totaled \$56,501.

### Note 6 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the custodian of the Plan).
