NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Applied Imaging Systems Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Lowery Corporation (Company), the Plan sponsor and the employees of ShredHub Inc. Employees become eligible to participate in the Plan on the first day of the calendar quarter following six months of employment and attaining age 18. Upon participation in the Plan, an employee is eligible to receive discretionary matching contributions and profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established January 3, 1990 and was restated effective January 1, 2022, to comply with legislative and regulatory changes.

Contributions

Participants may elect to make contributions to the Plan through payroll deductions from each participant's compensation, as defined, subject to statutory limitations. Effective December 1, 2021, participants may also make after-tax contributions and in-plan Roth rollovers and transfers are also allowed. Newly eligible employees will be automatically enrolled to defer 5% of their eligible compensation unless they elect otherwise. If eligible prior to January 1, 2020, the automatic deferral will remain at 3% of compensation, unless a separate election is made. The Plan also allows participants to transfer funds from other employer qualified plans into the Plan.

The Company may elect to provide a discretionary matching contribution. For the 2024 plan year the company elected to match 100% of a participant's compensation deferral up to a maximum of \$1,400. The Company may also elect to make a discretionary profit-sharing contribution to eligible participants who are employed on the last day of the Plan year. For the 2024 plan year this amount was \$479.89 per eligible participant.

Plan Operations

The Company has appointed Capital Bank and Trust Company to act as trustee, along with certain employees of the Company, and the Company to act as Plan administrator. The trustee is responsible for holding the investment assets of the Plan, executing investment transactions and making distributions to participants. The Plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, the Company's profit-sharing contribution, and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct all investment transactions associated with separate investment fund options made available by the employer for this purpose, as listed in the accompanying schedule of assets held at end of year.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer matching and profit-sharing contribution accounts is based on years of continuous service, as follows:

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of early or normal retirement age.

Notes Receivable from Participants

The Plan does not provide for participant loans.

Payment of Benefits

On termination of service a participant may elect to receive a lump sum amount equal to the value or a portion of the value of the participant's vested interest in his or her account. In-service withdrawals and hardship distributions are permitted subject to certain conditions and limitations.

Forfeited Accounts

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$108,228 and \$44,090, respectively. These accounts will be used to reduce future employer contributions. At December 31, 2024, \$108,228 was used from the forfeited nonvested accounts to reduce the 2024 employer match and profit sharing contribution receivable.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. While management believes it has consistently applied its best judgment in those areas requiring estimates, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefits paid to participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

For the year ended December 31, 2024, plan management has evaluated subsequent events for potential recognition and disclosure through August 21, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS AND DISCLOSURES

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The mutual funds have been valued using unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Using unadjusted quoted prices for identical investments in an active market is defined as a level 1 measurement method.

The collective trust: The fair value of participation units held in the Reliance MetLife Series 25053 CL 0 Fund, a collective trust (CCT) is based on net asset value, as reported by the manager of the collective trust fund, Reliance Trust Company. The CCT invests entirely in the MetLife Group Annuity contract 25053, which consists of separately managed investment portfolios as directed by Reliance Trust Company. The CCT provides for daily redemptions by the Plan at reported net assets value, with no advance notice requirements.

NOTE 4 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the Trustee, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Revenue sharing credits are included in investment earnings. The Plan made direct payments to the third party administrator and other parties-in-interest of \$128,153 for the Plan year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the plan's operations.

NOTE 5 - TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - INCOME TAX STATUS

The Plan was restated effective January 1, 2022 to comply with legislative and regulatory changes. The volume submitter plan used by the Plan obtained an opinion letter dated July 3, 2025, in which the Internal Revenue Service stated that the volume submitter plan was designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 8 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

All investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and the net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Capital Bank and Trust Company, the trustee.
