## Notes to Financial Statements

---

### 1. Description of the Plan

The following brief description of the Williams Brothers Trucking, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan is a defined contribution plan and is sponsored by Williams Brothers Trucking, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Eligibility*

The Plan covers all employees of the Company who attain the age of 21 and have completed twelve months of credited service. Participation in the Plan can be elected quarterly, subsequent to the above conditions being met. Long-term part-time employees who met eligibility requirements under SECURE 2.0 are also eligible to participate in the Plan.

#### *Contributions*

Each year, participants may contribute, on a pre-tax basis, up to 100% of their eligible compensation, as defined by the Plan, through payroll deductions, not to exceed the dollar limitation set forth in Section 402(g) of the Internal Revenue Code (IRC) in effect at the beginning of the Plan year. Eligible employees who have attained age 50 before the close of the Plan year are allowed to make catch-up contributions up to the maximum allowed by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. A current description of the investment funds may be obtained from the Plan administrator.

The Company may make discretionary matching contributions determined and contributed each payroll period. The Company may also make discretionary profit-sharing contributions determined and contributed on an annual basis. To receive an allocation of the discretionary profit-sharing contributions, a participant generally must be employed on the last day of the Plan year and have completed 1,000 hours of service. For the year ended December 31, 2024, no discretionary profit-sharing contributions were made. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 100% of the first 4% of compensation contributed to the Plan.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses). Allocations are based on participant compensation, deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### *Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in Company contributions plus actual earnings based on years of continuous service, as follows:

### 1. Description of the Plan (cont.)

#### *Notes Receivable from Participants*

Participant loans are not permitted by the Plan.

#### *Payment of Benefits*

Participant accounts may be withdrawn upon retirement, death, disability, attainment of age 59½, or termination of employment, as a lump-sum or in the form of installments as specified in the Plan. On termination of service due to any other reason, the participant may elect to receive a lump-sum or rollover to an eligible retirement plan in the amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account designated by the Company. In-service and hardship distributions are available to participants provided certain requirements are met. In-service distributions are limited to withdrawals from 100% vested accounts. Hardship distributions are limited to withdrawals not exceeding a participant's salary deferrals.

#### *Forfeitures*

Forfeited non-vested accounts totaled \$1,793 and \$3,048 at December 31, 2024 and 2023, respectively. Matching contribution amounts forfeited, plus earnings (losses) thereon, may be used to reduce employer contributions or pay Plan expenses. During the year ended December 31, 2024, \$381 and \$3,360 of forfeited funds were used to reduce employer contributions and pay Plan expenses, respectively.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The investments of the Plan are reported at fair value with the exception of the fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount participants normally would receive if they initiate permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

### 2. Summary of Significant Accounting Policies (cont.)

#### *Investment Valuation and Income Recognition (cont.)*

Purchases and sales are recorded on a trade-date basis. Interest is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Payment of Benefits*

Benefit payments are recorded upon distribution.

#### *Plan Expenses*

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan agreement. Certain other administrative expenses of the Plan are paid by the Company. Investment fees are paid by the Plan in the form of reductions of net investment income (loss) earned by Plan participants.

### 3. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Annuity Insurance Company of America (EAIC) and Empower Trust Company, LLC (ETC) (collectively, "Empower"), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### 4. Investment Contract with Insurance Company

The Plan holds a fully benefit-responsive guaranteed investment contract with EAIC, originally issued by Talcott Resolution Life Insurance Company (Talcott). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. The credit rate is reviewed on a semi-annual basis for resetting. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### 4. Investment Contract with Insurance Company (cont.)

Certain events limit the Plan's ability to transact at contract value. Such events include the following: amendments to the Plan documents, changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

### 5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

#### *Basis of Fair Value Measurement*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled Separate Account* - The fair value of the pooled separate account is based on the net asset value (NAV) of the account calculated based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments at fair value as of December 31, 2024 and 2023 are made up entirely of a pooled separate account, which is measured at the NAV as a practical expedient. In accordance with Subtopic 820-10, certain investments that were measured as such are not classified in the fair value hierarchy. The Plan has no assets at December 31, 2024 and 2023 that are classified in the fair value hierarchy.

### 6. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by NWRPC LLC. The Internal Revenue Service (IRS) has opined and informed NWRPC LLC by a letter dated September 23, 2022, stating that the form of the pre-approved document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

### 8. Related Parties and Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. The Plan invests in a guaranteed interest account provided by EAIC and in a pooled separate account maintained by ETC that were originally issued by Talcott. ETC is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Various administrative expenses of the Plan are paid directly by the Company.

### **9. Risks, Uncertainties, and Concentrations**

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

At December 31, 2024, approximately 21% and 20% of the Plan's investments were invested in the Franklin Moderate Allocation R fund and the Guaranteed Interest Account, respectively.

### **10. SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

### **11. Subsequent Events**

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, July 28, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
