Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Baker Drywall Partnership, L.L.P. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certification from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Baker Drywall Partnership, L.L.P. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by Baker Drywall Partnership, L.L.P. and participating employers, (collectively referred to as the “Company”), under the provision of section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company.

Substantially all employees of the Company who have completed one year of service, as defined, are eligible to participate, provided they are at least 20 years of age. Effective May 31, 2020, the age requirement for eligibility was reduced from 20 years of age to 18 years of age. Certain employees are excluded from participation, including employees covered by a collective bargaining agreement, leased employees, nonresident aliens, and interns. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Plan Administration

The Plan is administered by the Company. The Plan’s trustees are appointed by the Company. The duties of the trustees are to oversee the operations and administration of the Plan in accordance with the specific terms of the Plan, provide for prudent investment of Plan assets, and keep accurate records and reports. Accordingly, the trustees have been granted discretionary authority concerning investment and management activities.

Jackson National Life Insurance Company (“Jackson”) is responsible for the custody and management of the Plan’s individual variable annuities. Fidelity Management Trust Company (“Fidelity”) is responsible for the custody and management of all remaining assets for the Plan and serves as the record-keeper of the related participant accounts, as well as the third-party administrator for the Plan. Jackson and Fidelity are collectively referred to as the Custodians.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan, subject to the dollar limitation under section 402(g) of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2022, the Company reinstated the Plan’s safe harbor matching provision, where the Company makes safe harbor matching contributions to the 401(k) plan of 100% of the election deferral that does not exceed 3% of compensation, plus 50% of the elective deferral between 3 and 5% of the employee’s compensation. Additional profit sharing amounts may be contributed at the option of the Company. Contributions are subject to certain limitations. Company matching contributions to the Plan were \$1,172,727 and \$1,112,044 for 2024 and 2023, respectively. The Company did not make discretionary profit sharing contributions to the Plan in 2024 and 2023, respectively.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related employer matching and discretionary contributions, as well as the participant’s share of investment income, appreciation (depreciation), administrative expenses, and any related distributions. The participant determines both the amount to be invested and the allocation of the investment to one or more of the investment alternatives. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions and any safe harbor employer matching contributions, plus the earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts is based on years of vesting service, as defined in the Plan. A participant is 100% vested after five years of credited service. Full and immediate vesting will also occur upon early retirement, death, or disability, as defined in the Plan. Participants who leave the Company before they are fully vested in the Company's contributions forfeit their non-vested portion.

Investment Options

Upon enrollment in the Plan, the participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds maintained by the Custodians, and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their account balance, whichever is less. A participant can only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Loans may not exceed a term of five years, unless the loan is for the purchase of the participant's principal residence. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, retirement, death or disability, a participant (or a participant's beneficiary in the event of death) may leave their account in the Plan or elect to receive a lump-sum distribution equal to the participant's vested account balance, installments, a partial distribution, or a joint and 100% survivor annuity. However, if the vested account balance of the terminating participant's account is \$5,000 or less, the participant may only receive a lump sum distribution or direct rollover. Effective June 21, 2021, if the account is \$1,000 or less, the terminating participant may only receive an involuntary cash-out of his or her vested account balance. Participants are allowed to withdraw employee account balances prior to termination of their employment under certain conditions as specified in the Plan, including in-service and hardship distributions. Benefits are recorded when paid.

Forfeited Amounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$41,383 and \$26,912, respectively. Forfeitures of terminated participant's non-vested accounts may be used to pay administrative expenses, fund restorations of forfeitures, or to reduce employer contributions. For the years ending December 31, 2024 and 2023, forfeitures of \$1,614 and \$2,578 were used to pay Plan administrative expenses and \$0 and \$27,157 were used to reduce employer contributions, respectively. No amounts were used to fund restorations of forfeitures for the years ending December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting. Certain administrative expenses of the Plan are paid by the Plan. The remaining administrative expenses are paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. The Plan has no obligation to reimburse the Company for these expenses. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses in the accompanying statements of changes in net assets available for benefits.

Adoption of New Accounting Pronouncement

Effective January 1, 2024, the Plan adopted Accounting Standards Update ("ASU") 2025-05, *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets*. The Plan has elected to adopt the following practical expedients from this ASU: 1) The Plan assumes that the current conditions as of the statement of net assets available for benefits date do not change for the remaining life of the assets. 2) The Plan considers collection activity after the statement of net assets available for benefits date when estimating expected credit losses. This ASU has been applied to notes receivable from participants. The adoption of this ASU did not have a material impact on the financial statements.

Use of Estimates

In preparing financial statements in conformity with GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable from participants earned interest of \$72,589 and \$77,992 the years ended December 31, 2024 and 2023, respectively, which is included in interest and dividends in the accompanying statements of changes in net assets available for benefits. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Notes receivable from participants have interest rates ranging from 4.25% to 9.50% and are due at various dates through August 2044.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in fair value are reflected in operations. Interest bearing cash and mutual funds represent investments with various investment managers. The respective fair values of these investments are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in interest bearing cash and mutual funds are traded on national securities exchanges and are valued at the net asset value ("NAV") at year end. Individual variable annuities with insurance company are valued, as a practical expedient, using NAV and are discussed further below.

Purchases and sales of investments are recorded on the trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation (depreciation) of investments includes realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Individual Variable Annuities with Insurance Company

Effective January 1, 2015, the Company elected to disallow participants the option of making contributions to individual variable annuities with Jackson. The following description of the variable annuity contracts provides only general information. Participants who previously elected to contribute to these variable annuity contracts should read their variable annuity contracts and the prospectus for a more complete description of the contract provisions. Contributions to these individual variable annuities may be allocated by the participant to various investment divisions and fixed accounts. Each investment division purchases the shares of one underlying fund that has its own investment objective. The value of amounts in each participant's variable annuity contract and the income received depends on the performance of the investment divisions selected. The value of the investment divisions is not guaranteed and may decline. Each fixed account credits interest to the participant's contract value for a specified period selected by the participant. The variable annuity contracts guarantee a minimum interest rate for the fixed accounts and that minimum rate will never be less than 1% or more than 3%.

Contract holders have access to the money in their contract by making partial or complete withdrawals, electing a systematic withdrawal program, electing a guaranteed minimum withdraw benefit, or electing to receive income payments. Withdrawals from a variable annuity contract may be subject to withdrawal fees of up to 8% of the withdrawal amount, but depend on the number of years since receipt of contributions and the age of the participant. The contracts also provide for a death benefit which is payable during the period in which contributions are being made. The contracts are charged asset based fees for administration of 1.15% of the daily NAV of the investment division as well as an annual contract maintenance charge of up to \$35 for contracts with a value less than \$50,000. Other fees may apply, depending on the options selected by the contract holder. Individual variable annuities are valued based on the fair value of the underlying investments in each investment division, less asset-based charges.

Risks and Uncertainties

The Plan provides for investments in various investment securities with different investment strategies, which, in general, are exposed to various risks, such as interest rate, credit, foreign investment, active management, and overall market volatility risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. The Plan attempts to limit these risks by authorizing and offering participants a broad range of investment options that are invested in high quality securities or are offered and administered by reputable and known investment companies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The Plan's exposure to a concentration of risk is limited by the diversification of investments across multiple investment fund options. Additionally, the investments within each investment fund option are further diversified into varied financial instruments.

Market conditions have resulted in an unusually high degree of volatility and increased the risks and may affect the short-term liquidity associated with certain investments held by the Plan which could impact the value of investments after the date of these financial statements. Because the values of individual investments fluctuate with market conditions, the amount of gains or losses that will be recognized in subsequent periods, if any, cannot be determined.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2 or 3.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Interest bearing cash: Valued at the NAV of units held by the Plan at year end, as provided by the Custodians.

Mutual funds: Valued at the NAV of shares held by the Plan at year end, as provided by the Custodians.

Individual variable annuities with insurance company: Valued, as a practical expedient, based on the NAV of individual variable annuities held by the Plan at year-end, as provided by the Custodians.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. REPORTABLE TRANSACTIONS

During the years ended December 31, 2024 and 2023, there were no reportable transactions, no investments both acquired and disposed of within the Plan year, no loans or leases in default or uncollectible, or non-exempt transactions with parties-in-interest which would require presentation under the DOL's Rules and Regulations.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments represent interest bearing cash (money market accounts) and mutual funds managed by Fidelity Investments. Fidelity Investments is an affiliate of Fidelity Management Trust Company, one of the Custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions. Certain Plan investments represent individual variable annuities managed by Jackson, one of the Custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions.

Purchases and sales of these accounts and the underlying investments comprising these accounts are open market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

8. TAX STATUS

Effective October 1, 2019, the Plan adopted the Fidelity Management & Research Company (“FMR”) Volume Submitter Defined Contribution Plan (Fidelity Basic Plan Document No. 17) and the related adoption agreement. The IRS has issued an opinion letter dated March 31, 2014 stating that the plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Company is relying on the opinion letter (in accordance with Announcement 2011-49) that the Plan meets the qualification requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Effective September 17, 2021, the Plan adopted the amended and restated FMR, LLC Pre-Approved Defined Contribution Plan (Fidelity Basic Plan Document No. 17) and the related adoption agreement. The IRS has issued an opinion letter dated June 30, 2020 stating that the plan is acceptable under section 401 of the IRC for use by employers for the benefit of their employees. The Company is relying on the advisory letter (in accordance with Announcement 2017-41) that the Plan meets the qualification requirements of the IRC. Although the Plan has been amended since receiving the advisory letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The trustees have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. PLAN AMENDMENTS

Effective January 1, 2023, the Company amended the Plan document to update the determination period for the employer match to be each payroll period.

Effective January 1, 2023, the Company amended the Plan document to decrease the number of loans a participant can take from 2 to 1 with 30 days waiting period to take a new loan after paying one loan off. In addition, participants can now only borrow from the employee deferral source. There was no change to the calculation to determine necessary security.

Effective January 1, 2023, the Company amended the Plan document to change six previously unrelated employers to related employers. These employers were previously participating in the plan.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.
