Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Medical Review Institute of America 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following brief description of Medical Review Institute of America (the “Company”) 401(k) Plan (the “Plan”) provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering all employees of the Company who are age 21 or older and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan.

Contributions. Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan agreement, subject to annual limits determined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Participants direct the investment of their contributions into investment options offered by the Plan. Eligible employees are automatically enrolled in the Plan unless they opt out of participation. The Company may make a discretionary matching contribution, which is allocated among all eligible employees who are participating in the Plan. The Company funds its matching contribution annually, and an eligible employee must have worked more than 1,000 hours during the period and be employed at the end of the year in order to receive a share of the employer’s matching contribution. Matching contributions for the year ended December 31, 2024 (funded in 2025) were \$635,612. Participants direct the investment of their contributions and matching contributions to the various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and Company matching contributions (if any), as well as allocations of the Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are vested immediately in their own elective contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 3 years of credited service while participating in the Plan.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. As a result of the SECURE Act provisions, the Coronavirus Aid, Relief and Economic Security (CARES) Act of 2021, the plan was amended to allow a maximum loan limit of \$100,000, up to 100 percent of the present value of a participant’s vested account balance.

1. Description of Plan (continued)

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. As a result of the SECURE Act provisions, the Coronavirus Aid, Relief and Economic Security (CARES) Act of 2021, the plan was amended to allow a maximum loan limit of \$100,000, up to 100 percent of the present value of a participant's vested account balance.

All loans are secured by the balance in the participant's account. Loans bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions, and the note payoff term cannot exceed five years, with a one-year delay as a result of the SECURE Act and CARES Act amendment. There were no delinquent notes receivable from participants at December 31, 2024. Participants are limited to no more than two loans outstanding at a time.

Payment of Benefits. On termination of service due to death, disability or retirement, participants may elect to withdraw their vested balance either in a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than the participant's assumed life expectancy. For termination of service due to other reasons, participants may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also elect to rollover their vested interest to another qualified retirement plan. Participants are eligible to begin receiving distributions of all vested account balances when reaching 65 years of age.

Forfeited Accounts. At December 31, 2024, forfeited balances in nonvested accounts were not known because former employees have the possibility of returning to employment with the Company within five years of termination, in which case their previous nonvested account balance, which may have been forfeited, may be restored, unadjusted for any gains or losses. When prior employees exceed the five-year cutoff, the non-vested balance in their account is subject to forfeiture at the time of distribution, so balances subject to future forfeiture are not currently calculated. The Plan allows for any amounts forfeited to first be used to restore forfeited amounts of previous employees who return to work for the employer, then to pay any administrative expenses, and for any remaining forfeitures to be used to reduce Company contributions. Amounts forfeited in December 31, 2024 and 2023 from contributions to former participants amounted to \$21,266 and \$35,641, respectively, and the administrator plans to use these amounts to reduce future contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan Trustees determine the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make repayments and the plan administrator considers the participant loan to be in default, both the loan balance and the participant's account balance are reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements and include the audit fee. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 27, 2025, the date the financial statements were available to be issued.

3. Information Certified by Plan Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement Services, the Plan's Trustee and recordkeeper.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Valued at account balance on the last business day of the Plan year.

Mutual funds: Valued at fair value based on quoted redemption values on the last business day of the Plan year.

Fixed and variable annuities: Guaranteed investment contracts that are reported at contract value, which is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract.

Common/collective trusts: Valued at the daily rate which is a blend of the contract's rate of return and the liquidity component's daily rate based on the contract value which is based on the provisions of the contract. The net asset value ("NAV") is used as a practical expedient to estimate fair value.

Certain plan investments are shares of funds managed by Empower Retirement Services, who provided all recordkeeping and trust services to the Plan, and therefore, these transactions qualify as party-in-interest transactions. Any purchases and sales of these funds are open market transactions at fair market value and, consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. W.C. Administrators serves as third-party administrator to the Plan, and also qualifies as a party-in-interest. The accounting firm Traveller & Company, LLC provides auditing service to the Plan and is also a party-in-interest. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These loans to participants are considered parties-in-interest transactions.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate, amend, modify or suspend the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

On June 30, 2020, the Internal Revenue Service states that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit.

9. Net Assets Available for Benefits of Terminated Employees

Net assets available for benefits at December 31, 2024 include \$4,707,183 allocated to the accounts of former participants who, as of or prior to that date, had terminated their employment with the company but who chose to leave their account balance in the Plan, as allowed by the Plan. This amount is payable to the former participants at the time they elect distribution or transfer to other qualified plans, with a portion of that (not now determinable) which is subject to forfeiture.
