Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The HMC Group Marketing, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

Basis for Opinion

NOTE 1. DESCRIPTION OF PLAN

The following description of the HMC Group Marketing, Inc. 401(k) Plan (Plan) is for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan, adopted January 1, 2005, that covers employees of the following participating companies: The HMC Group Marketing, Inc. and McClarty Farms, LLC. The Plan sponsor is The HMC Group Marketing, Inc. Employees who are members of a union collective bargaining unit and their exclusion from coverage under the Plan was part of the union's negotiated agreement or who are nonresident aliens and received no earned income from within the U.S. are excluded from the Plan. Employees are eligible to participate in the Plan once they have attained age 21 and completed 1 year of service. The Plan has an open enrollment period, twice a year, for eligible participants. Participants may enter the plan on the first day of January or the first day of July. The Plan is operated in reasonable and good faith compliance with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended July 1, 2019, to allow for systematic and periodic withdrawals after retirement.

Contributions – Each year, participants may defer a percentage of their compensation up to the maximum percentage allowable not to exceed the limits of Code Section 401(k), in the form of pretax elective deferrals. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan sponsor has adopted a safe harbor matching contribution provision whereby the Plan sponsor will make a matching contribution equal to a participant's deferral rate, but not to exceed a maximum of 4% of participant's compensation for the plan year.

Participant Accounts – Each participant's account is credited or debited with (1) the participant's contributions by payroll deduction, (2) the participant's portion of employer matching, (3) an allocation of earnings and losses, (4) any loans made to or repaid by the participant, and (5) an allocation of Plan expenses.

Vesting – Participants are immediately vested in their voluntary contributions, safe harbor contributions and related earnings at all times.

Participant Loans – Participant loans are not permitted under the Plan.

Payment of Benefits – The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, death, disability, financial hardship, or termination of employment. In-service distributions of a participant's rollover funds are available at any time. In-service distributions of all vested holdings are also available, providing the participant is at least age 65. The normal form of payment is a lump sum cash payment, though a participant may elect to receive installments. The benefit to which a participant is entitled is the benefit that can be provided directly from the participant's vested account balance. Beginning in 2023, retired participants must begin receiving distributions from the Plan no later than April 1 of the year following the year in which the participant attains age 73.

Participant Investment Options – Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. Participants may change their allocation on a daily basis.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting which is in conformity with accounting principles generally accepted in the United States of America.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits – Benefits are recorded when paid.

Plan Expenses – Expenses to administer the Plan, if not paid by the sponsor, may be paid by the Plan and certain fees are allocated to the individual participant accounts.

Subsequent Events – The Plan Administrator has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

NOTE 3. CERTIFIED INFORMATION

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and at December 31, 2024 and 2023 and interest, dividends, and net appreciation (depreciation) of fair value of investments for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Ascensus, Inc. in accordance with 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure Under ERISA.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: the fair value of mutual funds is based on quoted net asset values ("NAV") of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily NAV and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Stable value collective trust fund: The fair value of the investment is based on the net asset value of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds that were managed by Ascensus Inc. LPL Financial Corporation provides advisory services to the Plan and received compensation of \$36,798 and \$30,084 during the years ended December 31, 2024 and 2023, respectively. Ascensus received \$1,785 and \$1,185 for distribution fees during the years ended December 31, 2024 and 2023, respectively. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee received compensation from the Plan. As described in Note 2, the Sponsor pays certain expenses of the Plan. The Plan also has a number of service providers. Such parties are parties-in-interest under ERISA.

NOTE 6. INCOME TAX STATUS

The Plan sponsor has adopted a volume submitter profit sharing plan with a cash or deferral arrangement that received a favorable opinion letter from the IRS on January 1, 2018. The Plan sponsor and administrator believe that the Plan, as amended, is qualified pursuant to the various requirements of the Internal Revenue Code and have indicated that they will take whatever action is required, if any, to maintain the Plan as a qualified plan. Accordingly, they believe that the Plan is a qualified plan and its related trust is exempt from current income taxes.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. Plan management has determined that no such disclosure is required. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan document to terminate this Plan subject to the provisions of ERISA. In the event of termination, each participant, retired participant, former participant and beneficiary shall be entitled to receive any amount credited to that person's account.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
