Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Transhumance Inc. & Subsidiaries 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 2, 2024 and November 4, 2023, and the related statements of change in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended November 2, 2024 and November 4, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS
November 2, 2024 and November 4, 2023

NOTE 1: DESCRIPTION OF PLAN

The following description of Transhumance Inc. & Subsidiaries 401(k) Plan (the “Plan”) provides only summarized general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan became effective June 3, 1997, to provide retirement benefits for employees of Transhumance Holding Company, Inc. (the "Plan Sponsor") and its subsidiaries. The Plan is a defined contribution plan covering all full-time, non-union employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Principal Trust Company serves as the Plan Trustee and the custodian of the assets.

Plan Year

The Plan has adopted a 52-week/53-week plan year, which ends on the Saturday closest to October 31. The Plan year corresponds with the Plan Sponsor’s accounting year-end.

Eligibility

Employees of the Plan Sponsor and its participating subsidiaries are eligible to participate in the Plan. Employees are eligible to participate in the Plan on the first day of the fiscal quarter coinciding with, or next following, the date the employee commences service with the Plan Sponsor. To be eligible, an employee must be at least 18 years of age.

Vesting

Participants are 100% vested in their salary deferrals and safe harbor matching contributions. Participants become fully vested in discretionary contributions upon the completion of three years of credited service. Participants are 100% vested upon death or total and permanent disability.

Contributions

The Plan allows for the following types of contributions:

- ***Employee Salary Deferral 401(k) Contributions***
The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (the “Code”) where each eligible employee may elect to have their compensation reduced up to the maximum amount allowable, not to exceed the limits of Code Section 401(k). These contributions are subject to nondiscrimination tests prescribed by the Plan agreement. Salary deferrals include pre-tax elective deferrals and Roth after-tax elective deferrals.
- ***Qualified Non-Elective Employer Contributions (QNEC)***
The Plan Sponsor may make a discretionary QNEC to the Plan. If made, the contribution is allocated pro rata to all non-highly compensated employees. The Plan Sponsor made no QNEC during 2024 and 2023.
- ***Employee Rollover Contributions***
Employees may make rollover contributions from another qualified plan.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Contributions (Continued)

- ***Employer Discretionary Contributions***
A contribution may be made at the discretion of the employer without regard to the employer's current or accumulated profits. In 2024 and 2023, the Plan Sponsor elected not to make discretionary contributions.
- ***Safe Harbor Matching Contributions***
The Plan Sponsor will contribute safe harbor matching contributions in the form of cash or Plan Sponsor stock up to 100% of participant salary deferrals, limited to 3% of compensation, plus 50% of the excess over 3% up to 5% of compensation. Safe harbor matching contributions are made to the Plan Sponsor's Employee Stock Ownership Plan. The Plan Sponsor made matching contributions of \$392,759 and \$394,027, in cash, in 2024 and 2023, respectively.

Participant Accounts and Allocations

The Plan allows participants to self-direct their account balances and contributions among various investment options. Participants are allowed to direct their investments to a single fund or a combination of funds. Investment earnings and losses are allocated to participants' accounts based on the earnings or losses of the investments selected. The benefit to which a participant is entitled is limited to the vested balance of their individual account.

Forfeitures

Forfeitures are first used for payment of administrative expenses and then may be used to reduce employer contributions. No forfeitures were used for payment of administrative expenses in 2024 and 2023. No forfeitures were available for payment of administrative expenses or reduction of employer contributions at November 2, 2024, and November 4, 2023.

Distributions

Vested benefits are distributable from Plan assets for hardships, in-service early distributions, upon retirement (age 65), termination, death, or disability. The manner of distribution is determined by the trustee as either: (1) a lump sum, (2) installments not to exceed five years, or (3) a combination of the above.

Participant Loans

Participant loans are not permitted.

Retirement

Normal retirement under the Plan is age 65.

Administrative Expenses

Administrative expenses are paid by the Plan and the Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Benefit Payments

Benefits are recorded when paid.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments in securities are stated at fair market value. Fair market value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year. Changes in the unit values of investments are reflected in each participant's self-directed account. Investments are valued daily.

Income Taxes

The Plan has adopted a pre-approved plan which obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan is acceptable under Section 401 of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of November 2, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Estimates and Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 4: FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 2, 2024, and November 4, 2023.

Mutual Funds: Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. They are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and have a readily determinable fair value.

Pooled Separate Accounts: Pooled separate accounts invest mainly in mutual funds and stocks, both domestic and international. The majority of the underlying assets have Level 1 quoted pricing inputs and observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets.

Common Collective Trust: This is a stable value fund that is composed primarily of fully benefit-responsive investment contracts. It is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5: PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Certain Plan investments include units of pooled separate accounts, and in 2023, a common collective trust managed and issued by Principal Life Insurance Company, a member of the Principal Financial Group. Principal Trust Company, also a member of the Principal Financial Group, is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are recorded in net appreciation in fair value of investments. Fees for certain administrative expenses are paid to members of the Principal Financial Group, the record keeper and third-party administrator of the Plan. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 6: RISKS AND UNCERTAINTIES

The Plan invests in various mutual funds, pooled separate accounts, and a common collective trust. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8: SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 12, 2025, the date the financial statements were available to be issued, and management has determined that no subsequent events have occurred that should be disclosed.
