Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of ArisGlobal, LLC 401(K) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's system of internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Reliance Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.



A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiency in the Plan's internal control to be a significant deficiency: **2021-001**.

**2021-001 Evaluation of Complementary User Entity Controls (“CUECs”) as part of the review of the System and Organization Controls (SOC) report**

**Criteria**

The control objectives stated in the description of SOC reports of the Plan and ArisGlobal, LLC (“Plan Sponsor”) service organizations can only be achieved if CUECs are designed, enforced, and operating effectively. CUECs are integral to the design and operating effectiveness of the control environment, and the appropriate implementation of CUECs by the Plan and Plan Sponsor helps in the achievement of control objectives for service organizations.

**Condition**

The Plan Sponsor does not have a process to review the SOC reports prepared by the Plan’s service organizations.

**Cause of Condition**

The Plan Sponsor does not have procedures in place to identify, track and implement applicable CUECs for the Plan.

**Potential Effect of Condition**

If internal control is not effective at the Plan and/or the Plan Sponsor, the service organizations’ controls may not compensate for such weaknesses. Further, If CUECs do not operate effectively at a user entity like the Plan Sponsor, control failures could still occur related to the use of a particular service organization, resulting in an overall weak control environment for the Plan.

**Recommendation**

Management should implement a system and process to review SOC reports from all relevant service organizations for any CUECs annually. As part of this process, they must ensure that any applicable CUECs are identified, tracked, and implemented consistently and timely, and that the system controls designed are operating effectively.
