Scope and Nature of the ERISA 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of Frank's Supply Company, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The Frank's Supply Company, Inc. 401(k) Profit Sharing Plan (the Plan) was established for the benefit of the employees of Frank's Supply Company, Inc. (the Company). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have six months of service and have attained age eighteen. Employees elect to participate in the salary deferral program. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants are allowed to defer up to 100% of compensation to the allowable limit. The Plan Sponsor contributes to the Plan for all employees that meet the requirements in the Plan document. The contributions include a matching safe harbor contribution at 100% of an employee's contributions of the first 3% of their salary and 50% of the next 2% of the employee's salary. The Plan allows for rollover contributions from qualified plans.

Participant Accounts

Each participant's account is credited with participant contributions and Company safe harbor contributions, as well as allocations of Plan earnings, gains and/or losses, and administrative expenses that are paid by the Plan. Employees vest immediately in their contributions, safe harbor contributions and actual earnings thereon.

Administration

Administration costs incurred by the Plan are generally paid by the Plan sponsor.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate approximates market at the time of the loan.

Payment of Benefits

Upon termination of service, participants with account balances in excess of \$5,000 may elect to receive their vested account balance in the form of a lump sum distribution, partial payment or installment payments over a period of time not to exceed assumed life expectancy. Accounts with balances less than \$5,000 may only be distributed in a single lump sum distribution.

Plan forfeitures are available for Plan expenses or to reduce employer contributions. Forfeitures were immaterial in 2024 and 2023, respectively.

Basis of Accounting

The Plan's financial statements are prepared on an accrual basis.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, respectively.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

Accounting principles generally accepted in the United States of America (US GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under US GAAP are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the investment entity has the ability to access.

Fair Value Measurements – Continued

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investment Valuation and Income Recognition

Investments are reported at fair value, with the exception of the stable asset fund, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis, interest income is recorded on an accrual basis and dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Plan Tax Status

The Plan operates on a volume submitter document, and obtained its latest opinion letter on March 31, 2014, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Plan administration believes there are no uncertain tax positions related to Plan activities.

NOTE 5 – STABLE ASSET FUND

The Plan invests in a fully benefit-responsive stable asset fund investment contract with Standard Insurance Company (Standard). The contract is included in the financial statements at contract value as reported to the Plan by Standard, which approximates fair value. Consistent with Accounting Standards Update (ASU) 2015-12 Part I, *Plan Accounting: Defined Benefit Pension Plans* (Topic 965), fully benefit-responsive contracts are measured, presented and disclosed at contract value. Therefore, there is no adjustment to the net assets available for benefits for the difference between contract value and fair value in the accompanying financial statements. The contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Participants' stable asset fund balances are credited with interest daily, at a single annual effective net interest rate. The guaranteed crediting interest rate is declared by Standard in advance and locked in for the calendar quarter. The interest rate is contractually guaranteed never to be less than 1%. The average yield on the contract on an annualized basis was 3.10% and 2.95% in 2024 and 2023, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6 – AMOUNTS DUE TO TERMINATED PARTICIPANTS

Plan assets due to participants who have terminated employment were \$1,072,666 and \$1,411,599 as of December 31, 2024 and 2023, respectively. These participants are no longer eligible to benefit from future employer contributions.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
