Schedule SB Line 9 – Explanation of Credit Balance Discrepancy

Lines 6 and 31a of the 2023 Schedule SB show a normal cost of \$111,808. Line 32a shows a new shortfall amortization base of \$58,709 with an annual amortization of \$5,377. Lines 34 and 36 show the total of \$117,185. Line 37 shows the discounted contribution of \$186,878. Line 38a shows the net, \$69,693.

According to Regulation §1.430(f)-1(c)(2), “For purposes of determining whether a plan is exempt from the requirement to establish a new shortfall amortization base under section 430(c)(5), the amount of the prefunding balance is subtracted from the value of plan assets only if an election under paragraph (d) of this section to use the prefunding balance to offset the minimum required contribution is made for the plan year.”

Line 35 shows no such election, so the amount of the prefunding balance is not subtracted from the value of plan assets in line 2b.

According to Regulation §1.430(a)-1(c)(2), “Unless the value of plan assets (as reduced to reflect the subtraction of certain funding balances as provided under §1.430(f)-1(c)(2), but not below zero) is equal to or greater than the funding target for the plan year, a shortfall amortization base is established for the plan year. . . .”

Since the value of plan assets of \$1,232,132 in line 2b is greater than the funding target of \$936,207 in column (3) of line 3d, no shortfall amortization base is established. Consequently, line 32a of the 2023 Schedule SB should have shown zero. Lines 34 and 36 should have shown \$111,808, and line 38a should have shown \$75,070.

Thus, column (b) of line 11a of the 2024 Schedule SB shows \$75,070 instead of \$69,693, while line 32a of the 2024 Schedule SB shows only one amortization base—a new one for 2024.
