1. Description of the Plan

The following description of the Sause Bros. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document, as amended, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for the benefit of eligible employees of Sause Bros., Inc. and South Coast Aviation, Inc. (collectively, "the Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Principal Trust Company (the Custodian) is the appointed custodian of the Plan's assets. The Plan is administered by the Trustees of the Plan, who are employees of the Employer. Participants may direct their contributions and account balances into various investment options offered by the Plan.

Eligibility

Employees – other than those who are union employees or leased employees – are eligible to participate in the Plan as of the sixth day of the calendar quarter coinciding with or following the date the employee completed 60 days of service.

Contributions

The Plan includes a salary deferral provision which provides for both pre-tax contributions and after-tax Roth 401(k) contributions. Participants may elect to defer up to 100% of their eligible compensation to the Plan each year subject to current Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates set at 4% of their eligible compensation, and such contributions are invested in an age-based target date retirement fund until changed by the participant. Participants may also contribute amounts representing distributions from individual retirement accounts (IRA) and other qualified defined benefit or defined contribution plans (i.e., rollover contributions).

The Employer is required to make a safe harbor matching contribution equal to 125% of each participant's elective deferrals that do not exceed 4% of the participant's annual compensation. In addition, the Employer may make a discretionary profit-sharing contribution. Profit sharing contributions are allocated to each eligible participant's account on an individual basis at management's discretion. Employees are eligible to receive profit sharing contributions if they are still employed at year end and were credited with 1,000 service hours during the Plan year. The Employer did not make any profit-sharing contributions during the years ended December 31, 2024 and 2023.

Participant accounts

Each participant's account is credited (charged) with the participant's contributions and allocations of (a) the Employer's contributions, (b) Plan earnings (losses), and (c) administrative expenses. Earnings (losses) for each investment fund are allocated to participants' accounts based on the individual participant's account balance as compared to the total balance of the related investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in all contributions to the Plan and the actual earnings (losses) thereon.

Benefits

Upon termination of service, distributions of participant account balances less than or equal to \$1,000 are made in a taxable lump-sum cash distribution, unless directed by the participant to initiate a rollover to another qualified plan or an IRA. If the participant's account balance exceeds \$1,000, the Plan permits a participant to elect distribution by lump-sum cash distribution or rollover to another qualified plan or an IRA. If the participant's account balance is between \$1,000 and \$5,000, and the participant does not elect to receive a distribution, the Plan permits the plan administrator to make a distribution directly to an IRA set up on behalf of the participant. Upon reaching age 59½, a participant may elect to receive one in-service distribution of at least \$1,000 each year thereafter.

Effective January 1, 2024, The Company amended its plan to allow for federally declared disaster and domestic abuse withdrawals allowable under the Secure Act 2.0.

Administrative expenses

At the Employer's discretion, administrative expenses of the Plan may be paid directly by the Employer; certain other administrative expenses may be paid by the Plan. Expenses that are paid by the Employer are excluded from the accompanying financial statements. In addition, certain investment related expenses are offset against net appreciation or included in net depreciation in fair value of investments in the accompanying statements of changes in net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and the Custodian. See Note 4 for discussion of fair value measurements.

Investment income recognition

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The plan administrator has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through September 9, 2025, which is the date that the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained by Management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (the Custodian) a qualified institution.

4. Fair Value Measurements

GAAP defines fair value, establishes a framework for measuring fair value, and requires certain disclosures about fair value measurements. The hierarchy of fair value valuation techniques under GAAP provides for three levels: Level 1 provides the most reliable measure of fair value, whereas Level 3, if applicable, generally would require significant management judgment. The three levels for categorizing assets and liabilities under GAAP's fair value measurement requirements are as follows:

- Level 1: Fair value of the asset or liability is determined using unadjusted quoted prices in active markets (that the Plan has the ability to access) for identical assets or liabilities;
- Level 2: Fair value of the asset or liability is determined using inputs other than quoted prices that are observable for the applicable asset or liability, either directly or indirectly, such as quoted prices for similar (as opposed to identical) assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in markets that are not active; and
- Level 3: Fair value of the asset or liability is determined using unobservable inputs that are significant to the fair value measurement and reflect the Plan's own assumptions regarding the applicable asset or liability.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - The fair value of mutual funds is based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - The fair value of investments held in pooled separate accounts is determined using the NAV published and made available via investor online reporting. The underlying investments comprising the pooled separate accounts are primarily mutual funds, which are valued at quoted market prices.

Common collective trusts (CCTs) - The fair value of the CCTs is determined using the NAV published and made available via investor online reporting. The CCTs consist of units of the Morley Stable Value Fund (the Morley Fund) and certain Schwab Indexed Retirement Trust Funds (the Schwab Funds). The Morley Fund is primarily invested in investment contracts and is valued based on information reported by the investment advisor using the audited financial statements of the Morley Fund at year-end.

The underlying assets of the Schwab Funds are primarily equity and bond market-based collective trust funds and they are valued based on information reported by the investment manager of the Schwab Funds.

All of the Plan's investments in pooled separate accounts and CCTs provide for daily redemption at the prior day's NAV, with no advance notification requirements or significant redemption restrictions.

5. Related Party Transactions

Plan investments include a CCT and a pooled separate account managed by Principal Trust Company and/or an affiliate of Principal Trust Company. Therefore, transactions involving these investments qualify as exempt party-in-interest transactions.

The Employer is the sponsor of the Plan and paid substantially all administrative expenses of the Plan during the years ended December 31, 2024 and 2023. In addition, the plan administrator is a participant in the Plan.

Prime Pensions Northwest, LLC (PPNW) provides certain administrative services to the Plan and receives revenue from the Custodian for the services that PPNW provides. This revenue is used to offset certain amounts owed to PPNW for its administrative services to the Plan. The Plan or Employer may make a payment to PPNW for administrative expenses not covered by revenue sharing.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their accounts.

7. Tax Status

The Plan document is a volume submitter defined contribution retirement plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 1, 2022, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the

Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment instruments which are exposed to certain risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of the Plan's investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements and supplemental schedule.
