Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Froedtert Health, Inc. 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Froedtert Health, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 DESCRIPTION OF PLAN

The following description of Froedtert Health, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is sponsored by Froedtert ThedaCare Health, Inc. (the Employer or Plan Sponsor), formerly known as Froedtert Health, Inc. The Plan is a participant-directed Employee Retirement Income Security Act Section 404(c) defined contribution plan. The Plan is a defined contribution plan covering all eligible employees of the Employer and provides employer contributions to match the Internal Revenue Code (IRC) Section 403(b) employee salary deferral benefits. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All employees are eligible to become a participant in the Plan. Participants are eligible to receive Employer nonelective contributions for a calendar year for which the employee has completed 1,000 hours of service during the calendar year and is employed on December 31 of that calendar year. However, an employee that is covered under a collective bargaining agreement is not eligible to receive Employer matching and nonelective contributions under the Plan unless the collective bargaining agreement provides for such contributions under the Plan.

The 1,000 hours of service and last day of the plan year requirements will be waived for the Employer nonelective contributions for those employees that: (i) have a severance from employment during a plan year at any time after reaching age 65 or due to death, and (ii) completed at least 1,000 hours of service in at least one out of the last six calendar years of the employee's employment including the calendar year in which the employee severs employment.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants may elect to have any portion, or all of their contributions designated as Roth 403(b) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer's contribution is comprised of a matching contribution and a nonelective contribution. The Employer matching contribution is equal to 50% of the first 6% of a participant's deferred contribution into the Plan (which can be either pre-tax or Roth contribution) up to a maximum of 3% of eligible compensation.

Contributions (Continued)

The Employer's nonelective contribution for each participant is based on years of service and the amount of the contribution is determined as follows (except for the exceptions noted below):

0 to 4 Years	2.50%
5 to 10	2.75%
11 to 15	3.00%
16 to 20	3.50%
21 to 25	4.00%
26 and Over	4.50%

Any participants in the Plan who are also participants in the Froedtert Hospital Retirement Plan for Certain Former Milwaukee County Employees will receive an Employer nonelective contribution equal to 3% of such participant's compensation, regardless of his or her total period of service.

Certain participants in the Plan who are also participants in the Community Memorial Hospital Retirement Plan do not receive any Employer nonelective contributions under this Plan.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The participant's Employer contribution account balances become 100% vested if the participant retires on or after reaching age 65, dies, or becomes disabled. Active employees hired prior to January 1, 2020, have a four year vesting schedule as follows: 0% after year one, 33-1/3% after year two, 66-2/3% after year three, and 100% after four years of service. Active employees hired after January 1, 2020, have a three year cliff vesting schedule. A vesting year of service is defined as a plan year during which the employee is credited with at least 1,000 hours of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest at 1% above the published prime rate determined quarterly. Principal and interest is paid ratably through biweekly payroll deductions or ACH from a participant's personal bank account.

Forfeited Accounts

Forfeitures result when participants terminate employment prior to fully vesting in their account. The unvested contributions and related earnings will be forfeited at the earlier of the date of distribution or after a period of five consecutive years of separation from the Employer. During the year ended December 31, 2024, forfeitures of \$1,737,675 were used to reduce the Employer's nonelective contributions funded in 2024. Forfeitures as of December 31, 2024 and 2023 were \$2,434,770 and \$1,682,472, respectively.

Benefit Payments

Participants are eligible to receive the vested portion of their accounts upon retirement, disability, death, or termination of employment. Distributions of account balances can be made using the normal method, which is the lump-sum distribution, or the optional method of payment, which are installment payments. A participant may also elect to receive a partial lump sum payment following his or her termination of employment.

If a participant terminates employment and the aggregate value of his or her vested account balance is \$5,000 or less, the funding agent will distribute such balances to the participant as soon as practicable following his or her termination. If the aggregate value of his or her vested account balance is greater than \$1,000 and the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Employer will have the account balance distributed in a direct rollover to an individual retirement plan designated by the Employer.

If permitted under the terms of the applicable custodial account agreement or annuity contract, a participant that is still employed can: (i) receive a hardship withdrawal from the portion of his or her account that consists of the participant's pre-tax, Roth and/or rollover contributions to the Plan, (ii) withdraw all or any portion of his or her rollover contributions at any time, and (iii) withdraw all or any portion of his or her vested account balance after having attained age 59½.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Lincoln Financial Group Trust Company, Inc., the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Personal Choice Retirement Accounts – Valued at the fair value as reported by Charles Schwab for the individual investments reported in the various portfolios subject to the investment adviser’s review and approval. Investments include mutual funds, EFTs, cash equivalents and interest-bearing money market fund. Mutual funds and EFTs are valued on the basis of readily determinable market prices. Investments in cash and cash equivalents are valued based on cost, which approximates fair value in a noninflationary economy and is protected by the Federal Deposit Insurance Corporation.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company (insurance company). The insurance company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than the guaranteed rate. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 PLAN TAX STATUS

403(b) plans are not required to receive a favorable determination letter from the IRS indicating that the Plan is tax-exempt under present income tax law. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The Plan is placing reliance on an opinion letter received from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since relying on the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions.

NOTE 10 TRANSFER OF ASSETS

The Plan Sponsor has an existing frozen plan named the Froedtert Memorial Lutheran Hospital / Froedtert Health 403(b) Thrift Plan. Participants are allowed to transfer their investment account balances from the Froedtert Memorial Lutheran Hospital / Froedtert Health 403(b) Thrift Plan to the Plan at their discretion. During the year ended December 31, 2024, \$1,512,367 was transferred into the Plan.

NOTE 11 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Differences between these financial statements and information combined in Schedule H, Parts I and II of Form 5500 were identified and are due to different classifications among various detail accounts. The investments reported in the financial statements include pooled separate accounts that are not Direct Filing Entities, and as a result, the underlying investments of these pooled separate accounts are reported in the Schedule of Assets (Held at End of Year) and classified in the Form 5500 based on these underlying investments. In total, these balances are in agreement.
