NOTE 1 DESCRIPTION OF PLAN

The following description of Account Plan (the Plan) is provided for general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1988, and is currently maintained pursuant to an agreement between Local Union No. 16 of the Sheet Metal Workers International Association and the Columbia Chapter of the Sheet Metal and Air Conditioning Contractors' National Association. The Plan was most recently restated effective January 1, 2015 and amended on May 20, 2023. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility

The Plan covers eligible employees of employers who have executed collective bargaining agreements with Sheet Metal Workers International Association Local No. 16 (the Union). An employee who works in covered employment at least one hour on or after August 1, 1998, or who has at least one hour as a classified employee on or after January 1, 2008, is eligible to participate in the 401(k) elective deferral account. An employee is eligible to participate in the employer contribution account when at least 500 hours of service in covered employment has been completed during a calendar year. The 500-hour requirement may also be completed with hours of service in noncovered employment with a contributing employer.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a portion, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Employer contributions shall be funded to the Plan as required by collective bargaining agreements. There were no employer contributions required to be contributed for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of employer contributions, Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contribution sources plus actual earnings thereon. Employer contributions made prior to January 1, 2009 are fully vested upon completion of five full vesting credits as defined in the Plan. With respect to employer contributions made on or after January 1, 2009, a participant is fully vested on the earlier of the completion of three full vesting credits, attaining normal retirement age, total and permanent disability, or death.

Benefit Payments

A participant may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution upon termination, normal retirement, attainment of age 55 and completion of five years of service for five vesting credits (excluding credits earned under noncovered employment), death, or total and permanent disability. If a participant terminates employment and the participant's account balances does not exceed \$5,000, the participant may elect to rollover the amount to another qualified plan or IRA. The Plan also permits hardship withdrawals, as defined in the Plan.

Forfeitures

When a nonvested participant has a one-year break in service, the nonvested account balance shall be transferred to a forfeiture suspense account until restored or permanently forfeited. Forfeitures may be used to fund employer contributions, to pay expenses of the Plan, or re-allocated to participants. There were no forfeited nonvested accounts at December 31, 2024 and 2023. There were no forfeitures used during the years ended December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, investment performance monitor, and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from employees are accrued based upon reported hours worked during the year by covered employees. Delinquent contributions, if any, are recorded in the financial statements when received.

Employer Contributions Receivable

Contributions due but not paid prior to year-end are recorded as contributions receivable. Contributions are due from employers as specified in the collective bargaining or participation agreement. In general, contributions are due on the 15th day of each month following the work month. Delinquent contributions and payroll audit findings are individually analyzed for collectability. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024, the allowance for credit losses was insignificant.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

All expenses of maintaining the Plan are paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through August 14, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing prices as reported by the fund. Registered investment companies held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common/Collective Fund: Valued at the NAV of units of a bank common/collective fund. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective fund, the issuer reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 4 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 PLAN TERMINATION

The trust agreement shall continue in existence until such time it is terminated by a written declaration of termination executed by the Union and the employer associations and filed with the Board of Trustees. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 TAX STATUS

The IRS has determined and informed the Plan by a letter, dated January 16, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Board of Trustees believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 6 TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

The Plan pays expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE 8 NONEXEMPT TRANSACTIONS

Multiple signatory employers failed to remit employee 401(k) deferral contributions for certain payroll periods within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. The amount of late deferral contributions not corrected was \$47,547 at December 31, 2024. The Plan is in the process of correcting the prohibited transactions by filing the required Forms 5330 with the IRS and determining the appropriate excise taxes due.
