### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Pollard (U.S.) LTD 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

#### 1. Description of the Plan

The following description of the Pollard (U.S.) LTD 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### A. General

The Plan is a defined contribution plan covering substantially all employees of Pollard (U.S.) Ltd., Schafer Systems, Inc., Pollard iLottery, Inc., Pollard Games, Inc. (dba American Games and International Gamco), Diamond Game Enterprises, Inc. and Pollard Digital Solutions Inc, all of which are wholly owned subsidiaries of Pollard Holdings, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 3, 2024, the Plan was amended to add Pollard Digital Solutions Inc, as a participating employer.

##### B. Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation as defined by the Plan as either pre-tax or after-tax Roth contributions, provided the contribution does not exceed the maximum limits established by law. Participants may also contribute rollover contributions which represent distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer matching contributions for each company are as follows:

- Pollard (U.S.) Ltd. contributes to non-union participants and Pollard iLottery, Inc. participants at 25% of the participant's deferral up to 6%, with an annual maximum contribution of \$1,500.
- Pollard iLottery, Inc. and Pollard Digital Solutions Inc. contribute 100% of elective contributions up to 3% of eligible compensation, plus 50% of elective contributions over 3% up to 7% of eligible compensation.
- International Gamco and American Games contributions are 100% of the participant's deferral up to 3%.
- Schafer Systems, Inc. and Diamond Game Enterprises, Inc. contributions are equal to 100% of participant contributions up to 3% of eligible compensation, plus 50% of elective contributions over 3% up to a maximum of 5% of eligible compensation.

**B. Contributions - Continued**

The Plan includes an auto-enrollment provision and an automatic increase provision for select employers. The following employers are subject to both auto-enrollment and automatic increases: Pollard (U.S.) Ltd., Pollard iLottery Inc., Pollard Games, Inc. (dba American Games and International Gamco), and Pollard Digital Solutions, Inc. All newly eligible employees employed by one of these employers are automatically enrolled in the plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% pre-tax of eligible compensation and their contributions invested in a target date fund based on an anticipated retirement date until changed by the participant. Unless the participant affirmatively elects out, participants contributing less than 8% of eligible compensation on January 2nd and who have not changed their contribution rate in the preceding 6 months, will have their contribution rate automatically increased by 1% annually up to a maximum contribution rate of 8%. Automatic increases shall occur each October 1st. The automatic increase will be applied to the pre-tax contribution rates only.

**C. Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the employer matching contribution, and an allocation of the Plan earnings/losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**D. Vesting**

Participants are vested immediately in their contributions and any prior safe harbor match contributions, plus actual earnings thereon. Vesting in the employers' matching contributions plus actual earnings thereon is based on years of continuous service, with participants vesting 25% after one year of service and 25% annually thereafter until fully vested at 4 years of service. Schafer Systems, Inc. participants vest 25% after two years of service and 25% annually thereafter until fully vested at 5 years of service. All participants whose accounts were merged into the Plan effective December 1, 2020, vest 20% in prior profit-sharing contributions after one year of service, and 20% annually thereafter until fully vested at five years.

**E. Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding note receivable balance in the participant's account during the prior twelve-month period. Notes receivable are secured by the balance of the participant's account and bear interest at a rate the Plan Administrator determines to be reasonable based on the prevailing interest rates charged by those in the business of lending money for loans which would be made under similar circumstances. As of December 31, 2024, outstanding notes receivable carry interest rates ranging from 4.25% to 9.50%. A participant may have only two loans outstanding at any given time. Principal and interest are paid ratably through payroll deductions at least quarterly.

**F. Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant may receive a single lump-sum payment of their entire account, or a single-sum payment of a portion of the account balance over a fixed time period. Balances less than \$5,000 are paid to terminated participants by lump sum payment without consent. Any such distribution greater than \$1,000 made to a participant without consent before normal retirement age will be rolled over to an individual retirement plan designated by the Plan Administrator. Other in-service distributions are paid out as permitted by the Plan.

**G. Forfeitures**

Nonvested matching contributions of terminated participants become forfeitures in the year in which a participant incurs a break in service as defined in the Plan. Forfeitures are used to pay Plan administrative expenses and/or reduce the employers' matching contributions. Unused forfeitures are \$30,466 and \$23,522, respectively at December 31, 2024 and 2023. Forfeitures were used to reduce employer matching contributions in the amount of \$38,483 and \$39,090 in 2024 and 2023, respectively.

**2. Summary of Significant Accounting Policies**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**E. Excess Contributions Payable**

Amounts payable to participants for contributions in excess of the amount allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

**F. Payments of Benefits**

Benefits are recorded when paid.

**G. Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan's employers and are not reflected in the Plan's financial statements. Other administrative expenses not paid by the employers are paid by the Plan's participants and charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

**H. Subsequent Events**

Management has evaluated transactions and events occurring subsequent to December 31, 2024, and through September 12, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements, other than those disclosed in Note 8.

**I. Risks and Uncertainties**

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**4. Fair Value Measurements**

Financial Account Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual and Money Market Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Fund:* Valued at the NAV of the common/collective trust (CCT). The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust to ensure securities liquidations will be carried out in an orderly business manner.

**5. Party-in-Interest Transactions**

The Plan engaged the services of Fidelity Management Trust Company, whose responsibilities include investing assets, paying benefits to participants under the direction of the Plan Administrator, and performing the recordkeeping of the Plan. Administrative expenses paid by the Plan to Fidelity Management Trust Company qualify as party-in-interest transactions. Additionally, certain Plan investments are shares of mutual funds and money market funds managed by Fidelity.

**6. Plan Termination**

Although the employers within the Plan have not expressed intention to do so, they have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their account balances.

**7. Income Tax Status**

The Plan has adopted a preapproved plan sponsored by Fidelity Management Trust Company. On June 30, 2020, the Internal Revenue Service stated the plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan, and the Plan has since been amended, however, the plan administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt. The Plan has not received a determination letter specific to the Plan

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and concluded as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Subsequent Events**

Effective January 1, 2025, the Plan was amended to add Clarence J. Venne, L.L.C., as a participating employer.
