## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cambridge Air Solutions Employees 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

### **NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Cambridge Air Solutions Employees 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Cambridge Engineering, Inc. (the Company) who are eighteen or older and have completed at least one month of service. Non-resident aliens and leased employees hired on or after October 1, 2016, as well as those covered by a collective bargaining agreement, are not eligible to participate in the Plan. An employee may enter the Plan on the first of the quarter following the date that the eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the plan document was amended to remove the requirement for a participant to be suspended from making contributions for a period of 6 months after the receipt of the hardship distribution.

Charles Schwab Trust Bank is the custodian of the Plan and Epic Retirement Plan Services provides recordkeeping services. Certain members of management serve as trustees. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### **Contributions**

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company's matching contributions are discretionary and determined as a percentage of participant elected deferrals. For the year ended December 31, 2024, the Company contributed 50% of the first 6% of base compensation that a participant contributed to the Plan. The Company suspended matching contributions from March 2024 to September 2024.

Discretionary profit-sharing contributions are determined annually. There were no profit-sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain limitations. Participants may also transfer funds to the Plan from other qualified retirement plans.

#### **Investment Options**

Participants of the Plan elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, Company matching and profit-sharing contributions, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and rollovers plus earnings thereon. Vesting in the Company's profit sharing and matching contribution portions of their accounts, is based on years of service as follows:

2	20%
3	40%
4	60%
5	80%
6 or more	100%

Participants become fully vested upon death, total and permanent disability, and early retirement date.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate. Principal and interest are paid ratably through monthly payroll deductions.

**Payment of Benefits**

On termination of service, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination. Participants with a vested account balance of less than \$5,000 must take a lump-sum distribution.

In-service distributions are allowed when a participant reaches age 59½. Rollover contributions may be withdrawn at any time. The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are subject to specific statutory and regulatory requirements.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to reduce Company contributions or pay administrative expenses. Forfeitures of \$17,546 were used to pay plan expenses for the year ended December 31, 2024. Unallocated forfeitures were \$10,557 and \$1,293 at December 31, 2024 and 2023, respectively.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Plan expenses primarily consist of recordkeeping and advisory fees. Fees related to the administration of benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**Subsequent Events**

Subsequent events were evaluated through August 7, 2025, the date the financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which level 1 inputs were not available. Level 3 inputs would only be used if level 1 or level 2 inputs were not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

*Common/collective trusts:* Valued at the NAV of units of the fund, which is based on the readily determined fair value of the underlying securities. The stable value common/collective trust invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value.

**NOTE 4 — INFORMATION CERTIFIED BY CUSTODIAN**

Information related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interests and dividends for the year ended December 31, 2024, disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Charles Schwab Trust Bank, the custodian.

**NOTE 5 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

**NOTE 6 — TAX STATUS**

The Company has adopted a pre-approved defined contribution plan, and therefore, can rely on the advisory letter issued by the Internal Revenue Service on June 30, 2020, which stated that the Plan is acceptable under Section 401 of the Internal Revenue Code. Management believes that the Plan is operating in compliance with all the terms provided in the non-standardized plan agreement.

The Plan is subject to examination by the Internal Revenue Service for the statutory period.

**NOTE 7 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
