### *Opinion*

We have audited the accompanying financial statements of William H. Metcalfe and Sons, Inc Employees' 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended November 30, 2024, and the related notes to the financial statements.

Note 1. **Description of Plan**

The following description of the William H. Metcalfe and Sons, Inc. Employees' 401(k) Plan (the Plan) provides only general information purposes. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of William H. Metcalfe and Sons, Inc. ("the Company") who have completed at least 500 hours in the first six months of service or have completed at least 1,000 hours and one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

**Contributions** - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed the IRS annual deferral limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching and profit-sharing contributions are discretionary. For the years ended November 30, 2024 and 2023, the Company matched 100% of the first \$500 of pretax deferrals and 50% of the next \$500 of pretax deferrals contributed to the Plan, for a maximum matching contribution of \$750. All contributions are invested according to each participant's election of the Plan's investment options. Profit sharing amounts may be made at the discretion of the Company's board of directors. The Company has never made a profit sharing contribution. Contributions are subject to certain IRS limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and the Company's matching contribution, as well as an allocation of Plan earnings. Plan earnings include dividends and realized and unrealized appreciation or depreciation on investments, less plan expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their employee contributions and the Company's matching contributions plus actual earnings thereon. Vesting in non-matching company discretionary contributions are based on years of continuous service. A participant is 100 percent vested in non-matching contributions after six years of credited service.

Note 1. **Description of Plan - (Continued)**

**Payment of Benefits** - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal installments over a period not more than his or her assumed life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeited Accounts** - There were no forfeited non-vested account balances as of November 30, 2024 and 2023.

Note 2. **Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are recorded as dividends. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

**Subsequent Events** - The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

Note 3. **Fair Value Measurements** - The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1           Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2           Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3           Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

*Money market funds* - Valued by the institutional fund management at the stated price of the fund which generally approximates the original costs of the investments.

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4. **Related-Party Transactions and Party in Interest Transactions** - The Plan utilizes service providers for custody, investment advisory, recordkeeping, and other professional services. These service providers are compensated by the company and the mutual funds for services provided to the Plan. Transactions with these and other service providers qualify as party in interest transactions under ERISA.

Note 5. **Plan Termination** - Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

Note 6. **Tax Status** - The IRS has determined and informed the Company by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 6. **Tax Status** - (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. **Risks and Uncertainties** - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
