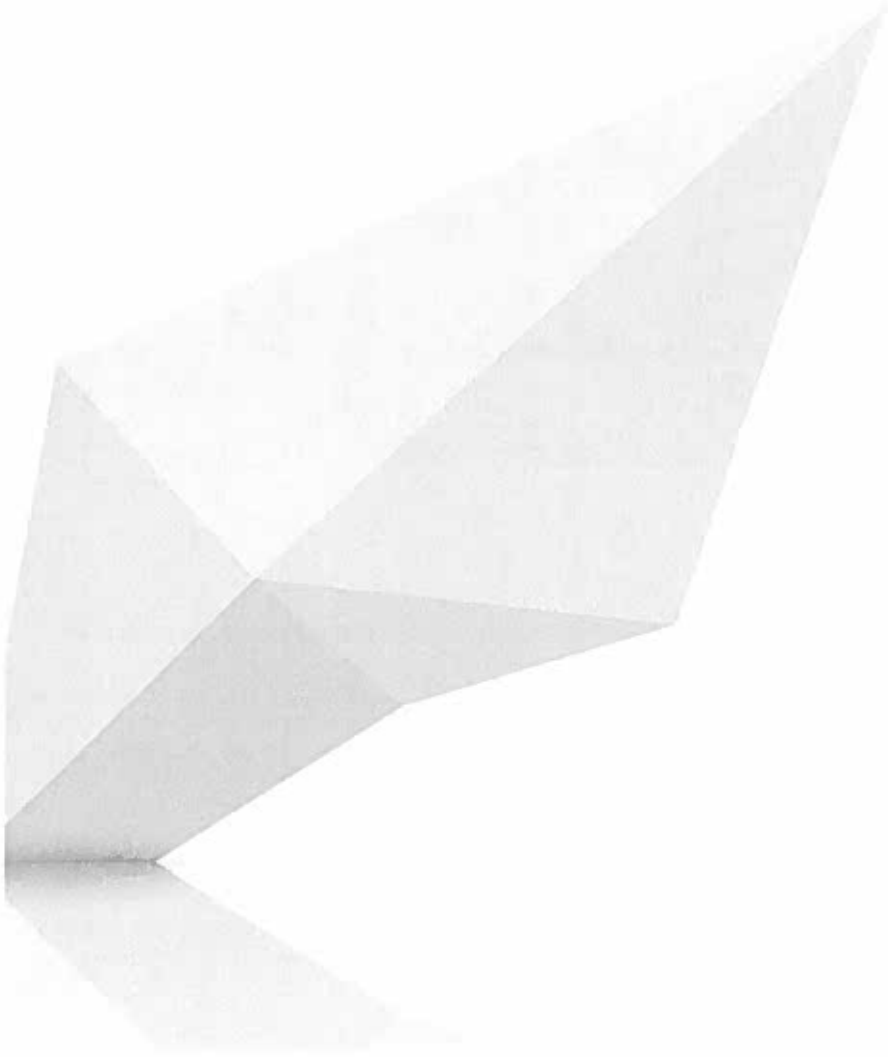

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of O'Connor GMC Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the O'Connor GMC Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a non-standardized, pre-approved defined contribution profit sharing plan covering all employees of Hutchins Motors Inc. d/b/a O'Connor GMC (the "Company") who have completed 6 months of service with 500 hours or a year of service with 1,000 hours. In addition, beginning January 1, 2024, long-term, part-time employees who have completed 500 hours of service in three consecutive years are eligible. Participants enter the Plan on the first day of the quarter coinciding with or next following the date on which such requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Key management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investments and monitors investment performance.

#### Contributions

Each year, participants may contribute up to 80% of pretax annual compensation, as defined by the Plan. Eligible participants can also make Roth deferral contributions, which are contributions based on after-tax compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Company match and profit sharing contributions may be contributed at the option of the Company's Board of Directors. During 2024, the Company matched 20% of the first 1% of employee deferrals. The Company did not make a profit sharing contribution for the year ended December 31, 2024. Company match and profit sharing contributions are invested based on participant elections. During the year ended December 31, 2024, the Company made matching contributions of \$23,681. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Employee deferrals are funded on a payroll basis; match contributions are funded on an annual basis; and profit sharing contributions, if applicable, are funded annually.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's profit sharing contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants are vested immediately in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary profit sharing contributions, plus actual earnings thereon, is based on years of continuous service. Participants vest at a rate of 20% per year after two years of service. Participants become fully vested after six years of service, as defined by the Plan. Participants are also fully vested immediately if employed on or after normal retirement age or when they become disabled.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024 and 2023, which are commensurate with local prevailing rates as determined by the plan administrator at the time of the note origination. Note terms cannot exceed five years, unless the proceeds are used in the purchase of a primary residence of the participant for which the plan administrator may permit a longer repayment term. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The participant may also elect to receive a series of substantially equal payments over a fixed period of whole years or a specified dollar amount each year. If the balance is less than \$5,000 (\$7,000 effective January 1, 2024), the plan administrator may automatically distribute the balance as a lump-sum distribution. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2 provided certain conditions are met.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,666 and \$3,685, respectively. These accounts may be used to reduce Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. Forfeitures used to reduce Company contributions for the year ended December 31, 2024, totaled \$3,215.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are reflected in total investment income.

### **Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described, as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Units are valued daily at the NAV of the net assets and outstanding units of the underlying collective investment funds held within the trust. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### **Note 4: Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

### **Note 5: Party-in-Interest Transactions**

The Plan uses ADP LLC as its recordkeeping platform and fees paid by the Plan to the recordkeeper qualify as party-in-interest transactions. Total fees paid for recordkeeping services were \$2,665 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary matching and profit sharing contributions.

### **Note 7: Tax Status**

The Company adopted a Non Standardized Pre-approved Profit Sharing Plan with an IRS notification letter which states the pre-approved plan is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Subsequent Events**

The Plan has evaluated subsequent events through September 8, 2025, which is the date the financial statements were available to be issued.
