Reasonable assurance is a high level of assurance but is not absolute assurance. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

*Other Matter — Supplemental Schedule Required by ERISA*

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at Year End) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Schaefer Systems International Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution savings plan, established on January 1, 1986, to provide retirement benefits for substantially all the employees of Schaefer Systems International Inc. (the “Sponsor”). Employees of the Sponsor become eligible to participate in the Plan after reaching 21 years of age and enter the Plan on the first day of the month following the month in which eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code (the “IRC”).

Contributions

Each participant may contribute, on a pre-tax or post-tax (Roth) basis, between 1% and 75% of their compensation, as defined by the Plan, subject to IRC limitations, in the form of a salary deferral. For any calendar year, elective deferrals may not exceed a specific dollar amount prescribed by the IRC, which is adjusted annually by the Internal Revenue Service (“IRS”). The Plan also allows participant rollover contributions from other qualified plans.

The Sponsor makes safe harbor matching contributions equal to 100% of the first 4% of the participant’s eligible compensation contributed to the Plan. The Sponsor may also make discretionary non-elective contributions on behalf of employees. No discretionary non-elective contribution was made for the year ended December 31, 2024.

Investment options

The Plan’s investment assets are held by Reliance Trust Company (the “Custodian”), the Custodian of the Plan’s investment assets. Under an arrangement with the Custodian and upon enrollment in the Plan, participants direct all contribution in any whole percentage increment to any of the available funds. Participant may change their allocation among the various investment options at any time.

Participant accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Sponsor’s contributions on behalf of the participant, and (c) the earnings and losses of the participant’s investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Each participant is immediately fully vested in the portion of his or her account attributable to his or her contributions and Sponsor safe harbor matching contributions, and earnings thereon. Vesting in the Sponsor’s non-elective contributions and the earnings thereon is based on years of continuous service with the Sponsor as follows:

2	40%
3	60%
4	80%
5	100%

Payment of benefits

Upon termination of employment, attainment of retirement age or for reasons of death or disability, participants may withdraw vested portion of their account in the form of a lump sum or annual installments. Participants still employed with the Sponsor may withdraw all or a portion of their vested account balance and actual earnings thereon upon attainment of age 59 ½ or for reasons of financial

hardship as permitted by IRC. A terminated participant who does not elect otherwise and whose vested account balance does not exceed \$5,000, will have their vested account balance automatically rolled over into an individual retirement account outside of the Plan. A terminated participant whose vested account balance does not exceed \$1,000 will receive a lump sum distribution of their vested account balance.

#### Forfeitures

Forfeitures of nonvested account balances may be used, at the sole discretion of the Sponsor, to pay administrative expenses of the Plan or reduce Sponsors contributions. During the year ended December 31, 2024, \$16,413 in funds were forfeited and \$13,375 was used to reduce Sponser contributions. Accumulated forfeitures totaled \$6,344 and \$3,219 at December 31, 2024 and 2023, respectively.

#### Notes receivable from participants

Participants may borrow, from their fund accounts, amounts ranging from \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of repayment for a loan is five years, except for loans associated with a primary residence. Participants are allowed to have no more than one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal's published prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. The interest rate on loans outstanding was ranged from 4.25% to 9.50% at December 31, 2024 and 2023.

#### Administrative expenses

Administrative fees associated with participant loans, distributions, and recordkeeping fees are paid by the Plan and charged to the participant accounts of those participants who initiated the transaction.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of estimates in financial statement preparation

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Interest is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the Plan's financial statements and supplemental schedule.

The following information included in the Plan's financial statements and supplemental schedule was prepared and certified to be complete and accurate by the Custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

#### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

There were no changes in the methodologies used during the year ended December 31, 2024.

- Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. RELATED PARTY TRANSACTIONS

The Sponsor pays certain costs on behalf of the Plan for insurance, administration, and professional services. Recordkeeping and administrative services are also provided by the Sponsor at no cost to the Plan.

## 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

## 7. INCOME TAX STATUS

The Plan utilizes a prototype plan document sponsored by ADP LLC, who received a letter from the Internal Revenue Service (“IRS”), dated October 6, 2020, in which the IRS opined that the prototype plan, as amended, is designed in accordance with the applicable sections of the IRC. The Plan has not obtained a determination from the IRS on its adoption of the non-standardized prototype plan. In accordance with Revenue Procedure 2002-6, the Sponsor has chosen to rely on the opinion letter of the prototype plan.

Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Sponsor believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in

progress, and the plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 8. RECONCILIATION TO FORM 5500

#### 9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

#### 10. SUBSEQUENT EVENTS

Effective February 1, 2025, the Sponsor amended the Plan adoption agreement to allow forfeitures to be used to reduce employer matching contributions on a per payroll period basis. Previously this was only permitted annually.

The Sponsor has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.
