**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Bober, Markey, Fedorovich & Company Thrift/Incentive Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of Bober, Markey, Fedorovich & Company, a certified public accounting firm (the “Firm”). Employees are eligible to become participants on the first day of the month following their date of hire. The employee also has to be at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Charles Schwab Trust Bank is the Custodian (“the Custodian”) of the Plan’s assets.

***Contributions***

Participants can contribute up to 100% percent of eligible compensation. However, contributions may not exceed limitations established under section 402(g) of the Internal Revenue Code of 1986 (“IRC”), as amended. The Plan permits catch-up elective deferrals for participants over 50 years of age subject to IRC limitations. The firm may also make matching contributions to the Plan. These matching contributions are not required, and the amount of the contribution and the frequency of the contribution will be determined by the firm. For the Plan years ending December 31, 2024 and 2023, the firm made matching contributions of 50% of the employee’s contribution up to 6% of participant’s gross wages. These matching contributions were approximately \$470,000 and \$365,000 for the 2024 and 2023 Plan years, respectively.

The Firm also may, at its option, make a discretionary profit-sharing contribution to the Plan. The firm did not make discretionary profit-sharing contributions (modified cash basis) for the Plan years ended December 31, 2024 and 2023, respectively.

***Forfeitures***

As forfeitures become available, the Firm will reduce the discretionary Firm contribution for that Plan year. If the Firm does not make a discretionary Firm contribution to the Plan for such Plan year, the Plan may use forfeitures to reduce firm matching contributions or to pay Plan expenses as necessary.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and an allocation of the Firm’s matching contribution, discretionary Firm contribution, earnings, and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Firm matching and discretionary Firm contributions is based on years of credited service in accordance with a six-year graded vesting schedule.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions, with repayment terms not to exceed five years.

***Payment of Benefits***

On termination of service, if a participant's account is less than \$5,000, the participant receives a lump-sum amount equal to the value of his or her vested account balance. If the participant's account exceeds \$5,000, the terminated participant may elect to defer distribution until a later date (but not later than their normal retirement date).

***Rollover Contributions***

Rollover contributions consist of amounts rolled over by participants from former employer plans.

***Plan Termination***

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their respective accounts.

***Administrative Expenses***

Currently, the Firm pays certain professional fees related to the Plan. The Plan pays certain expenses charged for participant-directed transactions, such as loan processing fees, distribution fees, and participant set-up fees, as well as investment management fees, where these expenses are allocated to participant's accounts based on the participant's current fair value. These expenses are reflected in the accompanying statements of changes in net assets available for benefits as administrative expenses.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Presentation***

The accompanying financial statements of the Plan have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions and investment income are recognized when received, and disbursements are recognized when made.

***Use of Estimates***

In preparing the Plan's financial statements, the Plan administrator is required to make estimates and assumptions that affect the reported amounts of Plan assets, and liabilities, and the reported increases and reductions of Plan assets during the reporting period. Actual results could differ from these estimates.

***Investment Valuation and Income Recognition***

The Plan's Investments are stated at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

***Notes Receivable from Participants***

The Plan allows loans to participants in accordance with the Plan document. These loans are reported at the unpaid principal balance plus accrued interest. Loans are deemed distributions by the Plan when they are determined to be in default.

***Payment of Benefits***

Benefits are recorded when paid.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Unobservable inputs for which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

***Mutual Funds:*** Valued based upon quoted prices in an active market.

***Common collective trusts:*** Valued at the respective net asset values ("NAV") of the underlying investments held by the funds, less their liabilities. NAV is used as a practical expedient to estimate fair value. Transactions (purchase and sales) may occur daily. The Plan has no future investment commitments or redemption restrictions related to the funds as of December 31, 2024 and 2023.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - INCOME TAX STATUS**

On June 19, 2014, the IRS stated that the prototype adopted by the Plan, as then designated, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself, however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan's accounting guidance requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Firm has analyzed the tax positions taken by the Plan, and has concluded that as of and for the Plan years ended December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PARTY IN INTEREST TRANSACTIONS**

Certain participants have borrowed on their vested account balances. As the individuals are participants in the Plan, these transactions qualify as party-in-interest transactions.
