Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Affordable Interior Systems, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). 1. Description of Plan

The Affordable Interior Systems, Inc. 401(k) Plan (the Plan) is a defined contribution plan which began on January 1, 2000, and covers all employees of Affordable Interior Systems, Inc. and Pan Pacific, LLC (collectively, the Company and Plan Administrator) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Eligibility

The Plan states that all employees of the Company who have attained age 18 are eligible to participate in the Plan.

Contributions

Participants may defer pre-tax contributions to be made to the Plan through a reduction of their compensation of amounts between 1% and 100% in whole percentages of their eligible compensation, subject to certain limits under the Internal Revenue Code (the Code). Participants who are projected to be age 50 or older by the end of the calendar year and who are making pre-tax contributions to the Plan may also make an additional "catch up" pre-tax contribution subject to limits under the Code. Rollovers from qualified plans are permitted.

Employees who do not complete a salary deferral agreement will be automatically enrolled in the Plan with a 7% deferral percentage. The automatic contributions will be invested in a default investment fund selected by the Plan.

The Company makes a matching contribution equal to 25% of the first 6% of eligible earnings that a participant contributes to the Plan.

Additional non-elective contributions (profit sharing contributions) may be contributed at the option of the Company's board of directors. The non-elective contribution, if made, is allocated to all employees eligible to participate in the Plan. A participant must be employed by the Company on December 31 to receive any discretionary employer contributions. There were no non-elective employer contributions for the Plan year ended December 31, 2024.

All contributions are held in a trust and invested by the Plan's trustee in accordance with the options elected by the participants; all investments are participant-directed.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings to account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions plus cumulative earnings thereon. Participants vest in the Company's matching contributions and discretionary contributions and the cumulative earnings thereon as follows: less than one year of service, 0%; after one year of service, 25%; after two years of service, 50%; after three years of service, 75%; and after four years of service, 100%. Upon death or disability, participants become 100% vested in their account.

Note Receivable from Participant

Prior to March 2019, participants were allowed to borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in *The Wall Street Journal* plus 2%. Principal and interest is paid ratably through payroll deductions.

In March 2019, the Plan was amended to no longer permit loans from the Plan.

Forfeitures

Any non-vested amounts attributable to Company matching contributions shall be forfeited after a participant terminates employment. The forfeiture will occur in the Plan year that the participant receives a distribution of their vested account, or after a five-year period of severance. Forfeited discretionary Company contributions will be used to pay for Plan expenses or will be used to reduce the Company's subsequent contributions to the Plan. Forfeitures were not used to reduce employer contributions during the Plan year ended December 31, 2024.

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$57,137 and \$35,463, respectively. These accounts will be used to reduce future employer contributions.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested balance in his or her account or periodic installments based on the life expectancy of the participant or the participant's designated beneficiary.

Plan Termination and Amendment

Although the Company has not expressed any intent to do so, the Company has the right, under the Plan agreement, to amend any or all provisions of the Plan as well as to discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA. In the event of the termination of the Plan, each participant shall become fully vested in his or her retirement account at that date.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition

Investments are held in pooled separate accounts and are stated at fair value, except for the fully benefit-responsive insurance company general account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Pooled separate accounts, excluding the John Hancock Stable Value Fund, invest in shares of mutual funds. None of these pooled separate accounts held by the Plan are subject to transfer or withdrawal restrictions.

The John Hancock Stable Value Fund is invested solely in units of the John Hancock Stable Value Trust (the Trust), a collective investment trust managed by John Hancock Life Insurance Company (John Hancock). The Trust invests primarily in fixed income mutual funds and separately managed bond accounts. Deposits to and withdrawals from the Trust may be made daily at the current Net Asset Value (NAV) per unit. A delay of up to 12 months may be experienced for plan level withdrawals.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are segregated from Plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as deemed distributions based upon the terms of the Plan document.

Benefits to Participants

Benefits are recorded when paid.

Administrative Expenses

The Company pays substantially all of the administrative costs of the Plan. Personnel within the Company perform various administrative services for the Plan. Administrative expenses incurred by the Plan include loan fees and withdrawal processing fees charged directly to the participants' accounts, as well as investment management fees which are netted against investment returns. During the year ended December 31, 2024, the payroll and related overhead costs associated with these services were not included as administrative expenses of the Plan.

Subsequent Events

Management has considered transactions or events occurring through September 11, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Information Prepared and Certified by Trustee

The investments, investment transactions, net appreciation in fair value of investments, note receivable from participant and related income were obtained by management and agreed to or derived from the information certified by John Hancock, the trustee, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

4. Fair Value Measurements

The Plan uses a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts, excluding the John Hancock Stable Value Fund – Valued based on the market prices of the underlying assets.

John Hancock Stable Value Fund – Valued based on the NAV of units held by the Plan. NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

5. Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts and funds held in the insurance company general account managed by John Hancock. John Hancock is the trustee as defined by the Plan and, therefore, transactions with this institution qualify as party-in-interest transactions.

6. Tax Status

The Plan was originally established, and all subsequent amendments have been made, under the provisions of the third-party administrator prototype plan. The Internal Revenue Service has informed the third-party administrator, by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
