## ONTARIO ORTHODONTICS DEFINED BENEFIT PLAN

### Summary of Plan Provisions

Effective Date: January 1, 2011.

Eligibility: The employees Brian Rheude, Haymish Murray, and Elizabeth Yull are the only ones not excluded from the plan and shall enter the plan on January 1 or July 1 coinciding with or next following attainment of age 21 and having worked 1 year of service. Due to the 5/31/20 plan freeze, participants shall not enter the plan after then.

Normal Retirement Age: Shall retire on the nearest 12/31 after having met age 62 or 5th anniversary of participation, if later.

Normal Retirement Benefit: 4% of average compensation multiplied by years of credited service to a maximum of 25 years. Due to the plan freeze effective 5/31/2020, no benefits accrue after this date.

Average Compensation: Career average beginning with participation. Due to the plan freeze, no compensation after the freeze shall be used.

Credited Service: Receives one year of credit for each year you work at least 1000 hours, while being a participant.

Normal Form of Benefit: Life annuity or actuarially equivalent joint and 50% survivor annuity.

Pre-retirement Death Benefit: Actuarial equivalent of the vested accrued benefit.

Vesting: 6 year graded vesting schedule. 100% vested upon death or disability.
