## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries of the  
Beaumont Retirement Services, Inc. 403(b) Retirement Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Beaumont Retirement Services, Inc. 403(b) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Beaumont Retirement Services, Inc. (the "Company") 403(b) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### [1] General:

The Plan is a 403(b) plan covering all employees of the Company upon date of hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). To be eligible for employer contributions, an employee must complete one year of service with the employer and be age 21 or older. An eligible employee may enter the Plan as an active member on the first day of the following month from the date on which he or she meets all the entry requirements. The Plan's recordkeeper is Lincoln Financial Group. The Plan's life insurance company is Lincoln National Life Insurance Company ("Lincoln"), and its custodians are Lincoln Financial Group Trust Company, Inc. and Ascensus, LLC an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC.

#### [2] Contributions:

Participants of the Plan can authorize a pre-tax and after-tax payroll deduction of any amount of compensation; however, total deferrals in any taxable year may not exceed statutory limitations. Participants who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions, in addition to the regular salary deferrals. Special code section 403(b) catch-up contributions are permitted if a participant has 15 years of service with the same employer ("15 years of service catch-up"). The 15 years of service catch-up enables the limit on elective deferrals to a participant's account to be increased by up to \$3,000 in any year up to a maximum of \$15,000. The Plan has an automatic enrollment feature whereby upon a participant's entry date, unless an eligible employee affirmatively elects otherwise, the employee will be automatically enrolled in the Plan at a 3% deferral rate. This rate will increase by 1% per year, up to a maximum of 10%; the increase will occur on the first day of each Plan year, unless otherwise communicated by the participant. Employer contributions are made at the discretion of the Company. To be eligible for discretionary employer contributions, a participant must work 1,000 hours in the given Plan year. The employer contribution was 5% of Plan compensation, as defined by the Plan, for eligible participants for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

#### [3] Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings (losses) and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### [4] Vesting:

Participants are immediately fully vested in their elective deferral contributions, rollover contributions and earnings thereon and are vested in Company's contributions and earnings thereon based on years of service as follows:

#### [5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. The interest rates on outstanding loan balances range from 4.25% to 9.25% at December 31, 2024 and 4.25% to 9.5% at December 31, 2023. Principal and interest are paid by employees in line with repayment plan. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### [6] Policy loans:

Participants may borrow from Lincoln, the insurance company, and use a portion of their Plan account balance as collateral for the loan. The collateral is held in the participants' account. The collateral must be 110% of the loan and payments on the loan are made outside of the Plan. As of December 31, 2024 and 2023, approximately \$20,000 of Plan assets were pledged as collateral for such loans made by the insurance company. Participants may borrow a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of his or her account balance, subject to annuity contract and Plan provisions. Loan terms range from one to five years in one-year increments, or longer for the purchase of the participant's primary residence, as defined. Principal and interest are paid ratably by the participant to Lincoln, and each payment reduces the amount collateralized. The interest rate charged on the loans is 7%. While outstanding, the amount held as collateral earns interest at the contractual rate of 4.5%. The difference between these two rates is retained by Lincoln.

During the year ended December 31, 2024, there were no Plan assets distributed from the Plan related to defaulted loans of this type.

#### [7] Payment of benefits:

On termination of service due to death, retirement or other reasons, a participant or beneficiary may receive the value of the vested interest in his or her account as a lump-sum distribution, with annuities as an alternative option. Distribution of a terminated participant's vested account balance will occur as soon as administratively practicable after termination of employment.

#### [8] Forfeited accounts:

Forfeited nonvested accounts may be used to reduce future employer contributions and pay Plan expenses. Forfeited nonvested accounts available as of both December 31, 2024 and 2023 totaled \$3,013 and \$3, respectively. During the year ended December 31, 2024, \$0 was used to reduce employer contributions and \$12,399 was utilized to pay Plan expenses.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### [1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### [2] Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements and the changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### [3] Investment valuation and income recognition:

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized depreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### [4] Payment of benefits:

Benefits are recorded when paid.

##### [5] Plan expenses:

Certain administrative expenses incurred in connection with the administration of the Plan are paid by the Company, and certain Plan expenses are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of fair value of investments. The Plan has an ERISA account which was established to hold revenue sharing funds that the Plan receives from Lincoln, pursuant to an agreement. The funds are available to pay Plan administrative expenses or to allocate to participant accounts. As of both December 31, 2024 and 2023, the ERISA account balance was \$0. During the year ended December 31, 2024, no Plan expenses were paid from the ERISA account.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Lincoln National Life Insurance Company, Lincoln Financial Group Trust Company, Inc. and Ascensus, LLC as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC have certified to the completeness and accuracy of all investments and related investment activity, notes receivable from participants and policy loans and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

*Registered investment companies* – Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Investments can be redeemed daily. There is no redemption notice period.

*Variable annuity contracts* – Valued at NAV, as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly-quoted price in an active market. Investments can be redeemed daily. There is no redemption notice period. The underlying investments are registered investment companies and have the following strategies:

#### NOTE E - FIXED ANNUITY CONTRACTS WITH INSURANCE COMPANY

The Plan entered into benefit-responsive fixed annuity contracts with Lincoln National Life Insurance Company. Lincoln maintains the contributions in a general account. The contracts are reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

Because the fixed annuity contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed annuity contracts. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contracts held by the Plan are fixed annuity contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The guarantees and returns of the fixed annuity contracts are backed by Lincoln's claims-paying ability. When the accumulation is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The guaranteed annual interest rate for these contracts is between 1% to 3% for all premiums remitted under the accumulating contracts. The crediting interest is calculated on a quarterly basis. The contract cannot be terminated before the scheduled maturity date.

#### **NOTE E - FIXED ANNUITY CONTRACTS WITH INSURANCE COMPANY (CONTINUED)**

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (the "Code") or the failure of the trust to be tax-exempt under Section 501(a) of the Code;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or
4. A material amendment to the agreements without the consent of the issuer.

#### **NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **NOTE G - TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator believes that the Plan is designed and currently operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan is qualified and the related accounts are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **NOTE G - TAX STATUS (CONTINUED)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE H - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are variable and fixed annuity contracts and are managed by Lincoln National Life Insurance Company as a part of Lincoln Financial Group. Transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan were \$27,694 for the year ended December 31, 2024.

The custodians provide certain administrative services to the Plan and receives revenue from mutual fund providers for services the custodian provides to the funds. This revenue is used to offset certain amounts owed to the custodians for its administrative services to the Plan. If revenue received by the custodians from such mutual fund service providers exceeds the amounts owed, the custodians remit the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, \$3,000 was received from the custodians. The account balance as of December 31, 2024 and 2023 was \$0 and \$0, respectively.

#### **NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE J - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued.
