### 1. DESCRIPTION OF THE PLAN

The following description of the AVITA 401(k) Profit Sharing Plan and Trust (formerly the Longs Drugstores of SC, Inc. 401(k) Profit Sharing Plan and Trust) (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of AVITA, Long's Drugs of Irmo, South Carolina, Inc., Long's Drugs of Lexington, South Carolina, Inc., Long's Drugs of Florence, South Carolina, Inc., Long's Drugs of Eastover, South Carolina, Inc., Long's Drugs of Bakersville, North Carolina, Inc., Long's Drugs Thomson, Georgia, Inc., Long's Drugs of Sandersville, Georgia, Inc., Long's Drugs of Charlotte #1, Inc., Long's Drugs of Chesterfield, South Carolina, Inc., Long's Drugs of Cheraw, South Carolina, Inc., Long's Drugs of Saluda, South Carolina, Inc., Long's Drugs of Newberry, South Carolina, Inc., Long's Drugs of Pamplico, South Carolina, Inc., Long's Drugs of Ridgeland, South Carolina, Inc., Long's Closed Door Pharmacy, Inc., Avita Drugs, Inc., Avita Drugs, LLC, MedExpress Pharmacy, Ltd., 340B Partners Pharmacy, LLC, 340B Partners Pharmacy-Dallas, LLC, PharMedQuest Pharmacy Services, Pharmblue Services and Q Care Plus, Inc., collectively (the "Company"). The Plan is intended to be a qualified retirement plan under Section 401(a) and 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan Administration** – The Plan is administered by the Company, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

**Eligibility** – Employees who have completed six months of service and have attained 18 years of age. Employees meeting these criteria are eligible for participation as of the next election date, which is either the first day of the Plan year or the first day of the fourth, seventh, and tenth months of the Plan year.

**Contributions** – Each year, participants may contribute up to 92% of pretax annual compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Company matches 100% of employee contributions up to the first 3% of employee annual compensation and 50% of employee contributions from 3% up to 5% of employee annual compensation. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant Accounts** – Each participant's account is credited with the participant's contribution and related Company matching contribution; an allocation of the Company's profit sharing contributions, if any; plan earnings; and forfeitures of terminated participants' nonvested amounts. Participant accounts are also charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Direction of Investments** – Participants may direct the investment of their account balances under the Plan. The recordkeeper will invest the participant's account balance under the Plan in accordance with their direction. Participants may modify their investment options daily.

**Vesting Requirements** – Participants are immediately vested in their voluntary contributions and employer matching contributions made by the Company. Profit sharing contributions made by the Company are fully vested after 6 years.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the participant's vested balance and bear interest at prime plus 1.00% at the date the loan is originated; such rates currently range from 4.25% to 9.5%. Principal and interest is paid ratably through payroll deductions.

**Forfeitures** – Upon termination of employment and distribution of a participant's entire vested account balance or any reason other than death or permanent disability, the non-vested contributions are forfeited and are first used to pay administrative expenses and then used to reduce Company contributions. As of December 31, 2024 and 2023, there is approximately \$205 and \$1, respectively, in forfeitures that can be used to reduce future employer contributions.

**Payment of Benefits** – Upon death, retirement, disability financial hardship or termination of employment, a participant or his or her beneficiary may elect to receive a lump sum payment equal to the value of his or her account, or may elect to rollover the asset balance directly into an IRA or into another qualified plan sponsored by an employer.

A participant may request a withdrawal from his or her account balance based upon financial hardship as defined by IRC regulations. In the event such a withdrawal is made, the distribution is subject to a 10% excise tax if the participant has not attained age 59 ½. Also, upon making such a withdrawal, a participant is suspended from plan participation for a period of six months.

**Administrative Expenses** – Certain administrative expenses for individual participant transactions are paid by participants directly from their account balances upon completion of those transactions. The professional fees of the Plan are paid by the Company, including legal, accounting and administrative fees.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' account would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting and Presentation** – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes Receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Contributions** – Contributions are reported in the year services are rendered to the Company by the Plan participants.

**Payment of Benefits** – Benefits are recorded upon distribution.

**Administrative Expenses** – The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

**Date of Management's Review** – Subsequent events have been evaluated through September 15, 2025, which is the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common collective trusts (CCTs) – CCTs are valued at the NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

#### 4. INFORMATION CERTIFIED BY THE TRUSTEE

#### 5. RELATED PARTIES

The Plan invests in certain funds managed by the trustee. The income from the Plan is derived from these funds; therefore, these transactions qualify as party-in-interest transactions. In addition, participant loans are considered party-in-interest transactions since these participants have a vested interest in Plan assets.

#### 6. TAX STATUS

No determination letter has been received for the Plan as it operates under a prototype document. The IRS issued an opinion letter for the prototype on June, 30, 2020 stating that the form of the prototype is acceptable under Section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
