### 1. Description of Plan

The following description of the Fleet Feet, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code covering all employees of Fleet Feet, Incorporated ("the Company") who are 21 years of age or older, other than highly compensated employees. Employees are eligible for the Plan after completing one month of service, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was amended effective June 1, 2025 to remove the auto-enrollment feature from the Plan.

#### *Contributions*

Each year, participants may make pre-tax and Roth contributions up to 100 percent of their eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan has an autoenrollment feature whereby all participants are auto-enrolled at 4 percent of eligible compensation upon eligibility, unless they affirmatively elect not to participate. Applicable participants will have their deferral rate increased by 1 percent on the first day of each Plan year up to a maximum of 9 percent. The Company may make discretionary matching contributions as determined by the Company's board of directors on behalf of all qualified participants. The Company elected to contribute discretionary matching contributions of 100 percent of participant's elective deferrals up to 4 percent which is deferred to the Plan each pay date. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds as investment options for participants.

#### *Vesting*

Participants are vested immediately in their contributions and the Company discretionary matching contributions, plus actual earnings thereon.

### ***Payment of Benefits***

On termination of service due to death, disability, retirement, or early retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Participants may take in-service withdrawals from all accounts after attaining age 59 ½ or at any time from their elective deferral and rollover contribution accounts. Hardship distributions are permitted from deferral accounts and Roth in-plan conversion accounts upon demonstration of a financial hardship, as defined by the Plan. Vested balances less than \$5,000 can be distributed from the trust upon proper notification to the participant.

### ***Forfeited Accounts***

Forfeiture balances at December 31, 2024 and 2023 were \$73 and \$29, respectively. Forfeitures may be used to reduce future Company contributions or pay for plan expenses. In 2024, \$1,358 in forfeitures were used to offset Plan expenses.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees charged for benefit payments are charged directly to the participant's account. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

### 3. Information Certified by the Trustee

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to related information in the financial statements and supplemental schedules.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the quoted net asset value ("NAV") of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants are 100 percent vested in their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Company may determine.

## 6. Tax Status

The Plan has received an opinion letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). From time to time the Plan may be amended. The Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

### **7. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Ascensus Trust, the trustee. Transactions with this party qualify as party-in-interest transactions.

### **9. Non-Exempt Transactions**

During the plan year ended December 31, 2023, employee withholdings amounting to \$724 were not remitted to the Plan within the appropriate time frame by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company remitted these contributions to the Plan during the 2023 Plan year. Lost earnings were paid to the Plan in August 2024.

### **10. Subsequent Events**

The Plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.
