## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants  
WSP USA Retirement Savings Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the WSP USA Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### Note 1 - Description of Plan:

The following description of the WSP USA Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan sponsor is WSP USA Buildings, Inc. (the Company, Plan Sponsor or Plan Administrator). The Plan is a defined contribution plan covering substantially all employees of the Company. Eligibility for the Plan begins on the first day of employment with the exception of Service Contract Act (SCA) inspectors working on the project for the Federal Emergency Management Agency (FEMA). SCA inspectors are required to complete 1,000 hours of service and shall become a participant commencing on January 1 or July 1 coincident with or next following the day during which the participant meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by a Retirement Savings Plan Committee of the Company (the "Committee") consisting of three persons who act for the exclusive benefit of the Plan participants and their beneficiaries. All assets of the Plan are held in trust by T. Rowe Price Trust Company (T. Rowe Price).

Effective August 7, 2023, the Plan was amended with regard to the sale and conveyance of Louis Berger Services, Inc. (LBS), a participating employer, stock to Versar, Inc. Any Employee of LBS who ceased to participate in the Plan as a result of the LBS sale shall become 100% vested in their Employer Matching Contribution Account and their Employer Discretionary Contribution Account as of the LBS termination date of August 4, 2023.

Effective January 1, 2024, the Company amended and restated their Plan Document.

#### Contributions

Each year, participants may contribute from 1% to 35% of annual compensation (effective September 1, 2023, participants may contribute up to 50% of annual compensation), as defined in the Plan, not to exceed Internal Revenue Code (IRC) limits. Participants may elect to make Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans

#### Contributions - continued

(rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an amount less the designated percentage. Automatically-enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated default investment fund until changed by the participant.

The Company makes a matching contribution to the Plan. During 2024, the Company made matching contributions equal to 50% of each participant's aggregate pre-tax elective deferrals and Roth elective deferrals on the first 6% deferred. The total annual contributions made on behalf of a participant shall not exceed 3% of the participant's compensation for the Plan year. Catch-up contributions shall not be subject to matching contributions. The Company's matching contribution is calculated on a payroll period basis.

The Plan also allows for Company discretionary profit sharing contributions determined by the Board of Directors which may be allocated to eligible participants who are employees on the last day of the Plan year. During the year ended December 31, 2024, there were no Company discretionary profit sharing contributions.

Upon enrollment in the Plan, participants may elect to change their deferral percentage in one percentage point increments or decline to participate in the Plan at any time. Participants may direct their contributions to any of the Plan's investment options. Participants may change their investment options daily.

#### Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as an allocation of Company discretionary profit sharing contributions, and an allocation of Plan earnings and Plan losses. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants hired prior to January 1, 2017 are fully vested in Company contributions and earnings thereon. Participants hired on or after January 1, 2017 are fully vested in Company contributions based on a three-year cliff vesting schedule wherein a participant is not vested until completion of three years of service.

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Plan Sponsor. Forfeitures of terminated participants' non-vested accounts are used to either pay Plan expenses or reduce the Company contributions for the following plan year.

#### Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,903,130 and \$1,720,933, respectively. During the year ended December 31, 2024, the Plan used \$2,699,825 of forfeited non-vested accounts to reduce Company contributions.

#### Payment of benefits

If a participant's vested balance is \$5,000 or less the payment will be made in a single lump sum payment. If the vested balance is greater than \$5,000, the participant is entitled to receive any one or a combination of a single lump sum or an installment basis (monthly, quarterly, semi-annually, annually) at the discretion of the Committee after considering the participants request. Effective January 1, 2024 the threshold of \$5,000 was increased to \$7,000. In addition, with regards to amounts under \$7,000, if a participant does not elect a lump sum distribution or direct rollover to a qualified plan, the amount is automatically rolled over into an IRA set up for the individual.

In addition, any participant who has attained the age of 59½ and not yet retired may request distribution of his or her account. A participant may also request a withdrawal from the Plan while still under the employment of the Company for reasons of financial hardship in accordance with the Plan document.

### Note 1 - Description of plan - continued:

#### Notes receivable from participants

Participants may only have up to two outstanding notes at one time. The minimum amount they can borrow is \$1,000. The maximum amount they can borrow is the lesser of \$50,000 or 50% of their vested account. A note must be repaid within five years. If a note is for the purchase of a primary residence, the payment term can be extended up to 30 years. Repayment of principal and interest is made through equal payroll deductions. Notes are secured by an assignment of the participant's vested interest in the Plan, and bear interest at a rate commensurate with local prevailing market rates at the time funds are borrowed, as determined quarterly by the Plan Administrator.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion and disclosures related to fair value measurements. The Plan's Committee determines the Plan's valuation policies utilizing information provided by investment advisors and T. Rowe Price.

### Investment valuation and income recognition - continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Common trust funds

Investments in the common trust funds are required to be reported at fair value. The common trust funds at the fund level are composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. The Plan has elected to value the common trust funds using Net Asset Value (NAV) as a practical expedient to determine fair value.

### Risks and uncertainties

The Plan utilizes various investment securities, including mutual funds and common trust funds both outside and within a self-directed brokerage account. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investments securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the participants' account balances and the amounts reported in the financial statements.

### Payment of benefits

Benefit payments to participants are recorded upon distribution.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a deemed distribution is recorded.

### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses are reflected as a reduction of investment return for such investments and are included in net appreciation of fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

### Recent accounting pronouncements

The AICPA Financial Reporting Executive Committee (FinREC) approved enhanceive accounting updates related to accounting for revenue sharing arrangements in accordance with Financial Accounting Standards Board (FASB) ASC No. 606, Revenue from Contracts with Customers. Revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and are not paid to the plan for delivering or producing goods, rendering services or undertaking other activities for the investment manager. A plan should consider all relevant facts and circumstances, including the terms of the agreement to determine the appropriate presentation of revenue sharing amounts. The presentation should be applied on a consistent basis and the plan should consider whether the presentation of revenue sharing amounts is a significant accounting policy that should be disclosed in the notes to the financial statements. If significant, the notes to the financial statements include a description of revenue sharing arrangements including how such arrangements are presented in the financial statements. The adoption did not have a material impact to the Plan's financial statements.

### Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

##### Subsequent events

The Plan has evaluated subsequent events through September 11, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

In May 2024, the Company acquired AKF Group LLC. Effective January 2, 2025, substantially all participants of the AKF Group LLC 401(k) Plan and assets totaling \$64,516,092 were transferred into the Plan.

In October 2024, the Company acquired Power Engineers, Incorporated. The acquired company has a 401(k) Profit Sharing Plan that will be merged, along with all of its participants, into this Plan in January 2026.

#### Note 3 - Investments and Information Certified by T. Rowe Price:

T. Rowe Price holds the Plan's investment assets and executes investment transactions. Management has determined that T. Rowe Price is a qualified institution and the information prepared and certified by T. Rowe Price meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants, for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by T. Rowe Price.

#### Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- The self-directed brokerage account consists primarily of mutual funds and common stocks that are valued on the basis of readily determinable market prices.
- Units of participation of the common trust funds are valued at the NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the

reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common trust fund, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 - Related-party transactions:

Certain Plan investments are shares of mutual funds, common trust funds, and a self-directed brokerage account managed by an affiliate of T. Rowe Price. T. Rowe Price is the trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation.

#### Note 6 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

#### Note 7 - Income tax status:

The Plan has received a determination letter, dated August 26, 2015, from the IRS stating that the Plan is qualified under Section 401(a) of the IRC and; therefore, the related trust is tax exempt. The Plan has been amended since the determination letter was received. The Company and Plan management believe that the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as a of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
