## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator and Board of Trustees

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Lowell School Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the eleven months ended November 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of November 30, 2024 and December 31, 2023, and for the eleven months ended November 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Subsequent Event**

As discussed in Note 10 to the financial statements, on July 29, 2024, the Plan Administrator of the Plan resolved to merge into the Independent Schools of Maryland and Greater Washington Multiple Employer Plan as of December 1, 2024. The Plan will transfer its net assets into the Independent Schools of Maryland and Greater Washington Multiple Employer Plan and will cease operations as of that date. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.
