**NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of Alliance Water Resources, Inc. Profit Sharing/401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan, which has been adopted by Alliance Water Resources, Inc. (the Company), is a defined contribution profit sharing and 401(k) plan that was established on February 1, 1982, covering employees of the Company who have completed three months of service and are eighteen years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan consists of investments with Fidelity Management Trust Company, the Custodian of the Plan. Contributions to the Plan, including participant salary deferrals, matching contributions, discretionary profit-sharing contributions, and rollovers from other plans, can be invested in any fund or combination of funds included in the Plan and are participant directed. A participant may change his or her investment options at any time, once enrolled.

The Custodian of the Plan's investments has provided certification as to the accuracy and completeness of the information provided to the Company. Accordingly, the Plan has elected to instruct the auditors not to perform any auditing procedures with respect to the information prepared and certified by the Custodian, pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Contributions**

Participants may defer salary up to 60% of their pre-tax eligible compensation, not to exceed the annual permissible dollar limit under the Internal Revenue Code (the IRC). Salary deferral contributions can be made as pre-tax contributions.

The Plan provides for discretionary matching contributions, as well as discretionary profit sharing contributions based upon annual determinations by the Company. The Company made matching contributions of \$658,848 and \$663,682 for 2024 and 2023, respectively. The Company did not make a discretionary profit sharing contributions for the 2024 and 2023 plan years, respectively.

The allocation of earnings (losses) is determined by the earnings (losses) of the participant's investment selection based on each participant's account balance and the investments selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their deferrals, rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant becomes 20% vested after one year of service, increasing 20% each year until 100% vested after five years of service. Participants become automatically 100% vested upon attaining age 60, qualifying for early retirement, or total disability or death.

**Forfeitures**

Forfeitures of nonvested benefits may be used to reduce any Company contributions or pay administrative expenses. Forfeitures which reduced Company contributions for the years ended December 31, 2024 and 2023 were \$91,809 and \$70,171, respectively. At December 31, 2024 and 2023, available forfeited nonvested accounts totaled \$1,144 and \$5,812, respectively.

**Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the total value of the participant's vested account balance. Loans are for a period not exceeding five years unless used to acquire a personal residence, and bear interest at a reasonable fixed rate of interest based on prevailing market rates. Loans are secured by participants' vested account balances. The loans are repaid in semi-monthly payments, through payroll withholdings, including principal and interest at rates ranging from 4.75% to 10.00%. The final installments are due on various dates through November 2029. Participants can have one loan outstanding at a time.

**Payment Of Benefits**

The Plan provides for retirement at age 60, subject to postponement upon the mutual consent of the participant and the Company. At retirement or termination, whether by reason of death or total disability or otherwise, a participant may elect to receive a distribution paid as a lump-sum amount or can elect to receive distributions through installment payments.

**Hardship Withdrawals**

A participant may make withdrawals from his or her participant deferral contributions account in the event of undue financial hardship, which includes payments for education expenses, medical or burial expenses, the purchase of a primary home or delinquent mortgage payments, and for the repair of damage to the participant's principal residence as defined by the Plan Document.

**Administrative Expenses**

Plan forfeitures may be used to pay certain administrative fees. The Company pays remaining fees and administrative expenses.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition**

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the declaration date. Interest income is recorded as earned on the accrual basis.

**Contributions**

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. No allowance for current expected credit loss was necessary at December 31, 2024 or 2023 for employer contributions receivable.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Fees are recorded as administration expenses and are expensed as incurred.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Investment Information**

#### 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds**

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market fund and mutual funds held by the Plan are deemed to be actively traded.

**Stable Value Collective Trust Fund**

The stable value fund is composed primarily of fully benefit-responsive investment contracts, along with fixed income securities and money market funds, and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the report NAV. The collective trust fund held by the Plan files an annual report on Form 5500 as a direct filing entity.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Party In Interest Transactions**

The Plan's investments include mutual funds managed by Fidelity Investments, an affiliate of the Custodian. Fees incurred by the Plan for the investment management services are included in net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These transactions qualify as allowable party in interest transactions.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered allowable party in interest transactions.

**6. Risks And Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**8. Income Tax Status**

The Plan uses a prototype plan document sponsored by Fidelity Management & Research Company (FMRS). FMRS received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2014, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Effective June 30, 2020, the Plan was restated through a pre-approved plan document sponsored by FMRS. FMRS received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. Although the Plan has been amended since the pre-approved plan received the letter, the Plan Administration believed the Plan was designed, and was being operated, in compliance with the applicable provisions of the IRC through the date of the plan restatement noted above.
