### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**NOTE 1 PLAN DESCRIPTION**

The following description of the Fenix Outdoor 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all qualified employees of Fenix USA Retail, LLC, Fjallraven USA, LLC, Primus North America, Inc. and Royal Robbins, LLC (collectively, the Company) who have attained the age of 18 and have completed 6 months of service. Employees are able to enroll in the Plan on the first day of the month following them meeting eligibility requirements. There are exceptions for death, disability or attainment of normal retirement age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. Third Party Administrators serve as the trustee of the Plan, maintain records of the participant data and hold the Plan assets.

Effective January 1, 2023, the Plan changed its name from "Brunton Outdoor, Inc. 401(k) Plan" to "Fenix Outdoor 401(k) Plan".

Effective November 25, 2024, the assets of the Plan were merged into The Standard Pooled Employer Plan.

**Contributions**

Each year, participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. Effective January 1, 2023, the Plan contains an automatic enrollment feature whereby employees will be automatically enrolled after meeting eligibility requirements. Participants will be notified approximately 60 days prior to when the Company will begin automatic 6% deductions on a pretax basis. The Company contributes a safe harbor matching contribution that is equal to 100% of each participant's salary deferrals that do not exceed 5% of the participant's compensation as defined by the Plan.

The Company may contribute a nonelective discretionary contribution equal to a uniform percentage or dollar amount of the participant's elective deferral each Plan year. In addition to meeting the eligibility requirements above, a participant must also work 1,000 hours during the Plan year to be eligible for the nonelective discretionary contribution. Historically, the Company has not made a discretionary contribution.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans or individual retirement accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the employer's contributions, and an allocation of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Notes Receivable from Participants**

Participants may borrow from the Plan in any amount greater than \$1,000 and less than \$50,000 or 50% of the participant's vested account balance, minus the highest outstanding loan balance in the last twelve months, whichever is lower. Loans are repaid over the term of no greater than 5 years, unless the loan is used for the purchase of a principal residence and then must not exceed 15 years. Loans bear a reasonable rate of interest similar to the interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions. Loan proceeds are available from all sources.

**Vesting**

Participants are immediately vested in their deferral contributions and rollover contributions, plus actual earnings thereon. Vesting for discretionary profit sharing contributions is based on years and hours of service. A participant is 100% vested after five or more years of credited service, as follows:

**Payment of Benefits**

Upon attainment of normal retirement age, termination of employment, disability, or death, a participant or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a series of substantially equal periodic installments. Additionally, participants may take an in-service distribution of employee deferrals upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$5,000. Automatic distributions above \$1,000 and less than \$5,000 made without the participant's consent are rolled into an individual retirement account designated by the Trustee. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Forfeitures**

Forfeitures are used to pay plan expenses or to reduce employer contributions. As of November 25, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$-0- and \$5,060, respectively. For the period ended November 25, 2024 and year ended December 31, 2023, \$21,917 and \$-0- of forfeitures were used to pay plan expenses. For the period ended November 25, 2024 and year ended December 31, 2023, forfeitures were used to reduce employer contributions by \$120,384 and \$37,313, respectively. On November 25, 2024, the Plan transferred \$13,628 of forfeitures into the new Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("U.S. GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:  
 Quoted prices for similar assets or liabilities in active markets;  
 Quoted prices for identical or similar assets or liabilities in inactive markets;  
 Inputs other than quoted prices that are observable for the asset or liability;  
 Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 25, 2024 and at December 31, 2023.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Total Plan assets were merged into The Standard Pooled Employer Plan on November 25, 2024 and, therefore, there are no assets to report within the fair value hierarchy for the period then ended.

**NOTE 5 INCOME TAX STATUS**

The Plan is a Pre-Approved Plan sponsored by the trustee and adopted by the Plan. The Internal Revenue Service informed the trustee by an opinion letter dated June 30, 2020, that the Pre-Approved Plan is acceptable under section 401 of the Internal Revenue Code. The Plan administrator and Plan management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 AMENDMENT AND TERMINATION OF PLAN**

The Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. As stated earlier, the Plan merged into The Standard Pooled Employer Plan on November 25, 2024. Participants' eligibility and vesting transferred into the new plan.

**NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Principal Trust Company is the trustee of the Plan as defined by the Plan adoption agreement. As such, transactions with the trustee qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and recordkeeping services amounted to \$68,260 and \$49,228 for the period ended November 25, 2024 and year ended December 31, 2023, respectively.

Principal Trust Company receives revenue from mutual fund service providers for services Principal Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Principal Trust Company as compensation for recordkeeping services Principal Trust Company provides. Mutual fund revenue used to offset amounts owed to Principal Trust Company totaled \$1,278 and \$2,036 for the period ended November 25, 2024 and year ended December 31, 2023, respectively.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through September 10, 2025, which is the date these financial statements were available to be issued.
