We have performed audits of the financial statements of Color-Art Palette, Inc. Employees Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of the Color-Art Palette, Inc. Employees Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for more complete information.

**General**

The Plan is a defined contribution plan with a 401(k) provision covering all eligible employees of Color-Art Palette, Inc. and subsidiaries (collectively, the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

During 2024 and 2023, the Plan's trustee and recordkeeper was Charles Schwab Trust Bank and Schwab Retirement Plan Services, Inc. (collectively, Charles Schwab), respectively.

**Eligibility**

The Plan covers substantially all employees of the Company who have completed 60 days of service and are age 21 or older. The Plan provides for automatic enrollment with contributions of 4% of eligible compensation unless the participant elects to opt out of participation or elects a different deferral percentage. In addition, the Plan provides for an automatic escalation provision. Unless elected otherwise, participant deferral contributions will automatically increase 1% every January 1 until the participant's deferral contribution rate reaches 10%.

Participants are eligible to share in the Company discretionary matching contributions upon completing 1,000 hours of service during the first year of employment or 1,000 hours of service during any subsequent Plan year.

Entry dates are the first of each month following the month in which the employee has satisfied the eligibility requirements.

**Contributions**

Participants may contribute up to 100% of annual compensation, not to exceed Internal Revenue Service (IRS) limits, consisting of pre-tax deferrals, Roth contributions, after-tax contributions or a combination thereof. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions.

The Company may elect to make discretionary matching and profit sharing contributions to the Plan. During 2024 and 2023, the Company's matching contribution was equal to 30% of the participants' deferral contributions, up to 10% of the participants' eligible compensation. There were no profit sharing contributions made in 2024 or 2023.

Participants direct the investment of all contributions into various investment options offered by the Plan.

**Notes Receivable From Participants**

A participant may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may not have more than one note outstanding at any given time. Notes receivable are for a period not exceeding five years, but not to exceed 15 years for the purchase of a primary residence. Interest rates on the notes are set at the prime rate plus 1%. The notes are repaid ratably through payroll withholdings and are secured by the participants' vested account balances.

**Vesting**

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 20% vested after two years of credited service, increasing 20% each year to 100% after six years of credited service.

**Forfeitures**

Forfeited nonvested accounts can be used to reduce future Company contributions or to pay the expenses of the Plan. At December 31, 2024 and 2023, forfeitures of \$159 and \$723, respectively, were available for future use. During 2024 and 2023, forfeitures of \$12,550 and \$5,325, respectively, were used to reduce Company matching contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment Of Benefits**

Upon termination of service, death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account.

**In-Service Withdrawals**

Active participants who experience a qualifying financial hardship may withdraw all or part of their vested accounts. Hardship withdrawals will be approved only if they conform to the Plan and IRS provisions. The Plan also allows withdrawal of all or part of their vested accounts upon reaching age 59 1/2.

**Administrative Expenses**

All administrative expenses are paid by the Plan, which includes recordkeeping fees, trust fees and professional fees. Investment related expenses are included in the net change in fair value of investments.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received in an asset sale or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan Document.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available to be issued, which is the date of the Independent Auditors' Report.

**3. Certified Investment Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Charles Schwab Trust Bank, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Charles Schwab Trust Bank that the information provided to the Plan Administrator related to the following information is complete and accurate.

#### 4. Fair Value Measurements

The Plan follows accounting rules, which establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Registered Investment Companies**

Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Fund**

Collective trust fund is valued at the NAV of units of a collective trust. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**7. Income Tax Status**

The Plan adopted the pre-approved plan document sponsored by Schwab Retirement Plan Services, Inc. Schwab Retirement Plan Services, Inc. obtained an opinion letter dated September 21, 2020, in which the IRS stated that the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter. The Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan and the related trust are tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

**8. Risks And Uncertainties**

The Plan invests in various investment securities, which in general are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
