Basis for Opinion

CAPITAL REGION GAMING, LLC PLAN

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Capital Region Gaming, LLC Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. The Plan is sponsored by Capital Region Gaming, LLC (“Company”).

General

The Plan is a defined contribution plan covering all employees of the Company except for leased employees, interns and non-resident aliens who do not receive U.S. source income. Employees in connection with an acquisition or merger may have a delay becoming eligible. The minimum age requirement is eighteen (18) and employees are eligible upon completing six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is intended to qualify as a safe harbor plan under the Internal Revenue Code (IRC).

Contributions

Employees can elect to defer up to 75% of their eligible compensation, as defined in the Plan, to their 401(k) accounts, subject to certain legal limitations. In addition, participants have the option to treat deferrals as Roth deferrals rather than pre-tax deferrals. Rollover contributions from other plans and certain IRA’s are permitted. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution to the Plan on behalf of the participants as a percentage of the employee’s contribution. The percentage applied to contributions is 100% match on the first 3% of the participants’ eligible compensation and then a 50% match on the next 2% of the participants’ eligible compensation.

Participant Accounts

Each participant’s account is credited with the employee’s contributions and allocations of (a) the Company’s safe harbor matching contributions and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their own contributions and allocated earnings. Participants are also immediately vested in the Company’s safe harbor matching contributions and allocated earnings.

Investment Options

The plan currently offers twenty (20) mutual fund accounts and one money market fund. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options. Participants may change their investment options and transfer funds amongst investments daily.

1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans from Roth deferrals are not permitted. Generally, loan terms range from zero to five years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time that may be longer than five years. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which are comparable to local prevailing rates as determined by the Plan administrator when the loan was originated. Principal and interest is paid ratably through payroll deductions, which cannot be less frequently than quarterly.

Payment of Benefits

On termination of service, a participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum or installment arrangement. If the vested balance does not exceed \$5,000, then payment may be distributed in a lump-sum.

A participant could also request a withdrawal upon attainment of age 59 1/2 or a hardship withdrawal due to immediate financial need, as defined in the plan document.

Forfeitures

Forfeitures can be used to partially fund the employer matching contributions or pay the administrative expenses of the Plan. As of December 31, 2024 and 2023, the balance of forfeited non-vested accounts totaled \$16,091 and \$18,767, respectively. For the years ended December 31, 2024 and 2023, forfeited non-vested funds were not used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as excess contributions payable, with a corresponding reduction to contributions received from participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits to participants are recorded when paid.

Administrative Expenses

The Company is responsible for the administrative expenses related to the operation of the Plan with the exception of certain expenses directly attributable to a particular participant which are allocated to and paid from the participant's account. The Company absorbs the cost of the annual plan audit and other outside professional services, if any.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Financial Instruments Measured at Fair Value

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets and liabilities measured at fair value in the financial statements. These assets and liabilities include the investments in mutual funds and a money market fund.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value and classifies assets into a three-level hierarchy based on the nature of the inputs. Level 1 valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Level 2 valuations are based on inputs, other than quoted prices included within Level 1 that are observable either directly or indirectly. Level 3 valuations are based on inputs that are unobservable and significant to the overall fair value measurement. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the net asset value of shares held at year end based on quoted market prices.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. FAIR VALUE MEASUREMENTS

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have loans and the Plan also qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

8. RECONCILIATION TO FORM 5500

There were no differences between net assets available for benefits per the financial statements and the Form 5500 as of December 31, 2024 and 2023. Accordingly, no reconciliation is required.
