## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrative Committee of  
TSymmetry 401(k) Profit Sharing Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of TSymmetry 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TSymmetry 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the TSymmetry 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established by TSymmetry, Inc. (the "Company") as of January 1, 2010 and has been subsequently amended. The Plan is a defined contribution plan covering all employees of the Company upon hire (other than those covered by collective bargaining agreements, part-time employees, and nonresident aliens) who have reached age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan's assets are held by Fidelity Personal Trust Company, FSB ("Fidelity" or "the Custodian") and Sentinel Benefit Services as the custodian and the recordkeeper/third-party administrator, respectively. A member of Company management is the Plan's trustee.

Contributions

For the years ended December 31, 2024 and 2023, the total amount a participant may contribute to the Plan was limited to a deferral amount of \$23,000 and \$22,500, respectively. The Plan permits both pre-tax basis and Roth after-tax contributions. If a participant has attained age 50 before the end of the Plan year, he or she is eligible to make catch-up contributions. For the years ended December 31, 2024 and 2023, the maximum catch-up contribution limit was \$7,500 for both years. Contributions are subject to other certain limitations.

The Plan provides for a discretionary company matching contribution as well as a discretionary profit-sharing contribution. For the years ended December 31, 2024 and 2023, the discretionary match was calculated as 50% of a participant's deferral up to 3% of the participants eligible compensation, not to exceed \$5,000. There were no profit-sharing contributions during 2024 and 2023.

The Plan has an auto-enrollment feature for 3% of compensation once an employee has met the eligibility requirements.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the Plan's earnings. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Upon enrollment in the Plan, participants direct employer and employee contributions received by the Plan into any of the investment options offered by the Plan. Participants are assigned units of participation based upon per-unit market valuations computed each business day by Fidelity.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution and profit-sharing portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is vested gradually, with full vesting after three years of continuous service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one year to five years or for the purchase of a primary residence the plan administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear interest 1% above the prime interest rate. The loan interest rate ranged from 9.00% to 9.50% on outstanding loans at December 31, 2024.

Interest rates are determined at the inception of the loan and remain fixed for the term of the loan. Principal and interest are paid ratably through payroll deductions. The Plan permits one loan to be outstanding at a time, subject to certain limitations, including maximum amounts permitted by applicable laws.

Participant distributions

Participants, while employed by the Company, may elect to withdraw all or a portion of their vested Company contribution account value upon attaining the age of 59 ½. The Plan does not permit hardship distributions.

Upon termination of service, a participant (or the participant's beneficiary) may elect to receive his or her vested account value in the form of a lump-sum distribution, installments, or may elect to transfer the account value to an individual retirement account or another employer's qualified plan if the subsequent employer permits such transfer. If a participant's vested account balance is less than \$5,000, the Plan Administrator will distribute the amount in a lump-sum.

Forfeitures

Forfeitures are used to reduce employer contributions or Plan expenses. At December 31, 2024 and 2023 the available forfeiture balances totaled \$7,581 and \$11,507, respectively. During years ended December 31, 2024 and 2023, forfeitures of \$20,310 and \$23,000, respectively, were used either to reduce employer contributions or pay Plan expenses.

Plan expenses

The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("US GAAP").

Use of estimates

The preparation of financial statements in conformity with US GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information prepared by the investment advisors and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Amendments

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Subsequent events

The Plan has evaluated subsequent events through August 20, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 and 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Custodian, determined to be a qualified institution by the Plan Administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year). The Custodian has certified that the following data included in the financial statements is complete and accurate:

Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.

Net appreciation in fair value of investments, interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The Plan categorizes its assets measured at fair value into a three-level hierarchy based on the priority of the inputs to the valuation technique used to determine fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology included:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

5. PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

6. INCOME TAX

The underlying nonstandardized prototype Plan has received an opinion letter from the Internal Revenue Service (the "IRS") dated November 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and, therefore, the related trust is tax-exempt. In accordance with Revenue Procedure 2006-6 and Announcement 2001-77, the Plan Sponsor has determined that it is eligible to and has chosen to rely on the current prototype Plan IRS opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Sponsor has indicated that it will take the necessary steps to maintain the Plan's operations into compliance with the Code.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments include shares of mutual funds managed by Fidelity. Fidelity is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, administrative fees paid to the Custodian totaled \$20,205 and \$19,318, respectively.

Notes receivable from participants are considered party-in-interest transactions.
