A) Eligibility - The employees are eligible to participate on the first day of the plan year following the attainment of age 21 and the completion of two year of service, or the first day of the seventh month of the plan year following the satisfaction of the above.

Definition of EmployeeMembership Groups:

Group 1: This group consists of Scott Waller, M.D.

Group 2: This group consists of Principals not in Group 1.

Group 3: This group consists of Non-Principal Physicians.

Group 4: This group consists of all participants who are not part of any other group.

C) Accrued Benefit - The participant's Normal Retirement Benefit earned to date.

D) Termination of Employment - In the event of termination of employment, a participant shall have a 100% nonforfeitable interest in the Accrued Benefit.

E) Death Benefit -

Should a participant die prior to retirement, the beneficiary will receive the actuarially determined reserve plus the death benefit provided by any insurance policy on the participant's life less any cash value at date of death. If no option has been elected as of the date of death, the beneficiary has the right to determine the time and manner of payments. Should a participant die after his retirement, the beneficiary shall receive any remaining amounts payable under the payment option in effect.
