## Independent Auditor's Report

To the Plan Administrator  
The Detroit Institute of Arts 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of The Detroit Institute of Arts 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Note 1 - Plan Description

The following description of The Detroit Institute of Arts 401(k) Plan (the "Plan") provides only general information. The Detroit Institute of Arts (the "DIA" or the "Museum") is the plan sponsor. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, copies of which can be obtained from the plan sponsor.

#### **General**

The Plan is a defined contribution safe harbor plan covering substantially all employees of the DIA who are age 18 or older. All employees are eligible to participate in all contributions (elective deferrals, employer matching, and employer safe harbor nonelective contributions) of the Plan upon reaching the age of 18 and completion of 90 days of employment. The DIA is responsible for the general administration of the Plan. Alerus Financial, N.A. is the trustee and recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

In order to maintain safe harbor status, in 2024 and 2023, the DIA made safe harbor nonelective contributions of 3 percent of a participant's eligible compensation. These contributions were 100 percent vested. In 2024 and 2023, the DIA also provided a matching contribution of 100 percent of the participant's contribution, up to a maximum of 2 percent of the participant's eligible compensation. All contributions are subject to certain limitations of the Internal Revenue Code (the "Code").

Each year, participants may contribute an amount of pretax annual compensation, as defined in the Plan, or post-tax (Roth) amounts not to exceed a combined dollar limit, which is set by law (under Sections 402(g) and 415 of the Code). The amount for 2024 and 2023 was \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions, not to exceed \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants who do not direct their contributions are invested in a default mutual fund until the participants change their elections. The DIA's contributions are allocated in the same manner as that of the participant's elective contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the DIA's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Participant Notes Receivable**

Participants may borrow from their accounts, specifically from their pretax deferral amounts, Roth deferral amounts, or rollover accounts, a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Loan terms range from one to five years, but a longer term may be permitted for the purchase of a primary residence. The \$50,000 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. A participant may not have more than one loan outstanding at any point in time and must wait 90 days after an existing loan is paid off before a new loan can be taken. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the date of issuance, as determined by the review of rates charged for similar types of loans by other lenders. Principal and interest are paid no less frequently than quarterly. Repayment will be required to be made through payroll deductions. If a participant terminates employment with the DIA, the loan is due and payable 60 days following the date the participant terminates employment. If the participant does not repay the loan, it will be reported as a taxable distribution to the participant.

**Note 1 - Plan Description (Continued)**

***Vesting***

Participants are immediately vested in their deferral contributions, plus actual earnings thereon. A participant's entire interest in the Plan shall be 100 percent vested if employed on or after the participant's normal retirement age or if the participant dies or becomes disabled. Vesting in the DIA's employer contributions is based on years of continuous service, as defined in the plan document, and is presented in the following table:

***Forfeitures***

Upon termination of employment, participants forfeit their nonvested balances of the earlier of the date of the distribution of any vested balance or when there have been five consecutive one-year breaks in service. If a participant is rehired within a five-year period, the forfeited contributions may be reinstated. Forfeited balances of terminated participants' nonvested accounts may first be used to pay any administrative expenses. Any remaining forfeitures will be used to reduce future DIA contributions.

***Benefit Payments***

Upon separation from service with the DIA due to death, disability, retirement, or termination, a participant whose vested account balance exceeds \$5,000 may elect either to receive a lump-sum cash payment or to roll over the distribution to either an individual retirement account or annuity (IRA) or another employer retirement plan willing to accept the transfer. If a mandatory distribution is made because the participant's vested account balance is \$5,000 or less and the amount of the distribution exceeds \$1,000, the law requires that the distribution be directly rolled over into an IRA provider selected by the Plan, unless the participant makes an affirmative election to either receive or roll over the distribution.

In-service withdrawals from a participant's account are available to employees over the age of 59½ or for withdrawals of rollover contributions. Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS). The plan administrator must approve any such hardship withdrawals.

***Termination***

While it has not expressed any intent to do so, the DIA has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Alerus Financial, N.A. or its affiliates. Alerus Financial, N.A. is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value based on quoted market prices reported in active markets except as noted below.

### Note 2 - Summary of Significant Accounting Policies (Continued)

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the DIA, as provided by the Plan's provisions. Administrative expenses paid by the Plan include record-keeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the DIA. Expenses that are paid by the DIA are excluded from these financial statements.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 13, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Alerus Financial, N.A. (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Tax Status**

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service. The volume submitter plan has received a favorable notification letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
